1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI SAIS NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** *Inetnon Lalåhen Guåhan*, also known as the Young Men's League  
4 of Guam (YMLG), is the oldest *CHamoru* fraternity on record having been incorporated  
5 in March of 1917 in order that *CHamoru* men may engage in social discourse, and moral  
6 and physical development; and to elevate the status of young men on Guam; and

7 **WHEREAS,** *Inetnon Lalåhen Guåhan* fought for and successfully secured the  
8 support of the Honorable Woodrow Wilson, President of the United States, in order that

1 the League’s founding members may congregate and engage in peaceful enterprise and  
2 the exercise of free thought; and

3 **WHEREAS**, the preamble of the *Inetnon Lalåhen Guåhan* states that “for God  
4 and Guam, we associate ourselves together to promote fellowship, closer understanding  
5 among fellowmen and to inculcate a sense of individual obligation to God and country”;  
6 and

7 **WHEREAS**, the first officers of the *Inetnon Lalåhen Guåhan* were Leon Flores,  
8 President; Jose Dueñas, Vice President; Manuel Ulloa, Secretary; and Adriano M.  
9 Cristobal, Treasurer. The YMLG’s Librarian was Vicente Arriola; its Sergeant of Arms  
10 was Y. Aflague; and its Sports Manager was Manuel Franquez; and

11 **WHEREAS**, under the present leadership of Johnny Taitano, President; Andrew  
12 Laguana, Vice President; Frank Mesa, Secretary; and Victor Paulino, Treasurer, *Inetnon*  
13 *Lalåhen Guåhan* continues to advocate, promote and preserve the *CHamoru* culture;  
14 and

15 **WHEREAS**, *Inetnon Lalåhen Guåhan* continues to serve and provide support to  
16 our island through scholarships, social activities and civic events with the support of  
17 fifty (50) active and engaged members; and

18 **WHEREAS**, *Inetnon Lalåhen Guåhan* further supports public education,  
19 government-sponsored events, natural and man-made disaster recovery efforts, and  
20 cultural and religious events such as fiestas and the Liberation Day festivities; and

21 **WHEREAS**, *Inetnon Lalåhen Guåhan* continues to support the YMLG Ladies  
22 Auxiliary which empowers and promotes equality among women within our society;  
23 now, therefore, be it

24 **RESOLVED**, that the Committee on Rules of *I Mina’Trentai Sais Na*  
25 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
26 of Guam, recognize *Inetnon Lalåhen Guåhan*/the Young Men’s League of Guam

1 (YMLG) on the occasion of the One Hundred Fourth (104th) Year Anniversary of its  
2 establishment; and commend the members of YMLG for their outstanding contributions  
3 to the people of Guam; and be it further

4 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
5 certifies, and the Legislative Secretary attest to, the adoption hereof, and that copies of
