COMMITTEE LEGAL COUNSEL.**

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SAIS NA LIHESLATURAN GUĀHAN:***

3 **WHEREAS,** the Committee on Ethics and Standards is a Standing
4 Committee of *I Liheslaturan Guāhan* tasked with the duty of investigating any
5 alleged violation of the Code of Ethics and Standards committed by a Senator or an
6 employee of *I Liheslatura*; and

7 **WHEREAS,** the Committee on Ethics and Standards will need the
8 professional and specialized services of a qualified Attorney or Law Firm, as
9 provided in Rule 5 of the Committee's Rules of Procedure, to perform the duties of
10 Committee Legal Counsel; and

11 **WHEREAS,** having the Legislative Counsel, who serves all Members of *I*
12 *Liheslatura*, fill the role of Committee Legal Counsel *may* present a conflict of
13 interest; and

14 **RESOLVED,** that the Committee on Rules of *I Mina'trentai Sais Na*
15 *Liheslaturan Guāhan* does hereby, on behalf of *I Liheslaturan Guāhan*, allocate
16 Fifteen Thousand Dollars (\$15,000) from the Central Operations Fund to the

1 Committee on Ethics and Standards for the purpose of contracting a Committee
2 Legal Counsel; now, therefore, be it

4 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that
5 copies of the same be thereafter transmitted to Senator Frank Blas, Jr., Chairperson

7 *Guâhan*; to the Members of the Committee on Rules of *I Mina'trentai Sais Na*
8 *Liheslaturan Guâhan*; to the Honorable Therese M. Terlaje Speaker of *I*
9 *Mina'trentai Sais Na Liheslaturan Guâhan*; and to Carlo Branch, Executive Director
10 of *I Liheslatura*.
