3 WHEREAS, Martin Luther King, Jr. Day is observed each year on the third
4 Monday in January and is designated as a national day of service to encourage
5 volunteers to improve their communities. MLK Day commemorates the life and legacy

1 of Dr. Martin Luther King, Jr., and his selfless call to help his neighbors and
2 communities by promoting his message of equality, social justice, and opportunity for
3 all by his vision of a “Beloved Community”; and

4 **WHEREAS**, Dr. King is honored for his movement that revolutionized the
5 country in which freedom is bound to the freedom of others. He fought for civil rights,
6 international peace, creating jobs and economic justice. Dr. King exemplifies how life
7 should be lived, by bringing fairness, abide by principles, and bringing goodness to all;

10 **WHEREAS**, through his determination and spirit, Dr. King helped lift others
11 and lead one of the greatest movements for equality and freedom in history. He led one
12 of the largest marches for the civil rights movement in Washington, D.C. on August 28,
13 1963, where he delivered his famous “I Have a Dream” speech. Dr. King became the
14 youngest man to receive the Noble Peace Prize, which he was awarded in 1964 for all
15 his work and efforts in creating a better community; and

16 **WHEREAS**, the values of faith, courage, truth, justice, and nonviolence that
17 guided Dr. King's dream will be celebrated and preserved each year as the 2022 Dr.
