1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SAIS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, the Committee on Rules of *I Mina'trentai Sais Na Liheslaturan*
4 *Guåhan*, constituted as the policy-making body of *I Liheslaturan Guåhan*, has oversight
5 of resolutions and bills relating to the business, budget, design, and activities of *I*
6 *Liheslaturan Guåhan*, and shall prescribe all policies governing the administration and
7 operation of the Central Office of *I Liheslaturan Guåhan*, including, but not limited to,
8 staff organization, function, personnel requirements, and rates of compensation; and

9 **WHEREAS**, monies from the Central Operations Lapse Fund may be expended
10 as directed by a resolution from the Committee on Rules of *I Mina'trentai Sais Na*
11 *Liheslaturan Guåhan* adopted by no less than seven (7) of its members, in accordance

1 with Section 15.10 of the Standing Rules of *I Mina'trentai Sais Na Liheslaturan*
2 *Guåhan*; and


3 **WHEREAS**, upon separation, in lieu of being granted annual leave, a legislative
4 employee shall be given credit for any accrued and unused annual leave as of the date
5 of separation, in accordance with Section 14.09(n) of the Standing Rules of *I*
6 *Mina'trentai Sais Na Liheslaturan Guåhan*; now therefore, be it

7 **RESOLVED**, that the Committee on Rules of *I Mina'trentai Sais Na*
8 *Liheslaturan Guåhan* does hereby authorize the expenditure in the amounts of One
9 Hundred Seventy-seven Thousand Seven Hundred Thirty-eight Dollars and Sixty-three
10 Cents (\$177,738.63) from the Central Operations Lapse Fund, and Two Hundred
11 Twenty-two Thousand Three Hundred Ninety Dollars (\$222,390) from the unallocated
12 funds of the Committee on Federal and Foreign Affairs, Telecommunications,
13 Technology, and Labor; and the Committee on Heritage and the Arts, Parks, Guam
14 Products, *Hagåtña* Revitalization, Self-Determination, and Regional Affairs, for a
15 grand total of Four Hundred Thousand One Hundred Twenty-eight Dollars and Sixty-
16 three Cents (\$400,128.63), for the purpose of making lump sum payments to legislative
17 employees of *I Mina'trentai Singko Na Liheslaturan Guåhan*; and be it further


18 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules

- 2 to Mr. Carlo Branch, Executive Director of *I Liheslaturan Guåhan*.


