**Relative to adopting the budgetary allocations of *I Mina'trentai Sais Na Liheslaturan Guåhan* for Fiscal Year 2021.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2 ***MINA'TRENTAI SAIS NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, the Committee on Rules has oversight of the business, budget,  
4 design and activities of *I Liheslaturan Guåhan*, is constituted as the policy-making body  
5 of *I Liheslaturan Guåhan*, and shall prescribe all policies governing the administration  
6 and operations of the budget of *I Liheslaturan Guåhan*, including staff organization,  
7 function, personnel requirements, and rates of compensation; and

8           **WHEREAS**, the General Appropriations Act of 2021, Public Law 35-99,  
9 included an appropriation to *I Liheslaturan Guåhan* of Seven Million Six Hundred  
10 Thirty-two Thousand Three Hundred Thirty-six Dollars (\$7,632,336) for the period of  
11 October 1, 2020 to September 30, 2021; and

12           **WHEREAS**, the amount of One Million Nine Hundred Eight Thousand Eighty-  
13 four Dollars (\$1,908,084) was allocated for the first (1<sup>st</sup>) quarter of Fiscal Year 2021,  
14 leaving a balance of Five Million Seven Hundred Twenty-four Thousand Two Hundred  
15 Fifty-two Dollars (\$5,724,252); and

1           **WHEREAS**, *I Liheslaturan Guåhan* has recognized its fiscal responsibilities and  
2 has taken into consideration the current economic and fiscal restraints of the  
3 government of Guam in preparing its Fiscal Year 2021 budget; now therefore, be it

4           **RESOLVED**, that the Committee on Rules of *I Mina'trentai Sais Na*  
5 *Liheslaturan Guåhan* does hereby adopt as its budget request for *I Mina'trentai Sais Na*  
6 *Liheslaturan Guåhan* for the remaining nine (9) months of Fiscal Year 2021, the sum  
7 of Five Million Seven Hundred Twenty-four Thousand Two Hundred Fifty-two Dollars  
8 (\$5,724,252); and be it further

9           **RESOLVED**, that the following allocations shall also be adopted for the  
10 remaining nine (9) months of Fiscal Year 2021, subject to the availability of funds, and  
11 shall not be subject to modification or abrogation or transfer without a Committee on  
12 Rules Resolution adopted by no less than seven (7) members of the Committee on  
13 Rules:

14           (a) Two Hundred Seventy-six Thousand Seven Hundred Twenty-six  
15 Dollars (\$276,726) to the Office of the Speaker, which encompasses her standing  
16 committee;

17           (b) One Million Eight Hundred Sixteen Thousand Seven Hundred  
18 Thirty-five Dollars and Twenty Cents (\$1,816,735.20) to be allocated equally to  
19 the seven (7) Majority Senatorial Offices and seven (7) Minority Senatorial  
20 Offices;

21           (c) Seven Hundred Seventy-eight Thousand Three Hundred Sixty-five  
22 Dollars (\$778,365) to be allocated equally to the remaining seven (7) standing  
23 committees;

1 (d) Two Million Six Hundred Nineteen Thousand Three Hundred  
2 Forty-two Dollars and Thirty Cents (\$2,619,342.30) for Central Operations;  
3 Salaries and Benefits shall not exceed Two Million Six Hundred Nineteen  
4 Thousand Three Hundred Forty-Two Dollars and Thirty Cents (\$2,619,342.30).  
5 The Chairperson's transfer authority shall not apply to the "Salaries and Benefits"  
6 category: and

7 (e) Ten Thousand Six Hundred Ninety-three Dollars and Fifty Cents  
8 (\$10,693.50) for the Guam Youth Congress;

9 (f) Two Hundred Twenty-two Thousand Three Hundred Ninety Dollars  
10 (\$222,390) for Resolution No. 4-36 (COR)

11 (g) One Hundred Eighty-nine Thousand Dollars (\$189,000) to the  
12 Guam Capitol District Fund, which represents the nine (9) months cost savings  
13 from the rental of the former legislative building; provided, that such funds shall  
14 not be subject to modification, abrogation, or transfer without a Committee on  
15 Rules Resolution adopted by no less than seven (7) members of the Committee  
16 on Rules; and be it further


17 **RESOLVED**, that the Central Operations Lapse Fund may not be spent or  
18 obligated without first obtaining approval of the Committee on Rules by a Committee  
19 on Rules Resolution adopted by no less than seven (7) members of the Committee on  
20 Rules; and be it further

21 **RESOLVED**, that each of the aforementioned budget allocations shall be  
22 effective on January 4, 2021; and be it further


23 **RESOLVED**, that the Speaker and the Chairperson of the Committee on  
24 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that

- 1 copies of the same be thereafter transmitted to all the Members of *I Mina'trentai Sais*
- 2 *Na Liheslaturan Guåhan*; to Carlo J. Branch, Executive Director of *I Liheslaturan*
- 3 *Guåhan*; and to Agnes A. Cruz, Chief Fiscal Officer of *I Liheslaturan Guåhan*.
