

Dear Senator Nelson:

Buenas! The Department of Public Health and Social Services (DPHSS) supports H.R 265 to amend Title XI of the Social Security Act to eliminate the general Medicaid funding limitations for territories of the United States, and for other purposes. However, removing the cap without increasing the Federal Medical Assistance Percentage (FMAP) of the Medicaid Program may not resolve or alleviate the funding shortfall in the succeeding fiscal years because of the 45 % local match requirement. Guam will not be able to drawdown the federal money without the corresponding local match.

Currently, the Federal Medical Assistance Percentage (FMAP) is 83% with an additional 6.2 % due to COVID-19 pandemic, a total of 89.2%. Guam's local match pre-COVID-19 is 17%. This FMAP will expire on September 30, 2021 and will revert to 55% in FY 2022. Based on the table, the Guam Medicaid expenditures for the past several years continued to grow due to increasing medical costs brought about by new drugs, advancing medical technology or new treatment modalities, and new health standards or policies, not to mention the increase on healthcare services utilization. Furthermore, the number of Guam Medicaid enrollees has also grown for the past several years, which will continue to increase with the inclusion of COFAS.

Before the passage of Affordable Care Act, PL 116-20, and PL 116-94, the Guam Medicaid Program operated with an annual budget ceiling allotment based on Section 1108 of the Social Security Act. Although the funding allotment increased yearly based on the medical consumers price index, it was insufficient to support the healthcare needs of the Medicaid population.

If no action is taken to resolve this long-standing regulation, Guam will then revert to receiving fewer federal dollars which is approximately \$19 to \$20 million for fiscal year 2022. The inclusion of COFAS Citizens under Medicaid may alleviate some Guam financial hardships by shifting the healthcare cost of the existing MIP recipients to Medicaid. However, the inability to match the federal funds will continue to exist because Guam's Medicaid required local match is 45%. The shortage on local match may deter both on-island and off-island providers from accepting Medicaid patients risking the lives of the recipients that may result in more expensive medical treatment as patients tend to wait until their condition worsens and are forced to seek treatment at the hospital emergency room which may necessitate hospital inpatient admission.

Using FY 2020 expenditures as the basis for estimating FY 2022 expenditure, Guam Medicaid Program will need approximately \$51.2 million to match the federal funding. Therefore, it is also

imperative for the Medicaid FMAP to increase in order to resolve the funding shortfall, increase access to healthcare, and implement the Medicaid mandates effectively.

Hafa Adai Senator Nelson,

Thank you for allowing me to provide testimony in support of Resolution 42-36 (COR). II. SUMMARY OF TESTIMONY & DISCUSSION

The Public Hearing was called-to-order at 5:09 P.M.

Senator Telena Cruz Nelson, Author: *Buenas yan Håfa Adai.* Thank you everyone for being here. The Committee on Education, Self-Determination and Historic Preservation, Infrastructure, Border Safety, Federal and Foreign Affairs, and Maritime Transportation will now convene for this Public Hearing.

Today is Wednesday, April 21, 2021 and it is currently 5:09 P.M

For the record and in accordance with the Open Government Law, public notices were sent out via email to all senators, stakeholders, and all main media broadcasting outlets on Wednesday, April 14, 2021, and the second notice on Monday, April 19, 2021. Notice of today's hearing was also sent, was also available on the Guam Legislature's website.

Joining us today is Senator Tony Ada, Senator Telo Taitague, Senator Joanne Brown, and I'd like to also acknowledge Ms. Theresa Arcangel for being here today. Thank you.

I'd like to also acknowledge that Director San Agustin is also present here today. From Department of Public Health and Social Services. Thank you, Director for being present.

Håfa adai and good afternoon everyone.

I've called for this Public Hearing to discuss Resolution 42-36, relative to Medicaid for the territories. Medicaid is the largest source of public health insurance in the nation. It covers a broad range of health concerns which can include x-ray services, physical therapy, inpatient and outpatient hospital services, midwife services, dental care, and home health care, which many citizens would not otherwise have the means to pay for or access. Currently, the elderly, and adults with incomes below 133 percent of the local poverty level, and citizens from the Compact of Free Association nations are eligible for Medicaid. In addition, the Medicaid expansion program known as the Children's Health Insurance Program, which is also known as CHIP, provides health coverage for enrolled children. Nearly one-fifth of our island's population benefits from Medicaid, but Guam, along with other territories, only have access to federal dollars that are not to exceed the annual, mandatory ceiling amount provided in the Social Security Act. For further context, funds allocated to the States are not subject to a fixed amount but are provided funds based on their respective per capita incomes, allowing them to reach a Federal Medical Assistance Percentage of up to 83%. Guam and the territories percentage is statutorily set at 55%, which is inadequate to the unique issues we face due to our geographic location.

To address this federal funding inequity to the territories, Honorable Delegate Gregorio Sablan of the CNMI introduced H.R. 265, which is known as the "Insular Area Medicaid Parity Act," which was further supported by our Honorable Delegate Michael San Nicolas. The bill would eliminate the federal funding cap for Medicaid in the Territories, and if passed, could provide monumental contributions to Guam's health community. Our island could begin to address pressing issues like rising patient debt, our crumbling infrastructure, and our growing shortage in physicians and to include specialty nurses.

I'd like to thank the Director for being present today and also Tess Arcangel. And I believe, Tess, you're going to give a testimony at this time? Is that correct, Director?

Arthur San Agustin, Director of DPHSS: Yes, you are madam. Senator Nelson, I was wondering though if I could just make some brief comments? Tess has our official testimony written for us and I just wanted to make a few comments to what's going on this afternoon.

Senator Telena Cruz Nelson, Author: Yes. Thank you, Director.

Arthur San Agustin, Director of DPHSS: Sure. Well, let me know when I can make a few comments next.

Senator Telena Cruz Nelson, Author: Yes. Please proceed. Thank you.

Arthur San Agustin, Director of DPHSS: Sure. Senator Nelson, Senator Taitague, Senator Joanne Brown, and Senator Tony Ada, I'm Art San Agustin. I'm the Director of Public Health and Social Services.

So definitely, first and foremost I'd want to thank all of you for joining in the rally and the support for the passage of this measure in terms of the delegates who have put this forth for consideration at our Nation's Capital. Definitely Delegate Sablan, [Delegate] San Nicolas should be thanked and commended for this but also all of you for taking stock in what is before us.

So, really, I'd like to officially share with you that Tess will provide a statement that really has a lot of the details in terms of our fundings and our... and our costs. What I would like to do is just kind of give you an overview of what the Department's perspective is on this as well. This measure which is before... to be considered is long overdue. It will eliminate a structural legislative inequity that has severely restricted the ability of our limited-resource health care systems to provide an adequate level of comprehensive and quality care appropriate to the needs of our American Pacific Islander communities. All our U.S. territories are facing the same Medicaid cliff for which a band-

aid solution was made in 2019. Yet, a long-term solution is needed. Simply put, eliminate the cap and increase the Federal Medical Assistance Percentage, referred to as FMAP.

Medicaid should be structured for U.S. territories to be able to fiscally plan year after year and not be subject to variables that may or may not support the current level of service. It is not sound practice to provide health care services at an increased level and then decrease the level of services or the number of participants due to funding decisions that are made for us and decisions that clearly do not take into account the real-life health concerns and challenges of Guam's people and its neighboring island nations who avail of Medicaid.

Medicaid should be funded in a manner that supports a sustainable health care system. This way, the health departments and providers can properly plan a health care system that serves a community based on sound fiscal reliance resulting in proper health care planning. Medicaid funding should be responsive to meet the changing needs of its communities, the communities it serves. There needs to be flexibility due to natural and other challenges that threaten the health of our community. Medicaid provides access and affordability to thousands of Guam residents, over forty (40) thousand residents in 2021. These two factors, access and affordability, are key factors to our community's health. Access to care and being able to afford health care are concerns families have, and for the forty thousand (40,000) plus members on Medicaid, Medicaid has been their means to access affordable health care. However, this is our time for us to rally our support, to press for the passage of the measure that will address the disparity of funding to Guam, to territories. Not to put a band-aid on a legislative measure, but to make a change that is lasting for the health of our community, our Guam community.

Thank you so much Senator Nelson and members of the 36th Guam Legislature. Ms. Tess Arcangel will have more detail and I just really wanted to share the sentiment of the Department; and of course, as many of you know, Tess has been a longtime advocate and person who has employed the department, who has managed the Medicaid [and] MIP program. So, I'd like to hand it over to her at this time and thank you so much.

Senator Telena Cruz Nelson, Author: Thank you, Director. Tess, you may go ahead and proceed.

Theresa Arcangel, Chief Administrator: Okay. Good afternoon senators. On behalf of the Department of Public Health and Social Services, we also support your Resolution 42-36.

Please see attached testimony.

Senator Telena Cruz Nelson, Author: Thank you, Tess. And I'd like to acknowledge that we have Speaker Therese Terlaje and then we also have the Administrator for Guam Memorial Hospital, Mrs. Lilian Posadas. Mrs. Posadas, would you like to give a testimony at this time.

Lilian Posadas, GMH Administrator: Yes, sure. I apologize. I just came out of a meeting, and so I apologize for being late. But thank you. Thank you for this opportunity Senator Telena Nelson, and Speaker... Senator Therese Terlaje, Senator Amanda Shelton, Senator Mary Torres, Senator Clynton Ridgell, Senator Anthony Ada, Vice Speaker Tina Barnes, Senator Joanne Brown, Senator Pedo Terlaje, and Senator James Moylan.

As the administrator and CEO [inaudible], it is with a grateful heart to then be invited to this legislative forum and to provide testimony that I hope will strengthen this legislative leadership in its commitment and effort to ensure health care access and affordability is sustained for those enrolled in the Medicaid program. This congressional H.R. Bill No. 265 is definitely needed to avert a crisis that will occur if the FMAP and the Medicaid funding for Guam is reverted to how it was originally operationalized. From the hospital's perspective, should the FMAP and the Medicaid funding revert to the 55 percent (55%) reimbursement cap for the services it provides to those enrolled in the Guam Medicaid program, the hospital will, without any doubt, be in extreme financial hardship again. So, on behalf of the GMH leadership, management, medical staff, and employees, we are in absolute support of this resolution as it will, [inaudible] without any doubt, assist the hospital's revenue and reimbursement for the services provided to those covered under the Medicaid program.

Thank you. I know it's kind of short, but you know, to the point. And if it's something that, you know, I think all of us have been clamoring about and concerned [about] because it is going to be very, very devastating financially for our health care system and for the people of Guam who are enrolled in this Medicaid program. So, thank you. Thank you for this opportunity.

Senator Telena Cruz Nelson, Author: Thank you so much, Mrs. Posadas, and you're right on time. You're not late. The hearing is still going on and so that the... I think that's one of the things... is the convenience of Zoom. We're able to just move quicker.

Lilian Posadas, GMH Administrator: Correct.

Senator Telena Cruz Nelson, Author: So, at this time I'd like to open up for questions... that if there're Senators that have any questions. We'll start with Speaker Terlaje. Speaker, do you have any questions at this time?

Speaker Therese Terlaje: I don't have any questions. I do want to commend Representative Kilili, and of course our own Congressman for being sponsors of this and introducing this legislation to Congress.

I also, very much, want to commend the Department of Public Health and Social Services— our Director and Ms. Arcangel, who's been there for many years and has actually been to Congress to advocate for exactly this type of treatment for Guam, in particular Medicaid. Because of her and all of our concerns regarding, you know, covering as many people as possible. And so, I think we've been very consistent. It's something I think we all agree on.

Thank you, Lilian for your testimony as well. And I am very proud to be part of this team. I don't know if you've ever watched Tess testify to Congress. I just... I just am so proud of her and all her work in this division and her expertise in this regard and her ability to make this fund kind of go as far as it absolutely can. And we've seen that prior to the pandemic. We've seen it again during the pandemic. She's thinking all the time about ways to stretch it, you know? To make it reach the people who she knows it really needs to reach. And so, if I could just take this opportunity to say that and again urge Congress to support this resolution.

Thank you, Madam Chair.

Senator Telena Cruz Nelson, Author: Thank you, Speaker. Senator Ada, is there... do you have any questions or comments at this time?

Senator V. Anthony Ada: Just comments, Madam Chair. Thank you for introducing this resolution and having the hearing on it. And it just goes to show that when we all come together as a people that, you know, we need to come out and support, not only Congressman Kilili, but our own Congressman as well so that we'd be able to get as much as we can... federal assistance from the federal government for our people and for the Marianas as a whole. But again, Madam Chair, thank you for making me a co-sponsor on this resolution and anything we can do out of our offices to move this forward and, you know, advocate for parity in this Medicaid issue, we're there with you, Madam Chair, to move it forward. Thank you again.

Senator Telena Cruz Nelson, Author: Thank you, Senator Ada. Senator Taitague, do you have any questions at this time? Or comments you'd like to share?

Senator Telo Taitague: Thank you, Madam Chair, for the opportunity, and thank you for introducing this legislation. I hope you can also include me as a co-sponsor on this as well. I think it's most needed. Thank you, Lilian for being here, too. You're never too late when you come aboard. I mean, you're so busy and it's a great surprise that we can

actually have you here, that you took some time out. And [we] greatly appreciate it. Thank you for all your hard work.

As well as... the Speaker mentioned about Tess and how amazing she is. I really rely a whole lot on her when it comes to questions with regards to anything, even, you know, MIP as well as Medicaid, Medicare. She's the encyclopedia to go to when you need to know that information, and she's helped me many times. And I want to thank you so much for all you've done, Tess. Thank you so much.

And Mr. Director, you know, she's a gem over there. So please give her all the support she needs because I truly believe she's really for the best interest of the people of Guam, that she works this hard for and I greatly appreciate it. And to the Congressmen and also... both Congressmen, kudos and thank you for your advocacy; and let us know what else we can do to help assist you in this endeavor. Thank you so much.

Senator Telena Cruz Nelson, Author: Thank you Senator Taitague. Senator Brown, do you have any questions or comments at this time?

Senator Joanne Brown: Thank you very much, Madam Chair. Just a... just a very short comment. I think, pretty much, we're all on the same page and, certainly, thank you for sponsoring this resolution. We're certainly in line very much with our Delegate from the CNMI, Congressman Kilili Sablan as well as, certainly, our Congressman Mike San Nicolas in supporting this initiative.

I think if we're able, certainly, to get more federal resources into the Medicaid program on Guam, it's going to alleviate a lot of the pressure that we have with regards to funding the treatment and medical needs of our people. And, certainly, will improve the overall healthcare that's provided to our community. I don't have much more to add than what's already been put forth, but thank you to everyone who's participated—

[technical difficulty and inaudible dialogue]

Senator Telena Cruz Nelson, Author: Okay, I think we lost Senator Brown, but we can come back to her.

Tess, I do have a question or two. I want to thank you for your very thorough testimony. Can you just please tell the people of Guam why it's important to also address the FMAP, the Federal Matching Aid [Assistance] Percentage and can you just describe, also... well when you're done, but just describe the work that you had to do to ensure that Guam received this portion that we are receiving for 2020.

Theresa Arcangel, Chief Administrator: [inaudible]

Senator Telena Cruz Nelson, Author: Oh, you have to unmute.

Theresa Arcangel, Chief Administrator: It's very important to increase the FMAP, with the reason being it's because of the local match required. If the FMAP is not increased, the Government of Guam would have to put up a huge amount of funding, and which we know, based on our economic situation right now and because of [the] pandemic, let's face it... we don't have that local match.

You cannot use a federal funding to match a federal grant. It has to be coming from local funding. So with that, based on the analysis, based on the expenditure, historical expenditure, we would need forty million (\$40,000,000) to fifty one or to fifty five million (\$51,000,000 or \$55,000,000) in order to drawdown that federal funding. Without that local match, we cannot drawdown the federal funding. It has to be matched.

So, to me, it will not... though we want to remove the cap, it will not be much of a benefit for Guam because we won't be able to spend it even if they gave us one hundred thirty million (\$130,000,000) or two hundred million (\$200,000,000). If there's no equivalent local match, then we won't be able to pay for those services. Those clients won't be able to be treated. There would be no smooth access to services in order to provide the treatment that they need. So in summation, in reality, we would need that FMAP to be increased, which is the maximum FMAP that the federal right now can give is eighty three percent (83%).

Senator Telena Cruz Nelson, Author: And can you just speak historically in FY 19 and 18, was the local government able to match the federal—

Theresa Arcangel, Chief Administrator: Yes.

Senator Telena Cruz Nelson, Author: Okay.

Theresa Arcangel, Chief Administrator: Yes, we were able to match that as what we have done. We testified to Congress. We showed them our expenditure. We showed the historical utilization of services, and we told them about the difficulty, and we told them about the disparity—this long-standing regulation that it's not... to me, it should not be there because the people in Guam are also U.S. citizens. There's no difference wherever they go, they're all U.S. citizens, and U.S. citizens should be treated equally.

Senator Telena Cruz Nelson, Author: Thank you and would you happen to know how the formula is utilized or where the data that they utilize the formula for to determine the FMAP for our territory, for Guam?

Theresa Arcangel, Chief Administrator: That's based on Congress' formula, actually. We have been talking about that. It's not necessarily per capita [*inaudible*].

Senator Telena Cruz Nelson, Author: Do you feel that the formula needs to be addressed and, perhaps, reviewed to meet the needs of the island of Guam and the other territories? Do you feel there's a disparity in the formula when it's compared to the States?

Theresa Arcangel, Chief Administrator: Yes, definitely. There is a big disparity because U.S. citizens are U.S. citizens wherever they go. They have to receive the same services, the same benefits, wherever they are.

Senator Telena Cruz Nelson, Author: Okay. Thank you, Tess. Speaker, I see you raising your hand.

Speaker Therese Terlaje: I just wanted to add. Tess, if you can clarify... and the reason why this disparity is very pronounced is because when they're using poverty levels and the amount of your population that are in those poverty levels... you know, Guam's poverty levels are higher than many, many of the states and so we are affected very directly by that disparity in the formula. Yes. So, for them they get people in poverty levels covered to a much higher extent than we are able to cover them under this formula.

Thank you.

Senator Telena Cruz Nelson, Author: Okay. Thank you. Tess, I want to thank you again for your testimony. I'm hoping that we can, perhaps, make an amendment to also advocate for the formula to, perhaps, maybe be looked at and reengaged; and, perhaps even adjusting the FMAP and, perhaps, keeping it consistent with the amount that... the eighty three percent (83%) that we received for this year. And so, I want to thank you. I think you... were you accompanied with anyone when you went to Congress to advocate for this?

Theresa Arcangel, Chief Administrator: Yes, the previous Director, Ms. Linda DeNorcey. she was there.

Senator Telena Cruz Nelson, Author: Okay, great. So, I just want to thank Ms. DeNorcey and you for the hard work that you've done. And I also understand that you... that Guam also submitted testimony during one of the roundtable discussions addressing Medicaid, is that correct?

Theresa Arcangel, Chief Administrator: Yes. Yes, Senator.

Senator Telena Cruz Nelson, Author: Okay. Thank you. And so thank you for that and thank you for being in the loop with a lot of things that are happening on the federalist side that impacts our island and I'd like to thank again Mrs. Posadas. Thank you so much for taking time out of your busy schedule. And Director San Agustin, I know I've been messaging you guys and asking you to be present. And Tess, thank you for being available for the many questions that we had to resolve, some of the issues that we foresee in the future. And hopefully we can continue to advocate, especially as we look forward to the unknowns that we'll be facing in the upcoming years as a result of this pandemic.

So, with that being said, I'd like to thank my colleagues for being present, and thank you everyone for being here today. And we will now adjourn this public hearing.

III. FINDINGS AND RECOMMENDATIONS

Ms. Tess Arcangel, Chief Administrator for DPHSS, emphasized that eliminating the federal funding cap will not resolve or eliminate the funding shortfall if Guam's FMAP is not increased. Senator Telena Nelson acknowledged this statement and will amend the Resolution to propose that the FMAP score be readjusted to fit the needs of Guam and the territories.

Speaker Therese Terlaje, Senator V. Anthony Ada, Senator Telo Taitague, and Senator Joanne Brown further expressed their support of the Resolution and commended Director San Agustin, Ms. Arcangel, and Mrs. Posadas for their efforts in the medical community. Senator Taitague further requested to become a co-sponsor of the Resolution.

Senator Telena Cruz Nelson hereby reports out Resolution No. 42-36 (COR), "Relative to expressing the support of *I Mina'trentai Sais na Liheslaturan Guahan* for the passage of H.R. 265, the "Insular Area Medicaid Parity Act," introduced by the Honorable Delegate Gregorio Kilili Camacho Sablan and the Honorable Delegate Michael F.Q. - 3 WHEREAS, the Medicaid program was established in 1965 pursuant to U.S.
- 4 Public Law 89-97 and is authorized under Title XIX of the Social Security Act (SSA).

- 1 The program serves as the largest source of public health insurance in the nation.
- 2 Mandatory benefits include but are not limited to lab and X-ray services, inpatient
- 3 hospital services, home health services, and freestanding birth centers, along with
- 4 other optional benefits for states and certain territories; and
- 5 WHEREAS, from its establishment, Medicaid worked in service of the elderly
- 6 and certain low-income individuals. Since then, it has welcomed steady population
- 7 growth and now covers a wider demographic. Under the Patient Protection and
- 8 Affordable Care Act (ACA, P.L. 111-148, as amended), Medicaid expanded its
- 9 programs to a new adult group with incomes below 133 percent of the poverty level.
- 10 The provision covers low-income adults 65 years and younger, including parents and
- 11 adults without dependent children; and
- 12 WHEREAS, the Medicaid expansion program known as the Children's Health
- 13 Insurance Program (CHIP), provides health coverage for enrolled children through
- 14 both Medicaid and separate CHIP programs. Similar to Medicaid, it is jointly funded
- 15 by local and federal governments; and
- 16 WHEREAS, an omnibus COVID relief bill signed into law on December 28,
- 17 2020 extended Medicaid services to Compact of Free Association (COFA) citizens.
- 18 The law serves an estimated 100,000 COFA migrants who live in the 50 U.S. states
- 19 and District of Columbia, and who meet all Medicaid eligibility rules; and
- 20 WHEREAS, Medicaid is offered in all U.S. territories, including Guam,
- 21 American Samoa, the Commonwealth of the Northern Mariana Islands (CNMI), the
- 22 Commonwealth of Puerto Rico, and the United States Virgin Islands (USVI).
- 23 Medicaid was established on Guam in 1975 and is administered by the Department of
- 24 Public Health and Social Services (DPHSS); and
- WHEREAS, the program operates on a fee-for-service (FFS) basis, and nearly
- 26 21 percent of Guam residents are enrolled in Medicaid. While Guam, Puerto Rico, and
- 27 the USVI are required to provide mandatory Medicaid benefits, Guam is the only

territory to do so, providing also the optional benefits of dental and prescription services; and

WHEREAS, an increase in Medicaid funding aided one-fifth of the island's population during the unprecedented effects of the COVID-19 pandemic. Guam's primary public hospital, Guam Memorial Hospital (GMH), reported that its Medicaid collections for Fiscal Year (FY) 2020 increased to 26,999,457, which is 9.4 million more than the FY 2019 collections set at 17,579,613. The recent FY 2020 appropriations package (P.L. 116-94) and the Families First Coronavirus Response Act (FFCRA, P.L. 116-127) increased Guam's federal Medicaid allotment from \$18.4 million to \$130.9 million. The FY 2021 allotment raised from approximately \$18.8 million to \$129.7 million; and

WHEREAS, while Congress has provided limited supplemental federal Medicaid funds to Guam and other territories on several occasions, the territories only have access to federal dollars that are not to exceed the annual, mandatory ceiling amount provided in Section 1108(c)(4) of the SSA. If federal dollars are exhausted, local funds are used to fund the program. This is unlike the states where federal Medicaid spending is open ended; and

WHEREAS, the Federal Medical Assistance Percentage (FMAP) for Guam and the territories is statutorily set at 55 percent (§1905(b) of the SSA), unlike that of the states, where the FMAP is set using a formula based on state per capita income. For FYs 2020 and 2021, Guam has a temporary FMAP of 83 percent. During the national public health emergency declared in response to the COVID-19 outbreak, Guam received the 6.2 percentage point increase provided by the FFCRA to all states and territories, which went into effect January 1, 2020. This increase brought Guam's FMAP to 89.2 percent. Guam also received a 100 percent CHIP enhanced FMAP during the emergency period. Like the states and other territories, Guam's matching

1 rate for almost all program administrations is set at 50 percent (§ 1903(a)(7) of the SSA); and

WHEREAS, while Medicaid administered a funding increase for FY 2020 and FY 2021, the annual allotment for the fiscal years succeeding FY 2021 will revert back to a 55 percent federal matching rate. This means that if Guam were to spend \$10 million in local funds for Medicaid services, the federal government would provide 12.2 million, or 55 percent, only 5 percent above the statutory minimum; and

WHEREAS, H.R. 265 recognizes the need to address the inequitable distribution of federal funds to the territories as they face a unique set of challenges due to their geographic locations. The U.S. Department of Health and Human Services designated Guam as a Health Professional Shortage Area (HPSA) and a Medically Underserved Area (MUA). These designations demonstrate a need for more health care providers, practitioners, and health-related resources. The shortage in certain physician specialists and specialty care nurses is only expected to increase in the succeeding years; and

WHEREAS, architects and engineers from the Army Corps of Engineers (ACOE) deemed the Guam Memorial Hospital to be in an overall state of failure, citing pre-existing issues that include unsafe infrastructure, an outdated HVAC (heating, ventilation, and air conditioning) system, and a lack of financial resources available to adequately address these pressing issues. The cost of repairs recommended by ACOE is estimated to be \$21 million and would go towards replacing the existing facility and immediately repairing critical life safety items; and

WHEREAS, adding to the financial strains on the Hospital, Guam Memorial Hospital Authority (GMHA) reported up to \$145.5 million in uncollectable debt for the ending of FY 2019. The average debt acquired from patient receivables is estimated to be \$16.5 million annually, meaning GMHA receives 27 cents per dollar

for self-pay patients. With the \$658K decrease in federal grants for FY 2019, the 1 2

Hospital is further burdened by its negatively operating cash flow; and

WHEREAS, recognizing the need for additional federal funding for territories, 3 the Honorable Delegate Gregorio Kilili Camacho Sablan from the Commonwealth of 4 Northern Mariana Islands introduced H.R. 265, titled the "Insular Area Medicaid 5 Parity Act." The bill is further supported by several U.S. state representatives and the 6 Honorable Guam Delegate Michael F.Q. San Nicolas. The Act provides that Section 7 1108, Section 1902, and Section 1903 of the SSA, relative to the allocation of federal 8 funds to territories, be amended to eliminate the cap on Medicaid funding provided by 9 the federal government; and 10

WHEREAS, the additional funds would increase the capacity of the medical community to provide a steadier allocation of resources and programs geared toward improving health services. These financial resources could go towards several capital projects that are currently unfunded and address GMH's dire need for personnel, which would help stabilize the Hospital's financial health further; and

WHEREAS, increasing funding that goes towards health care should not be contingent on a pandemic but should be a matter discussed for communities in need even beyond the impacts of COVID-19. The "Insular Area Medicaid Parity Act," would provide a more equitable distribution of federal funds to territories and ensure that Guam's FMAP is proportionate to the financial needs of our island. H.R. 265 would aid not only the health of low-income individuals, but the wider community as a whole; and

WHEREAS, despite the persisting challenges to our island's medical community, the joint efforts of local and federal entities have done much in service to the People of Guam. However, more can and should be done. The continued efforts and support of local and state representatives is crucial to protecting the public's access to Medicaid and health care; now therefore, be it
