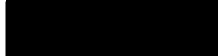

II. SUMMARY OF TESTIMONY AND DISCUSSION

The Confirmation Hearing was called-to-order at **1:00 p.m.**

Chairwoman Amanda L. Shelton:

Buenas and Hafa Adai everyone good afternoon. This virtual public hearing by the Committee on Air Transportation Parks Tourism Higher Education and the Advancement of Women, Youth, and Senior Citizens is hereby called to order. Today is Friday, July, 16 2021 and the time now is 1:03 p.m. For the record and in accordance with open government law, notices for this hearing were sent out on July, 9 2021 and again on July, 14 2021. In addition, this hearing was noticed on the Guam Legislature website. Joining me this afternoon, I'd like to thank my colleagues Speaker Therese Terlaje, Senator Telena Cruz Nelson, Senator Tony Ada, Senator Telo Taitague, and Senator Joanne Brown. *Si Yu'us Ma'ase* colleagues for being here today. I'd also like to recognize the President of the Mayor's Council of Guam, Mayor Jesse Alig, welcome. And the chairman of the Guam Visitors Bureau Board, Mr. Milton Morinaga. And of course, our nominee, our Mayor Rudy Paco from the village of MTM. Thank you very much Mayor for being here.

Before we begin with the discussion I'd like to first provide some general rules of conduct for all those in attendance. The conduct of the hearing will be as follows: one, all must abide by the rules and conduct and quality assurance standards. Please keep your video on at all times and ensure you are in a room with little interruptions and adequate lighting specifically to make sure the participants face is visible at all times when speaking. Please ensure that you are unmuted and that you are speaking into the microphone. The Chair will invite individuals who have signed up to testify to speak. Individuals testifying shall first be recognized by the chair and state their name for record purposes. The order of questioning will begin with the panel of Senators who shall complete their lines of questioning for each respective agenda item. Each member will be allowed to pose questions to an individual testifying for a round and then we can proceed with another round if necessary. Questions and testimony shall be confined to the substance and nature of the agenda. Personal inference as to the character motive of any Senator or individual testifying is not permitted. Any violations of this general rule of conduct will result in removal from the meeting room.

We will now continue on with the items on our agenda. First is the appointment of the honorable Rudy a Paco to serve as member the Mayors' Council representative of the Guam Visitors Bureau Board of Directors. The Guam Visitors Bureau Act encoded in Article 1 Chapter 9 Title 12 of the Guam Code Annotated provides that the exercise of the powers of the bureau shall be directed by the board of directors



composed of 12 members, one of whom shall be a Mayor or vice Mayor selected by the commissioner's council and appointed by the governor, with the advice and consent of the legislature. The board's duties include, among others, promoting visitor satisfaction, encouraging job opportunities in the tourism industry, assisting in the development of facilities and attractions, collecting and analyzing data on the industry, providing advice, and assistance to tourism development organizations. At this time, I'd like to first invite individuals who have signed up to testify on Mayor Paco's confirmation then we will hear from the nominee himself. Again, please state your name for the record before you begin your testimony. I'd like to begin with the Mayor's council of Guam president and Mayor Jesse Alig.

Hon. Jesse L.G. Alig, *President of the Mayor's Council of Guam; Mayor, Piti:*

Hafa Adai Senators. My name is Jesse Alig, I'm the Mayor of the beautiful village of Piti and the president of the Mayor's council of Guam. And I would like to testify in support of Mayor Rudy Paco's nomination to the Guam Visitors Bureau board of directors. And just some background information. On February 3rd, we had our regular meeting of the Mayor's council of Guam and there were three members of our council that were interested in representing the Mayor's council in the GVB board and so to be fair and transparent, I decided to call for a vote and Mayor Paco received a majority vote of the membership present at that meeting. And so, we are here today because of that. I want to say that I have worked with Mayor Paco since January 2017 when I began my first term as Mayor. And if there was one word to describe Mayor Paco, it would be tenacious. Tenacious because he is passionate about doing things right. He's always concerned about the people around him and the situations that might arise. I believe he's a thoughtful and discerning person and as rough around the edges as he might seem, he is a compassionate leader. And his concern really for our island and the welfare of our people is just as unrelenting. And because of these qualities Mayor Paco will represent the Mayor's council of Guam with the utmost integrity. And I asked the good Senators of the 36th Guam legislature to confirm his appointment to the board of directors.

Chairwoman Shelton:

Si yu'us ma'ase Mayor, thank you very much. And now the GVB chairman, Mr. Milton Morinaga.

Mr. Milton Morinaga, *Chairman, Guam Visitors Bureau Board of Directors:*

Thank you very much. I'll just make a very short remark. The president of Mayor council has said a lot of good things about him. As a board chairman of GVB and knowing him for a short while, I could gather that he is a trustworthy and responsible individual. And he takes ownership of all the project that he has initiated and I have a very high respect. And other boards do the same thing that we do have a high respect of his knowledge and his integrity. And the thing is that the board is looking forward to working with him. And I'd like the Senators to confirm his nomination.



And I mean there's nothing much I can say. That he's the man that can represent the Mayors and I think he is worthwhile to be a part of the board members and contribute the projects that he can contribute. Thank you very much.

Chairwoman Shelton:

Thank you very much Mr. Morinaga. I know we had dr. Nguyen and Mr. Angel Sablan, the executive director of the Mayor's council of Guam, have signed up to testify. I don't see them on the zoom yet so Mayor Paco we will move to you and if they log on we'll allow them to testify in a little bit so Mayor Paco the floor is yours.

Hon. Rudy A. Paco, Nominee and Mayor of Mongmong-Toto-Maite:

Good afternoon Senators. Thank you for taking the time for this confirmation hearing. And I also would like to express my gratitude to governor Lou Leon guerrero, lieutenant governor tenorio, and my colleagues at the Mayor's council of Guam for this appointment. For those who don't know me I'm Rudy Paco. I'm Mayor of mongmong, toto, maite, now serving my second term. I was born and raised in mongmong, toto, maite, and I'm a retired federal fire department. After 25 years of service, I knew what I wanted. I wanted to give back to the community. As a Mayor, I made it my mission to build partnership and I started with my neighbors. In my time in office, I established our village's first ever neighborhood watch program. Our network is 250 members strong. We have a daytime and nighttime patrol and by working together we are safer. In my office, I've improved our community facilities by partnering with private sectors. We renovated our mtm community center, enhanced the baseball field by installing lights. Because we have limited fitness facilities, I again partnered with private sectors to create a quarter mile walk around which is used by joggers and walkers. In my time in office, I've improved roadways and safety by partnering with department of public works. Reflectors and strippings widened roads and laid non-skid resurfacing on slippery streets. By partnering with Guam power authority, we installed over a dozen street lights. Partnering with Guam waterworks we installed fire hydrants with reflective marking and because I'm a former first responder, I also made my staff position reflector tapes on street signs for quicker respond times of emergencies. As you can see I love my community. I work well with others and I get the job done and I do social partnership. While I haven't been confirmed by the board yet, I'm already getting acquainted with Guam Visitors Bureau. And the missions I'm especially interested in keeping our island beautiful for not just visitors but for all those who call Guam home. And thank you for your time and your consideration.

Chairwoman Shelton:

Thank you very much for your testimony. I am happy to hear of your willingness to serve. I want to congratulate you on being selected by your peers and of course then nominated by the governor, and I look forward to confirming you here in the legislature. I think what you said about your willingness to partner with others and



work with others is very important and you'll bring that same spirit to the Guam Visitors Bureau. And I've seen firsthand how you are such a go-getter, a problem solver for the issues that you've faced in your village. You've been innovative to solve these problems and I've seen firsthand the progress that you've made. I've visited some of the places in your village and I'm very impressed by the work you've done in the short amount of time you've been the Mayor. So, I know that you will bring all of that to the Visitors Bureau and work just as hard there. And as you said not just for the visitors but to keep Guam beautiful and thriving for our local community as well. I think there's a lot to be done. I appreciate that. Now I like to open the floor to my colleagues if they have any questions. Speaker Therese, oh I'm sorry, before you begin Speaker we do have the executive director from the Mayor's council of Guam Mr. Angel Sablan. Mr. Sablan if you'd like to give your testimony.

Mr. Angel R. Sablan, Executive Director, Mayors' Council of Guam:

All right good afternoon. It's a pleasure to be here this afternoon to provide input and support to I believe one of the hardest working Mayors on our island and that's Mayor Rudy Paco. I have known him for a little bit over five years now and he's always amazed me. A very humble man but someone that takes his work very seriously. He has turned mtm around in just a short time, the first term that he was there. And I'm sure that as the desired appointee of the Mayor's council of Guam and appointed by the governor to represent MCOG and our people, that he will carry forth and do what needs to be done. He's a very determined man. Mayor Paco may be shy, maybe not the person that you'll hear from all the time, but when he has a task at hand when he has a mission that he wants to fulfill, he's going to hit that target. He's going to hit that target because bottom line is he wants to help our people and as our representative he feels the pulse of the 18 other Mayors and our seven vice Mayors and the people of Guam. And I'm sure that our president Alig would agree with me, that we picked a very fine man to represent us in the Guam visited bureau. Your other representative for many years, Mayor Robert Hoffman did a fantastic job too. As a director for Guam visitor bureau Robert did fantastic work but we look forward to Mayor Paco doing even more for the Guam Visitors Bureau. Even now when he's not yet a confirmed director he has been out there helping in tumor, sprucing it up with his personnel to make sure that our island is ready for the return of our tourists. We believe that Mayor Paco will do us good and we believe that he will do the Guam Visitors Bureau good. And we have no doubt that he will represent us well and carry forward the mission of GVB. So, I ask all of you my dear Senators and friends to fully support him as we in the council fully support him to be the next director of the Guam Visitors Bureau. I thank you so much, thank you so much for hearing us out and for supporting not just a personal friend but a colleague of Mayor's council of Guam as well.

Chairwoman Shelton:



Si yu'us ma'ase Mr. Sablan. And now Speaker Therese if you have any questions for the panel or for the nominee.

Speaker Therese M. Terlaje:

Hafa Adai Mayor Paco and Mayor Alig and of course the director Sablan and chairman Morinaga, and all my colleagues. Congratulations Mayor on your election and appointment to this position. It's very exciting. I guess that you're new on this and that it opens it up for some changes. And I just wanted to ask you about your goals on the board. Is there anything different that you want GVB to be doing more of relative to the villages or just tourism in general that you think is going to impact and keep the island beautiful for all of its residents and visitors? Are there any other priorities that you would have there at GVB?

Mayor Paco:

Yes, ma'am. I look at *Sagan Amot* where the old Guam memorial hospital used to be at. They have the *Sagan Amot* or *Sagan Umpti* where they make Chamorro medicines. They have arts and crafts up there as well. We should expand that and enhance that place so we can use it as a tourist attraction. So, that we can show our visitors that these are what Chamorro people are taking besides Tylenol and Advil. They have a beautiful *hotnu* there. I was really impressed during the first FESTPAC. When I went up there and I saw what they had, I said, "man we're sitting in a gold mine and we're not showing the beauty of this." This *Sagan Amot* they had a *hotnu* we can show our visitors how the local people use the *hotnu* to bake and to cook. And at the same time serve our visitors and make them try our local dish. Another idea that I would love to see and this is either a dream or a fantasy, I like to see a farmer's market being built down in *Hagatna* across the *Hagatna* Mayor's office instead of using it as a green waste dump site. We should clean it up and beautify that area. We clean the riverside, we can have a river raft boat that would take our visitors, and at the same time have their lunch. But let's showcase our culture to our visitors because they're not here to eat sashimi or their kind of food, we are here to show off what we have to represent on our culture.

Speaker Terlaje:

Thank you, Mayor. Yeah I like those ideas and so I'm willing to support you in those efforts. I think that's the original intention of the *Sagan Kottura Chamorro* and allowing them to use a land up there is exactly that. And so, I'm happy they highlighted it during FESTPAC but I'm sure with the Mayor's help it can also be enhanced. Like you said and the GVB's help absolutely get visitors there and really get it to be what it was meant to be.

Mayor Paco:

And when you look at reality Senator, sorry for intruding, but it's walking distance for the tourists.



Speaker Terlaje:

Yes, it's walking, yes that's right, you're right. So, I agree and there's long been talk about restoring a farmers market. They tried to do it over at the Chamorro village but i'll support any efforts for additional farmers markets and use of land other than for green waste facilities.

Mayor Paco:

We have the ample parking at the swimming pool.

Speaker Terlaje:

The GVB does a lot of its work by committee. Are you serving on any of the committees?

Mayor Paco:

Yes, ma'am. I'm serving in the destination management visitors and safety satisfaction.

Speaker Terlaje:

Sounds perfect. Okay so destination management is the committee where we talk about how are we gonna use destination funds to enhance our public bathrooms, it's always a big question right at the parks. And then how to get this money to the villages. So, do you feel like with your experience so far that GVB is being responsive to ensuring that the benefits of tourism are reaching the villages and not just being focused in Tumon?

Mayor Paco:

Well that's the whole purpose of me being in the board as a Mayor. Where I can reach out to GVB and listen to the Mayors' cry for help or their requests.

Speaker Terlaje:

So yeah I guess are you confident that you're going to be able to advocate for that because sometimes those guys are tough. Right Mr. Morinaga? Just joking. But you're gonna have to almost compete right for that type of attention, that type of focus, that type of funding. And I think really do it for all of us, for all the people in our villages, who really want to see that. We're depending on you. I know in the past that they've supported the festivals, right? Maybe not evenly across the board. So, I'm not sure what the Mayors are going to focus on, if it's festivals or other things, but the Mayors have been coming up with some great things and activities in the villages for both residents and visitors. So, I hope that we can get GVB to also focus on those things. I'm just gonna put in a plug for one thing, that I'm hoping they're also going to focus on. We tried to spruce up our parks, right? Our beaches and especially the ones that we have public restrooms at and make sure that those are safe with these safety



officers at the different places. But we also have these historic sites and just like showing off the culture at *Sagan Kottura* and those types of places. I really want GVB to focus on our historic sites, keeping them also safe and improved and highlighted so that our visitors can see that our history goes back four thousand years. And I really want them to know that when they leave here, not that we just have beautiful beaches, but that we have a culture that goes back four thousand years.

Mayor Paco:

We want them to go and spread the word out. So, we can bring more tourists into our island.

Speaker Terlaje:

Yes. *Si yu'us ma'ase* Mayor for your service on this board. I support you and let me know if there's any other way that we can help. Thank you very much.

Chairwoman Shelton:

Si yu'us ma'ase madam Speaker. Senator Nelson.

Senator Telena Cruz Nelson:

Thank you, madam chair. *Hafa adai* Mayor Rudy. First of all, I'd like to thank you for accepting this nomination. I believe that you are the perfect fit for this position and I look forward to seeing the great work that you come up with GVB. So, thank you again and looking forward to seeing you take care. Thank you so much.

Chairwoman Shelton:

Thank you, Senator Nelson. Senator Ada.

Senator V. Anthony Ada:

Thank you, madam chair. Mayor Rudy congratulations on your nomination. I continue to like your ideas of taking tourism out of Tumon, just like you wanted to do something in *Hagatna*. The president of the Mayor's council Mayor Alig has some wonderful historic sites down there in Piti as well that perhaps can be turned into a nice little tourist destination. With seeing the Piti guns, fresh ideas going into the Guam Visitors Bureau is going to be needed especially in this upcoming months as we try to reinvigorate our visitor industry. And what it's going to take to bring tourists back to our island. And I think you said it right out there is that they come here to see what our local community is about, they come out here to see what is it about Guam, the food, the culture, the historic sites, and all those things. And I think having you there on the board is going to shift the paradigm to where we're going to start looking at these things and we're going to start building upon and continuing to take the tourists out of Tumon. Tumon is beautiful and I'm pretty sure that we're gonna have those tourists that want to stay there, but I think a lot of the tourists that



come in and want to come out and see what the island is about and how do we regenerate that enthusiasm about coming to Guam. And Mayor Paco you got some ideas that I hope that you'll be able to share with your fellow board members and bring those things to light and make it make it happen. You have my full support Mayor and I hope to see your nomination on our next session agenda for voting. Thank you.

Chairwoman Shelton:

Thank you. *Si yu'us ma'ase* Senator ada. Senator Taitague.

Senator Telo T. Taitague:

Si yu'us ma'ase madam chair for the opportunity. And well Rudy we all know that the position that you're taking is the most sought-out appointment that most Mayors want to have. I know a few other Mayors who would like to have this opportunity to sit on the board and I'm just really happy that there is a change. So Mayor Hoffman was on there for quite some time but I think we need some change and new ideas to bring forth. And I think the Mayors have chosen the right person to sit in that position which is yourself. I know you on a professional level and what you've done for your village as well as the Mayor's council, but I also know you on a personal level. I had the opportunity many times to have dinner with you and to hear your perspective and one thing's for sure, is you're very enthusiastic. You're one of those get up and go-getter but you do it with a very "easy to talk to type of person." I think you'll bring that binding bond that needs to be put together at GVB, with what the public wants versus all those who are sitting on the board that seem to be concentrating solely in Tumon. When I was a deputy general manager of the Guam Visitors Bureau, I oversaw destination management, that particular committee as well, and it does a lot of work with the community. That's probably like 80 percent of what GVB needs to look at, and increase its awareness on who we are as an island. And so, I greatly appreciate that. I know that you also have within your grasp the opportunity to ask for assistance when you need it and so that's a good thing. Anything I can do to help you to improve, and anything we can do to improve what you're going to do, or help you what you're going to do please you have my cell number. Don't be afraid to reach out. Okay it'll be nice to work with you all. Okay good luck to you and you have my support. Thank you.

Chairwoman Shelton:

Thank you very much Senator Taitague. Senator Brown.

Senator Joanne M. Brown:

Thank you very much madam chair. And certainly, good afternoon to you. It's refreshing to hear your testimony and certainly your response to the questions that Speaker terlaje had. I certainly look forward to your service on the GVB board. I think you get a general sentiment of our feelings of wanting to see our visitor industry more



interfaced with our local community and having that brand, that Guam brand, that is truly representative of the history and the culture and the beauty of our island. We recall the time back in the early 70s and the 80s when the standard here on Guam and the tourism industry was trying to replicate the Hawaii experience. We were in the elevators and in the lobbies and we hear the Hawaiian music and the tiki gods and things that were being sold to our tourists that were not representative of our Guam culture. I think we very much want to see Guam to be that unique experience and certainly from the history of the responses on surveys to our tourists that they want to see that. And I think it's a wonderful opportunity with your presence on the GVB board to expand that. And the opportunity, also economically, for our people that have expertise in this area, be it in the cultural side, the artistic side, to actually be part of the benefits of our tourism industry. Because having that and contributing to the economy where our people that have this expertise actually can financially make a living doing it. Will help continue to allow our culture, our language, and everything that comes with it to sustain over a longer period of time in the future. I heard your comments about perhaps putting the farmer's market here and again expanding that local experience. But how do you think we can further get more of our local people engaged with the visitor industry and provide that Guam brand that we'd like to see more of? I just wanted to get your thoughts on that.

Mayor Paco:

Well when you look at in reality, Clifford Guzman and Monica Guzman has this program called *Guma* where they have some grant funds for all our talented local people to show off their talents. Like what they normally say Tan Maria makes good *guyuria* and his family makes good *empanada*, so then those people will get involved with that *Guma* group because the *guma* group has a grant that would finance our local people to show off their talents. And I pushed to my community to come out with your talents and join this program because they're going to help you.

Senator Brown:

Well I certainly appreciate that. I know we all know Monica and Clifford. And certainly, their commitment to our local culture. So, I wish you well. I'm sure you will do well with regards to your presence and your engagement of being able to bridge an even stronger relationship between our tourism industry and our local community, especially as we discussed putting that Guam brand that's unique to our island and a benefit to our visitors. So, that they actually have something more than just a sell that they're getting of "oh we're going to a tropical island" but a tropical island with a unique history and a unique culture. And more importantly because I think in order for these qualities and knowledge to move forward for our people, having it being something that's also economically viable for those that invest in it will continue to keep our culture alive. Where our people actually can pursue their passion and actually make a living doing it and provide a quality product to our visitors. Because in the past they've been short changed with the presentation that's



been made of what we think our visitors want to see in coming to an island versus you're coming to Guam. And this is a unique Guam experience that we'd like to share with them. Like I said even our food and those that have the expertise in providing that quality we all know where do you get the best *guyuria*, where do you get the best *empanada* and having that be part of their experience. We're not shortchanging them and we're allowing an opportunity for our people to be economically viable and sustainable to continue these practices. So, my congratulations to you I'm sure you'll get a unanimous confirmation by the Guam legislature. Thank you for extending yourself beyond the commitment you're already making to your village to extend your services to the Guam Visitors Bureau into our community. With that thank you very much madam chair for the opportunity to comment and ask a question of Mayor Paco. Thank you.

Chairwoman Shelton:

Thank you very much Senator Brown and again thank you Mayor Paco for what you've shared today and all that you are willing to do now to sit in this new position. I look forward to moving your nomination in the next session and confirming you along with my colleagues. With that the committee hereby deems the appointment of the Hon. Rudy a Paco by *I Maga'hågan Guåhan* to serve as member of the Guam Visitors Bureau Board of Directors to be duly heard. *Si Yu'us Ma'ase*.


