

an impact on all our people," Perez stated in a press release.

Also considered in the resolution are the four active firing ranges and ongoing construction of a fifth firing range above the Northern Lens Aquifer.

The resolution cites the known accumulation of heavy metals like nickel and copper in soils at training ranges, and the high cancer rates on Guam, which continue to be a leading cause of death.

The over-extraction of water from the aquifer as a result of the buildup may threaten the intrusion of saltwater into the freshwater aquifer, the resolution states.

"We all come from our mother's hånom; how special it is, and how much needed that is. It's crucial in so many ways to sustain our lives and in more ways that we may even realize, both physically and spiritually," Jessica Nangauta, an organizer with Prutehi Litekyan/Save Ritidian stated during Thursday's hearing.

Marine veteran Rick Perez directed attention to

contamination issues in Okinawa, which also hosts a U.S. military presence. "As a former Marine, I'm absolutely horrified by what the Marine Corps is doing on Guam. it's disgusting. It doesn't represent the best of American values," Rick Perez stated during the hearing.

He said targeted communication with Congress, the White House, and the Secretary of Defense may be better than dealing with Joint Region Marianas.

The resolution further called upon the Guam Environmental Protection

Agency to ensure that a high-quality environment be maintained at all times. It called upon the Department of Defense to prevent further damage related to the Live Fire Training Range Complex and to protect against irreparable harm to Guam's drinking water. It also urged a visit to the island by the United Nations regarding human rights to safe drinking water and the rights of indigenous peoples.

The testimony we received today was so heartfelt and compelling, and it is clear that the Department of Defense does not have the consent of our people to continue with the desecration of our lands and contamination of our waters," Sen. Perez said.

Supporting testimony was also heard from University of Guam's Green Army president Kyle Dahilig, Arthur Paulino of the Social Work Student Alliance, and Bobbie S.N. Benavente, a CHamoru grandmother and great-grandmother from Dededo.




