

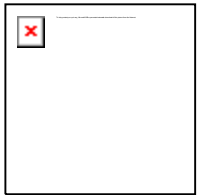

The streaming service is stepping up its output of kids and family movies and series to fend off competition from newer kid-friendly streaming services such as Disney+. It's also emphasizing original content over borrowed (but popular) series from Nickelodeon ("iCarly" and "Avatar: The Last Airbender") and Disney Jr. ("Sofia the First") Netflix says it will release more than 50 new original movies and TV shows aimed at kids and families this year.

Eddie Izzard co-wrote as well as stars in 'Six Minutes to Midnight'

The beginnings of British actor-comedian Eddie Izzard's career in show business happened without any comedy. He dipped his feet into it as a school boy, playing small dramatic roles, but learned to attract attention on the stage by speaking his lines a bit faster than everyone else. Upon discovering "Monty Python's Flying Circus" when he was about 13, he decided he wanted to get laughs, and eventually progressed through sketch

comedy, then street comedy, and finally standup. His next jump, in his 30s, brought him into film acting ("Velvet Goldmine," "The Cat's Meow"), and a return to drama, but he kept on doing the standup.

There were more films - he had a major role in "Victoria & Abdul" - and a recurring part in the TV series "Hannibal." But having honed his writing skills on standup material over the years, he's also wanted to try script writing. The first film to come out of that de-

south. Sirius is the head of Canis Major the Big Dog and that triangle of stars below Sirius is the Dog's hind legs. To the left of Canis Major and extending south is a sweep of stars that now make the constellation Puppis the Stern of the Great Ship Argo Navis.

Canopus, the second brightest star, is another easy find in the southwest. Canopus is the brightest and westernmost star of Carina the Keel of the ship. The rest of the Keel lies low above the southern horizon. Above the Keel is a ragged circle of stars that we call Vela the Sails.

The Great Ship Argo Navis used to be the sky's largest constellation, but it was broken into smaller pieces to make stellar navigation more precise. The parts are easier to see, however, if you view them as a single ship. There's no bow, supposedly it was lost in the crashing rocks, and the ship sails silently backwards across our spring southern skies.

In the missing bow is an awesome star called Eta Ca-

rinae. Although it can't be seen with the unaided eye now, in the mid-1800s, it was the sky's third-brightest star. Eta Carinae is huge and extremely unstable and it has probably already become a supernova. Who knows, the light from the explosion may reach us in your lifetime.

Guam's spring skies are awesome. We've got famous constellations, bright stars, planets and the largest ship in the universe. Don't miss it.
