

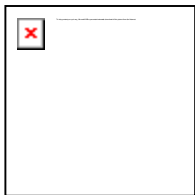

WHEREAS, Emilia F. Rice will be greatly missed for her insights and hard work and analysis. NOW THEREFORE:


