When complete the document will be sent to the EMSC for review. B. Policies and Protocol Booklet (tabled). Dr. Mendiola stated the changes have been finalized and Angel Llagas stated that the Booklet is currently being reviewed by the Department of Defense for uniformity with the federal requirements. There have been major changes with respect to paramedic and medication requirements and the scope of practice. Once the DOD review is complete, the Booklet will be provided to the EMSC. C. Ambulance Diversion Policy and Interfacility Transfer (need to identify sub-committee). 1. Chair stated that a sub-committee would need to be established. 2. Dr. Mendiola stated that there were no issues from GMHA. 3.
