

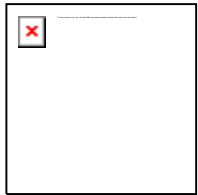

- I. Call to Order: Meeting was called to order by Chair Fisher at 4:00 PM.
- II. Roll Call: Present in person were Board Member Candy Okuhama, and Compliance Branch Staff. Present via Zoom were Chairwoman Lisa Fisher, Board Members, Carlo Pangelinan, and Ed Toves. Deputy Director Maria Lizama was present via Zoom.
- III. Old Business:

VIII. Open Forum: Kracked Egg Inc. DBA: Kracked Egg (The)

Ms. Blas, shareholder and part owner of and Kracked Egg, is applying for a General On-sale License. However, she is also shareholder and part owner of Onedera Store, a Class 5 General Off-Sale License Holder. Mr. Camacho advised that the way the current law is written (GCA Section 3300 33a), the holder of a Class 5 Off-sale License (ex. Onedera Store) cannot also hold a Class 4 On-Sale license (ex. Kracked Egg) at the same time.

Ms. Blas addressed the board, and stated that she is only a minority, and equal shareholder in both businesses – 12% Onedera, 25% Kracked Egg. She stated that she does not understand the intent and concern of why this would be an issue, when the application is for the business and not for her the person. They would like to expand their offerings, and be open to having alcohol serving functions at the establishment. The additional revenue from alcohol sales would be helpful, and that partial ownership of another alcohol selling establishment by one of their shareholders should not affect that.

Ms. Ann Marie Muna, shareholder and part owner of Kracked Egg, also addressed the board with her concerns. She stated that the corporations are completely different companies, with completely different owners, with just a small percentage that one person owns in both companies. She asked if there is any type of waiver, and they are appealing to the board to consider this request.

Chair Fisher replied that she is not opposed to the request, and asked for Mr Camacho's guidance in this specific matter. She advised that she is willing to enquire about the law in this regard, and requested the applicants provide a written request to the Board with their concerns. Supervisor Camacho recommended the board to seek guidance from the Attorney General's office on the matter. Chair Fisher said she would also seek guidance from Senator Sabina Perez.

IX. Meeting Adjourned: Chair Fisher moved to adjourn the meeting at 4:38pm. Motion seconded by Ms. Okuhama and approved without dissent.
