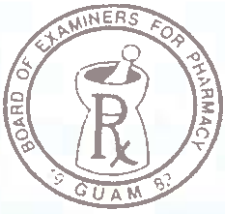

In cross-country, runners earn points according to their place. The top five runners earn a team score, while the No. 6 and 7 runners act as pushers, meaning they get the place but earn no points.

Hollingsworth, a junior, and Quinata, a freshman, did their best but could not catch up with the Sharks' overall top finisher Ryner Di Ramos, a 14-year-old freshman in just his second meet of high school.

"I got on the line and my mindset from there was just get it from the gun. Obviously, I saw a lot of competition on the line," said Di Ramos. "But I didn't let it get to me. I just decided that it's my race. I want it,

and so I'll run for it."

Di Ramos led from the get-go and finished with a time of 18 minutes, 49 seconds. Hollingsworth and Quinata clocked in at 20:01 and 21:40, respectively. The next several runners were all spaced apart, so there was no dramatic photo finish, even though the score was close. The Sharks' Warren Ortega and Noah Park clocked 22:22 and 22:29 for fourth and fifth, but the Dolphins took the next two slots with Ty Quinata and Michael Certeza to catch up, and Patrick Sumbo locked in the South Side victory.

Pablo Castro and Jake Hoya scored the final points for the Sharks.

And although the Southern High girls team will forfeit every meet this season (unless they add more girls), that didn't stop sisters Cheyenne and Cheyoung Ahn from taking the top two spots. Cheyenne Ahn, 16, ran a time of 24:25, while her 14-year-old sister was nine seconds behind. Southern High's other girl runner, Andi Leon Guerrero, finished at 43:45.

'The moment of truth'

Most find it difficult to do a golf swing. What is the impact on the golf swing? It is the time when the golf club face meets the ball downward. Yes!

Amateurs swing the club the opposite way — upward. And they end up duffing, topping, skulling, you name it.

Skilled golfers know how to make solid contact by attacking a ball downward.

When a good player swings a downblow, or a downward strike, the club face's loft works best. However, most amateur golfers

attack the ball the opposite way. They try to help the ball get up in the air by scooping the club at the moment of impact.

A side-on game

The golfer sets up his or her body to the side of the target. In other sports, like sharpshooting and bowling, players face the target and align themselves straight on with the target. Golfers do not. Why? Because this target-centered setup causes incorrect alignment and illusions of aiming.

In the pro-am golf tournament, many tour professionals are known to say, "The most common amateur golfer mistake — compared with tour profession-

als — is neither power nor accuracy. It is alignment."

I'll discuss these issues later in greater detail.
