 - 1. **VETOED BILL NO. 11-36 (COR)** - AN ACT TO *AMEND* § 19405(b) AND (c) OF ARTICLE 4, CHAPTER 19, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING LEGISLATIVE AUTHORIZATION TO EXTEND A DECLARATION OF A STATE OF PUBLIC HEALTH EMERGENCY AND TO BE KNOWN AS “THE RESTORATION OF SEPARATION OF POWERS ACT.” (Doc. No. 36GL-21-0257)
