  1. **VETOED BILL NO. 11-36 (COR)** - AN ACT TO *AMEND* § 19405(b) AND (c) OF ARTICLE 4, CHAPTER 19, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING LEGISLATIVE AUTHORIZATION TO EXTEND A DECLARATION OF A STATE OF PUBLIC HEALTH EMERGENCY AND TO BE KNOWN AS “THE RESTORATION OF SEPARATION OF POWERS ACT.” (Doc. No. 36GL-21-0257)
  2. **VETOED BILL NO. 38-36 (COR)** - AN ACT TO *AMEND* § 61106(b) OF ARTICLE 1, CHAPTER 61, DIVISION 2, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO ESTABLISHING EXTENSIONS OF DEADLINES TO SUBMIT REPORTS OR POSITIONS STATEMENTS TO THE APPLICATION REVIEW COMMITTEE, AND AN ADMINISTRATIVE FINE FOR THE DIRECTOR OF A MEMBER-AGENCY OF THE APPLICATION REVIEW COMMITTEE WHO FAILS TO PROVIDE REQUIRED REPORTS OR POSITION STATEMENTS ON LAND USE APPLICATIONS.   3. **VETOED BILL NO. 164-36 (COR)** - AN ACT TO *AMEND* SECTIONS 4, 5, 6, AND 7, AND *ADD* A NEW SECTION 8, AND *REPEAL* “EXHIBIT A,” ALL OF PUBLIC LAW 35-136 THE *RECOVERY INCOME SUPPORT AND EMPOWERMENT (RISE) ACT OF 2020*, RELATIVE TO REMOVING IMPEDIMENTS TO THE ISSUANCE OF PAYMENTS TO ELIGIBLE GUAM RESIDENTS DURING THE STATE OF PUBLIC HEALTH EMERGENCY DUE TO THE COVID-19 PANDEMIC.   4. **VETOED BILL NO. 73-36 (COR)**- AN ACT TO *AMEND* §§ 60102 AND 60103 OF CHAPTER 60, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO REMOVING THE RESTRICTIONS ON OWNERSHIP OF SUPPRESSORS AND SILENCERS FROM GUAM LAW; AND TO BE KNOWN AS THE “HEARING PROTECTION ACT OF 2021.” (Doc. No. 36GL-21-1444)
  5. **VETOED S.BILL NO. 179-36 (LS)**- AN ACT TO *ADD* NEW §§ 13510 AND 13503(h) TO ARTICLE 5 OF CHAPTER 13, TITLE 19, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING RULES AND REGULATIONS FOR THE LICENSURE OF ADOPTION AGENCIES, AND TO *ADD* THE DEFINITION OF AN ADOPTION AGENCY. (Doc. No. 36GL-21-1462)
  6. **VETOED S.BILL NO. 173-36 (LS)**- AN ACT TO *AMEND* § 9112 OF CHAPTER 9, § 117 OF CHAPTER 1, § 14105 OF CHAPTER 14, AND § 13103 OF CHAPTER 13; AND TO *ADD* A NEW § 15110 TO ARTICLE 1 OF CHAPTER 15, AND TO A NEW § 1124 TO CHAPTER 1, ALL OF TITLE 3, GUAM CODE ANNOTATED, RELATIVE TO ADDRESSING AND MODERNIZING ELECTION-RELATED ISSUES, TO INCLUDE THE COUNTING OF PROVISIONAL BALLOTS, ELECTIONEERING AT POLLING PLACES, THE CANCELLATION OF THE PRIMARY ELECTION IN CERTAIN CIRCUMSTANCES, AND VACANCIES.   7. **VETOED S.BILL NO. 236-36 (COR)**- AN ACT TO *AMEND* § 5213 OF SUBARTICLE B, ARTICLE 3, CHAPTER 5, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO STRENGTHENING THE REQUIREMENTS OF SMALL PURCHASES. (Doc. No. 36GL-22-1909)

8. **VETOED BILL NO. 123-36 (COR)**– AN ACT TO *AMEND* § 2108 OF CHAPTER 2, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING EMPLOYEES WHO RESIGN FROM GOVERNMENT OF GUAM EMPLOYMENT TO SUBMIT TO DRUG TESTING TO RETAIN RE-EMPLOYMENT RIGHTS IF SAID RESIGNATION WAS TENDERED SUBSEQUENT TO THE EMPLOYER'S ANNOUNCEMENT OF DRUG TESTING.
