- AN ACT TO *ADD* A NEW CHAPTER 54 TO TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO CREATING TAX REBATES FOR PERSONAL PROTECTIVE EQUIPMENT (PPE); AND TO BE KNOWN AS “THE PPE FOR GUAM ACT OF 2021.”
- AN ACT TO *AMEND* § 120.60 OF ARTICLE 1, CHAPTER 120, TITLE 8, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING TESTING FOR HIV OF THOSE CHARGED WITH CRIMINAL SEXUAL ABUSE OR CONDUCT AT THE REQUEST OF VICTIMS.
