AN ACT TO AMEND § 77104.1 OF ARTICLE 1, CHAPTER 77, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO INCLUDING ALL PEACE OFFICERS IN THE ENFORCEMENT OF ALCOHOL-FREE ZONES WITHIN THE GUAM TERRITORIAL PARK SYSTEM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. § 77104.1 of Article 1, Chapter 77, Title 21, Guam Code
Annotated, is hereby *amended* to read:

"§ 77104.1. Establishment of an Alcohol-Free Zone.

- 5 Notwithstanding any other law, rule or regulation, there is established
 - within the Guam Territorial Park system "Alcohol Free Zones," as defined in

this Chapter. Any person who possesses or consumes alcohol in an "Alcohol
Free Zone" shall be in violation of this provision and shall be issued a citation
and punished in accordance with § 77104.2 of this Chapter. All Peace
Officers, as defined in 17 GCA § 51101(b), shall have jurisdiction to enforce
this Section."

6 Section 2. Effective Date. This Act shall be effective upon enactment.
