**AN ACT TO AMEND § 403(i) OF CHAPTER 4, TITLE 1,
GUAM CODE ANNOTATED, RELATIVE TO
CHANGING THE OFFICIAL NAME OF THE
MUNICIPALITY OF “MERIZO” TO ITS NAME IN THE
CHAMORU LANGUAGE, NAMELY “MALESSO’.”**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 403(i) of Chapter 4, Title 1, Guam Code Annotated, is hereby
3 *amended* to read:

4 “(i) Village of Malessos'. Beginning at the mouth of the Toguan River
5 running easterly along said River to its head, thence easterly to the Mt.
6 Schroeder Triangulation Station, thence southeasterly to the Mt. Sasalaguan
7 Triangulation Station, thence southeasterly along the Ajayan River to its

1 mouth, thence westerly, northwesterly and northerly along the southwestern
2 coastline to the point of beginning.”

3 **Section 2.** All references to “*Merizo*” in the Guam Code Annotated and the
4 laws, rules, and regulations of Guam shall be understood to refer to “*Malessso*’.”
