

**AN ACT TO *AMEND* SECTION 13 OF PART III,
CHAPTER II, PUBLIC LAW 36-107 ("GENERAL
APPROPRIATIONS ACT OF 2023"), RELATIVE TO THE
UNIVERSITY OF GUAM CAPITAL IMPROVEMENTS
FUND.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 13 of Part III, Chapter II, Public Law 36-107 is hereby
3 *amended* to read as follows:

4 **"Section 13. UOG Capital Improvements Fund.** The sum of One
5 Million One Hundred Fifty-eight Thousand Two Hundred Eighty-three
6 Dollars (**\$1,158,283**) may be allocated from the General Fund appropriation
7 in Section 2 of this Part of this Chapter to the UOG Capital Improvements
8 Fund for the purpose of paying rental payments due under the lease-back
9 agreement pursuant to Public Law 31-229:18, as repealed and reenacted by
10 Public Law 31-277, or for its operations to offset or forego tuition increases."

11 **Section 2. Effective Date.** This Act shall be effective upon enactment.
