AN ACT TO AMEND SECTION 13 OF PART III, CHAPTER II, PUBLIC LAW 36-107 ("GENERAL APPROPRIATIONS ACT OF 2023"), RELATIVE TO THE UNIVERSITY OF GUAM CAPITAL IMPROVEMENTS FUND.

## 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Section 13 of Part III, Chapter II, Public Law 36-107 is hereby amended to read as follows:

"Section 13. UOG Capital Improvements Fund. The sum of One Million One Hundred Fifty-eight Thousand Two Hundred Eighty-three Dollars (\$1,158,283) may be allocated from the General Fund appropriation in Section 2 of this Part of this Chapter to the UOG Capital Improvements Fund for the purpose of paying rental payments due under the lease-back agreement pursuant to Public Law 31-229:18, as repealed and reenacted by Public Law 31-277, or for its operations to offset or forego tuition increases."

Section 2. Effective Date. This Act shall be effective upon enactment.
