AN ACT TO APPROPRIATE THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND SEVEN HUNDRED **DOLLARS** (\$3,880,716) **WITHIN** SIXTEEN ENHANCED 911 EMERGENCY REPORTING SYSTEM FUND (FUND) FROM PRIOR FISCAL YEARS TO THE **GUAM FIRE DEPARTMENT FOR PURPOSES** ESTABLISHED BY § 12304 OF ARTICLE 3, CHAPTER 12, TITLE 12, GUAM CODE ANNOTATED, GOVERNING USE OF THE FUND.

- 5 System Fund (Fund) to restore the funds transferred out of the Fund during Fiscal
- 6 Years 2014 through 2017 totaling Three Million Eight Hundred Eighty Thousand
- 7 Seven Hundred Sixteen Dollars (\$3,880,716), as described in the January 17, 2019
- 8 Order of the Guam Public Utilities Commission in GTA Docket 18-02, are hereby
- 9 appropriated to the Guam Fire Department for the purposes set forth in 12 GCA §
