

**AN ACT TO ADD A NEW § 80.39.2(d) OF ARTICLE 2,
CHAPTER 80, TITLE 9, GUAM CODE ANNOTATED,
RELATIVE TO EXCLUDING INDIVIDUALS
CONVICTED OF FIRST OR SECOND DEGREE
CRIMINAL SEXUAL CONDUCT FROM THE
SENTENCING REDUCTIONS OF THE JUSTICE
SAFETY VALVE ACT.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new § 80.39.2(d) to Article 2 of Chapter 80, Title 9, Guam
3 Code Annotated, is *added* to read:

4 “(d) the individual was convicted of criminal sexual conduct in the
5 first or second degree pursuant to 9 GCA §§ 25.15 or 25.20.”
