AN ACT TO ADD A NEW PARAGRAPH (r) TO § 3103 OF CHAPTER 3, TITLE 17, GUAM CODE ANNOTATED RELATIVE TO REQUIRING ALL REPORTS OF THE SUPERINTENDENT OF EDUCATION TO THE GUAM EDUCATION BOARD BE POSTED ON THE GUAM DEPARTMENT OF EDUCATION WEBSITE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Paragraph (r) is *added* to § 3103 of Chapter 21, Title 17, Guam Code Annotated to read as follows:

"(r) All reports of the Superintendent to the Guam Board of Education, that are required by Public Law, the Guam Administrative Rules and Regulations, Guam Education Board Policy, as a condition of receipt of grants-in-aid, as a condition of contract or at the request of the Guam Education Board shall be posted on the Guam Department of Education website within five (5) days after report is officially transmitted to the Board, except those reports that are confidential pursuant to Public Law. Board Packets from each board meeting shall also be posted on the Guam Department of Education's website within five (5) days after each board meeting. Confidential information contained in any report or board packet that contains public information shall be redacted prior to the report being posted on the website."
