3 **WHEREAS,** it is the obligation of *I Liheslaturan Guåhan* to recognize and
4 commend the commitment of individuals who have faithfully served and dedicated
5 years of their lives to the People of Guam; and

6 **WHEREAS,** Mr. Ferdinand B. Soriano, from the village of Mongmong-Toto-
7 Maite, was born on September 13, 1967 to Francisco and Agripina Soriano, and Mr.

1 Robert J. Aguon, of the village of Barrigada, was born on July 5, 1959 to Jose and
2 Francisca Aguon; and

3 **WHEREAS**, Ferdinand B. Soriano attended Father Dueñas High School from
4 1983 to 1985 and graduated from the University of Guam in 1989 with a Bachelor of
5 Science in Criminal Justice, and Mr. Robert J. Aguon graduated from George
6 Washington High School in 1978 and obtained his Associate of Science in Criminal
7 Justice; and

8 **WHEREAS**, Ferdinand B. Soriano have faithfully served Guam Customs and
9 Quarantine agency since March 9, 1993, retiring on the 30th of September, 2020 and
10 serving the island of Guam for Twenty-Seven (27) years, while Robert J. Aguon joined
11 Guam Customs and Quarantine on November of 1995 and retired on October of 2021,
12 dutifully serving our island for Twenty-Eight (28) years; and

13 **WHEREAS**, while in Guam Customs and Quarantine agency, Ferdinand B.
14 Soriano was a Public Information Officer and a Supervisor Captain in charge of several
15 locations such as the Antonio B. Won Pat International Airport, the Port of Guam,
16 Andersen Air Force Base MAC Terminal, Cargo Operations, and the Property and
17 Evidence Custodial office, while Robert J. Aguon was Officer in Charge at Antonio B.
18 Won Pat International Airport, Cargo Operations, the Port of Guam, Andersen Air Force
19 Base MAC Terminal, the Property and Evidence Custodial office, and the Internal
20 Affairs Section; now therefore be it
