WHEREAS, Mr. Raymond "Shino" Shinohara felt a strong sense of duty to his island and country. Through this sense of duty, he enlisted in the United States Marine Corps (USMC) on June 22, 2003. He went on to serve in deployments to various parts of the Middle East including Afghanistan and Iraq; and

WHEREAS, "Shino" became a Staff Sergeant and after eleven (11) years, he ended his career in the USMC to give back to his island community and other veterans; and

WHEREAS, "Shino" earned a bachelor's degree in Social Work from the University of Guam. He went on to earn a master's degree from the University of Hawai'i at Manoa in 2020; and

WHEREAS, based on Shino's experience and education he became a Social Strategy Consultant and Mental Health Practitioner. It was through these professions "Shino" saw firsthand the needs and struggles his fellow veterans faced while transitioning back into civilian life, such as homelessness, post-traumatic stress disorder, and depression; and

WHEREAS, in 2015, "Shino" founded Green Valor, a community-based organization created with the purpose of assisting fellow veterans transition back into society by providing support to Guam's veteran community; and

WHEREAS, in 2022, Mr. Raymond "Shino" Shinohara joined his fellow Marine veterans, Mr. Justin "JD" LeHew and Mr. Coleman "Rocky" Kinzer, on a mission to trek across the United States to raise awareness and support for thousands of US service members that were Prisoners of Wars (POWs) or missing/killed in action from all wars and conflicts; and


WHEREAS, known as Team Long Road, the group of three (3) traversed across the country on foot via US Route 20, which spans Three Thousand Three Hundred and Sixty-Five (3,365) miles through twelve (12) states; now therefore, be it




