3 **WHEREAS**, it is the sense of *I Liheslaturan Guåhan* to recognize the life and
4 accomplishments of those distinguished citizens of this great island, and it is the custom
5 of *I Liheslaturan Guåhan* to commend those public servants who have devoted
6 themselves faithfully serving in the best interests of this community and the needs of its
7 residents; and

8 **WHEREAS**, Antonio N. Martinez began his years of service to the people of
9 Guam in February 1978 as a Gardener at the Commissioner's Office before becoming
10 a Custodian in March 1986 at the Department of Military Affairs, a Trades Helper in
11 October 1991 at the Department of Public Works, and a Utility Worker in December
12 1995 at the A.B. Won Pat International Airport Authority; and

13 **WHEREAS**, Antonio N. Martinez has dedicated his time and efforts to helping
14 the people of Guam through the completion of training such as Scaffold Safety Training,

1 40-Hour Initial Hazardous Waste Operations and Emergency Response,
2 Communications Skills for Internal and External Customer Service Certification, 8-
3 Hour Hazardous Waste Operations and Emergency Response (HAZWOPER) Refresher
4 Training, and Ethical Rules and Standards of Conduct; and

5 **WHEREAS**, Antonio N. Martinez was recognized throughout the years for his
6 distinguished service and commitment to the people of Guam and has earned awards
7 including the GIAA 5-Year Service Award, GIAA 10-Year Service Award, GIAA 15-
8 Year Service Award, GIAA 20-Year Service Award, GIAA 25-Year Service Award,
9 and a Certificate of Appreciation for being apart of the Airport Recovery Team sent to
10 assist the Commonwealth Ports Authority and the Saipan International Airport recover
11 from the devastation of Typhoon Soudelor; and

12 **WHEREAS**, on September 20, 2024, Antonio N. Martinez retired from an
13 outstanding career with the Government of Guam and the A.B. Won Pat International
14 Airport Authority after Thirty-Two (32) years of faithful service; now therefore, be it

16 on behalf of *I Liheslaturan Guahan* and the people of Guam, recognize Antonio N.
