

- Appointment packet forwarded to this committee for public consideration on June 12, 2023.

# II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 8:33 AM.

**Chair Tina Rose Muna Barnes:** *Buenas yan håfa adai todus hamyo*! This public hearing by the Committee on Human Resources, *Hagåtña* Revitalization, Regional Affairs, Public Libraries, Telecommunications, Technology and Federal and Foreign Affairs is called to order. It is 8:33 in the morning.

On the agenda, ladies and gentlemen, we have the:

- Reappointment of Nicole B. Nelson to serve as Member (Information Technology Representative), Guam Public Library System Board of Directors.
- Appointment of Nolan G.T. Flores to serve as Member (General Public Representative),
   Guam Public Library System Board of Directors.

Joining me here this morning, I'd like to thank my colleague, Senator Taitague.

Before we proceed with the discussion, I would first like to provide some General Rules of Conduct for all who are in attendance. The conduct of this hearing shall be as follows:

With that being said, because all three of the reappointments are for the Guam Public Library System, I'm going to do something a little bit different. Do we have the sign up sheet? My colleague agrees with me. We're going to go ahead and get all the appointees up here. And, and please, please join us on the table.

Uh, and I, I understand, all three of the reappointments, are eager and willing to continue to serve. And I want to extend my un dangkolo na si Yu'os ma'ase'. And, it's such, a humbling pleasure to know that wanting to serve the library and the kids, the children, literally, takes to heart about the, the work that you do, for, for the children. So I want to say thank you in advance.

And, since we have it, So, based on the public hearing schedule, I'll go ahead and, and just have all of you three do your, your oral testimony. And then if anyone else comes in, to, share some, oral testimony, I'll go ahead and invite them up. So we'll go ahead and start with you and then Nicole and then Nolan.

I know you understand, right? We'll give the women a chance. So with that being said, Dr. Storie, you may proceed.

**Monique R.C. Storie, Ph.D., Nominee:** Håfa Adai. Good morning. For the record. My name is Dr Monique Storie and I have been a resident of the island of Guam since my birth. And, so I have over 25 years of experience working in libraries, as both as a librarian, as well as, my current position, which is Dean of the University Libraries.

I have been a patron of the Guam Public Library System since I was able to sign for a library card, I believe in 1976. So, I have been a long, lifelong advocate of the library system. And I thank you for the opportunity to continue to serve it as a member of the Board.

**Chair Tina Rose Muna Barnes:** You're very welcome, Doc. And now I'll have Ms. Nicole Nelson. You may proceed.

**Nicole B. Nelson, Nominee:** Thank you. my name is Nicole Bordallo Nelson, and I work at the Office of Technology, and I, I'm honored to be the Info Technology Rep on the Library Board. This is my second term, so I'm looking forward to, helping out. Thank you.

**Chair Tina Rose Muna Barnes:** Thank you. And, Nolan.

**Nolan G.T. Flores, Nominee:** *Håfa Adai, Guahu si* Nolan Flores. I prepared testimony. Mine's an appointment, not a reappointment. So, let me Yes. (*Nolan Flores reads written testimony hereto attached*)

Chair Tina Rose Muna Barnes: *Buen Prubechu*, Mr. Nolan Flores, and my apologies, I, I was so used to seeing you continuously come in, for the appointment that I just said it was a reappointment when I knew it was transitioning from student to... I want to say it is through your dedication, all three of you. And your commitment to the children here on our island and making sure that we make our Guam PublicLibrary a better place for our children to go to, especially with modern technology and what the kids can access to through the tip of their fingers.

And getting information, having this library is still really key for a home where, where children and, and adults can go to, to literally get information to literally work on educational documentation, to just a resource of learning that you guys have to offer.

And I want to say also thank you for your updates in what's happening with the library. I know that since you folks have been on board and the Executive Director, that you have not stopped looking for other alternatives and resources for the library. And then getting the bookmobile up into the community just goes to show that you guys are really, really committed.

And with that being said, I want the audience that's listening and those here in the hearing room to know that you, all three of you have my 100 percent support. I will ask our committee, our team to expedite the reports, the committee reports immediately and see if we can get all of you three on the October Agenda. I'd be remiss if I didn't recognize and say good morning to Senator Joanne Brown, who's also joining us. And I'm going to go ahead and yield, to my colleagues for any comments or questions. I'll start with Senator Taitague. Please proceed.

**Senator Telo T. Taitague:** Thank you and good morning, Vice Speaker. Well, you know, it's important to be here because your commitment to this island deserves respect and deserves our time too. Thank you so much for stepping up to the plate again and again. I greatly appreciate you all have great skills and, and can contribute greatly to the library.

So, I'm going to start with Dr. Storie. Dr. Storie, you are currently at the University of Guam as the Library Dean there, right? So you're bringing a wealth of information and knowledge, and even sharing maybe some stuff at the University of Guam and incorporating it into our public library, which is very instrumental. But what are you doing on with the *manåmko*?

I mean, that's one area that's different from the University of Guam in a way, you know, it's not something that you always deal with constantly, but you know, as our population is aging, it's getting to a point where there are more, they're going to be more seniors than there are children by the year 2023. And I mean, sorry, 2030.

And, So how, how is the library going to adjust to this aging population to assist them at the library? Not everyone is techie, but you know.

**Monique R.C. Storie, Ph.D., Nominee:** Thank you for that question. You're right. A lot of our seniors are not techie, and there are a number of us I am starting to get into that age group, that, enjoy the, the analog formats, the, the printed book and so forth.

And so, one of the things that we want to, to get a sense of, is to actually find out from our community what are their preference in terms of formats and that will help the library to be able to build their collection and build their services. So, if they're, if there are, I know that in the past, the library has had a very robust program in terms of teaching the *manåmko'* how to work with a computer and electronic gadgets.

And so, if that is still a need and still a desire, then the library can continue on that particular educational purpose. Other ways would be to find out what types of resources they're looking for. It can be something as simple as expanding magazines and journals or it could be in the number of printed novels or nonfiction works.

**Senator Telo T. Taitague:** Very good. And also, maybe incorporate, a lot of the seniors, particularly, they enjoy donating their time, volunteering...

Monique R.C. Storie, Ph.D., Nominee: Yes.

**Senator Telo T. Taitague:** So, if there's any opportunity or any kind of program that can do it, I'm sure you're going to get a lot of help, you know, maybe going to different libraries or being part of any kind of outreach program, you know, at the Micronesian Mall, you know, having them there, there's so many *manåmko'* out there who are retired and would love to contribute to the island in this way, so, take advantage of that.

**Monique R.C. Storie, Ph.D., Nominee:** That's a great idea. There are, across the nation, programs where um their inter-generational programs where, you would have an elder who... serves as a mentor. So, if there is a particular skill that they hold, that they can share it through the library, a workshop of some, of some sort.

**Senator Telo T. Taitague:** Okay, great. I look forward to seeing your progress on that. Okay, thank you. And thank you again so much for serving. I appreciate it.

Mr. Flores, you know, I, very impressed every time you come in front of me, you know, and the comments that you make are always being prepared, you know. But, I'm hoping that with your reappointment, you'll continue to provide the library, public library with cultural education because of your background.

You know, not just in Guam, but the Micronesian area, you know, with, even Saipan and everything come together, so, what type of cultural aspect are you trying to integrate into the public library to keep our heritage and our history alive at, at the library? And, and. Put it at the forefront. Okay.

I'm, I'm dictating here, right now, put it at the forefront. You know, ways that we can really keep it alive because, you know, we, this is all we have. Our, our heritage, our culture is really all we have and our language. We lose that, we just become any ordinary person in the world. So, how are you going to put that in the forefront?

**Nolan G.T. Flores, Nominee:** Yes, si Yu'os ma'ase' Senator Taitague for that question. I'm, I'm currently a graduate student with the Micronesian Studies program and, even in my undergrad.

Chamorro language reclamation has been very much, you know, one of my passions and one of my research interests. I'm currently working also on a grant that, it's with the Spencer Foundation. It would work with DOE with GCC, UOG to improve the, the pre-K through age 20. Right. So the entirety of the K through 12 system, improved Chamorro Medium education there and we have identified in the grant proposal, we're still pending the grant of course. We've identified GPLS as a partner, right.

Whether that's in what, the archiving work that we might do through GPLS, maybe serving as a, as a one of or the only archive place, for whatever resources are gathered from that, grant, righ/t. We're working on things like curriculum. I think also just the space of it, right. Bringing different community orgs into the library, different initiatives, right.

We've seen work with UOG Press, recently a memorial for the late Chris Perez Howard was held at the library, right. and I think that's a, that's a really good example of, of how we just need to bring in all these different programmings to show people, right. They, they come here for that, but then they see all of these offerings that we have at the libraries that, you know, they might not know of. Even the e-book service, right, that has, ;ocal books, and that might have, you know, cultural resources. So it's, it's not the libraries of the past where it's just, you know, books that may have been, may be very outdated, right?

There, we're constantly updating that, that catalog. So I think that's, that's how it's done, right? Through bringing all these different, there's a lot of ongoing work in our community. So bringing it into the library.

**Senator Telo T. Taitague:** Excellent. Excellent. I really appreciate that, Mr. Flores, and I look forward to the work that you're going to continue to do and make the library a great place.

Grant, I know you, you're probably capable of doing this, I know you are, and, and I'm hoping that, you can look at areas where you can bring funding to the library. A lot of our buildings are falling apart. You know, a lot of them, and we're forgetting that. We're forgetting to set aside funding, you know, for our infrastructure. And then, once we do have the funding, we forget to set aside maintenance. So, please look into grant funding and, even finding another location for a library. You know, so thank you again.

So the next one I have in line is, and for the record, I have to, divulge this, that, Nicole is my daughter and, she's my stepdaughter and I've known her forever. And I'm so very, very proud of her that not only that, I mean, she can do so many things, especially where she was in the States, as an IT working back there. I was just so proud of her, but she decided to come home and bring her talent to Guam. And I thank her for that because now I can see her baby, the grand.

Yeah, it would be my first, right? But I'm so very happy that you're at the library, Nicole, because, this technology is huge in this line. Not just, you know, for the next generation coming up,

sustainability, archiving the books, information, data is so important and, you'll have a lot of work into it.

But, one of the other things I'm, I'm sure you've always heard me tell you, or even speak about is, cybersecurity and how can the library system, if it is already hooked up to I.T., you know, the Office of Technology, because I know office of technology covers of a few departments and agencies, right?

And, and explain that, and is the library under office technology? Because then it gives me more comfort to know that, at least we've got watchdogs.

**Nicole B. Nelson, Nominee:** Thank you. Yes, Guam Public Library is under, well, it's known as the GGWAN, which is the GovGuam Wide Area Network, which is managed by the Office of Technology. It's actually all the line agencies, plus boards and commissions. So, we work very, very hard to secure things. We do run into issues such as, you we're doing the best that we can with what we have and we do take cyber security very very seriously. So the library is well protected.

**Senator Telo T. Taitague:** That's good to know very good to know. I mean we just heard about GEDA how they got hacked recently, you know. In fact, I don't even know if it was recent it might have been a while ago because we're just getting word of it like some other departments and agencies that were hacked, you know, we don't know about it. The public doesn't know about it until like Three weeks later or two weeks later.

So it's, it's a very, scary situation. So I'm glad you're on top of it. Definitely you're a great asset to it. Thank you again for coming home and, and bringing your talent back home to Guam to serve our community. So the way I see this madam chair is that this is an A team. This is an A team for the library. So we are very blessed to have you. I have to leave for another appointment, but again, congratulations. Okay, and you definitely, the three of you, have my support.

**Chair Tina Rose Muna Barnes:** Thank you, Senator Taitague. And before I ask Senator Brown to say some comments, I just want to acknowledge Senator Roy Quinata, who took the time to come in this morning. *Si Yu'os ma'âse yan manana si Yu'os*. Senator Brown, I will recognize you at this time. Please proceed. Thank you very much.

**Senator Joanne Brown:** Madam Chair. It's always interesting. We come all the way to Hagåtña to see each other and we just live down the street in Pago Bay, but, this is our meeting place. I concur with the, the sentiments that our chairwoman and, Senator Telo have made.

It's not every time we come here for confirmation hearings are actually pleasant for me. so I'm very pleased. I don't have a few questions, but I do want to recognize your, your talents and your capabilities. Mr. Flores, I know we've seen each other from the, Time we were during the pandemic and having to get on the computer and do your confirmation hearings. I mean, you're an old pro already I don't know how many times you've come before us in such a short time But

ask your thoughts on that and how can we strengthen the village libraries that we've had, you know, to get more support to, to have them operating on a more regular basis.

# Chair Tina Rose Muna Barnes: Anyone. Sure.

**Nolan G.T. Flores, Nominee:** Okay. Yes. thank you Senator Brown for the question. I think it's a matter like Dr. Storie said in her, her testimony, right, of identifying what the need is. we've seen the library kind of shift, even in recent years, right? We've tried to do, even late night hours, right? So staying open from that 5 p.m. to 8 p. m. time slot for, let's say parents who are getting off of work at five and would like to bring their kids to the library and go to the library with them, right? Maybe for their own self-enrichment. But we, we saw that the numbers weren't too great, right? So maybe there isn't necessarily a demand for that. So hence the shift, back to the, the usual eight to five.

I think another thing, right, is that we've, the e-book offering, that's an example, right, of how we can make this, make the library's needs more, adapted to, I'm, I'm sorry, the library service is more adapted to the public's needs, right? I was really impressed just recent, just last night, checking the GPLS website. it was revamped. there's even, you know, there's local books by Chamorro scholars, you know, Chamorro authors there, on the website in e book form. So if you have the library card, you put in your number and you get access to that, right, without ever having to, step into the library physically.

Likewise with some of the multimedia options that are available on the library website. I saw that there were videos there. So that's really cool. I think, right, that's, it's, we need to assess the need first. Excuse me. And from there, consider whether what we're offering in terms of technology wise is effective and is, you know, meeting the need that's there.

**Nicole B. Nelson, Nominee:** Yes, I definitely, with what Nolan said about how they tried extending hours before, I think maybe part of the problem is that a lot of people didn't realize that these hours were extended. So more community outreach, notification to everybody that we do have, I think we should try it again, basically. That's what I'm thinking, yeah.

Monique R.C. Storie, Ph.D., Nominee: So the library has stepped up its social media presence and that has, useful in, bringing more awareness of what kinds of, services are offered, ways to access the library without actually entering into the library. I think one of the things that, we can, encourage is, a rethinking of how, how we can How do we count when people come in? And so, the traditional thought is if they walk through the door, that that's a count. But with the instances of e library, or e books, checkouts, it's, even if they don't walk through the doors, if they are accessing this material, then we should, see that as being a useful, engagement with the library. Other options that we may explore, would be that idea that Nolan had talked about is meeting the, the people where they're at. so, across the nation there are other programs where the library has the ability to go not only out into the, into the public through like the, the bookmobile system,

but they also, do partnerships with, school libraries or, or malls, venues where the people are at and they just have like a pop up kind of event. So, there are, there are different options based on what we learn from what our community wants and needs.

Senator Joanne Brown: Well, I, very much appreciate the answer and I didn't realize, so we could get on the, the library website and, and explore what, what is there in the catalog and inventory and. I do have a library card, believe it or not, in my wallet. I had to take it out and put it up. It has my name on it. so I, I appreciate that. That's good to know that we can also do that. But again, I'm very pleased. I don't always have enjoyable confirmation hearings. But in this particular case, all three of you, you certainly made our morning. And I appreciate your, your public service. I don't think a lot of people realize the value of public service. And you literally, I mean, you're more so the public servants than we are, because we actually get paid for this job. but, but to contribute and, and contribute to your community to make it better is, is really admirable. I wish we had more people that would step up to the plate to do what you're doing. So you certainly, no doubt, have our, have our vote and we look forward to your continued work. Thank you. Thank you, Madam Chair. Thank you.

Chair Tina Rose Muna Barnes: Si Yu'os ma'åse' Senator Brown, Senator Quinata you may proceed.

**Senator Roy A.B. Quinata:** *Si Yu'os Ma'åse* madam Chair and colleagues. Good morning to those attending live *Håfa adai yan Saludus* to the panel and to those who are taking up this public service, right? It's very refreshing to see a younger face and it's very rare you see young people stepping up to do public service, so, I admire your passion. I know you're a very instrumental individual regarding the independence movement and I know you continue to be very involved in any, in many and numerous civic engagements in including the University of Guam. And I commend you for your passion and again, engagement in all those capacities. Dr. Storie. And, Mrs. Nelson, thank you for stepping up as well to serve in the public, capacity. I understand you both have, education from off island and I really thank you guys for coming back and being of service to the island that, you came from, right?

So, you guys have no questions for me. I wish you all the best. My office stands ready to support in whatever capacity. Let's keep this committee report short so you guys can get on to the confirmation on the Session floor.

**Chair Tina Rose Muna Barnes:** You're very welcome, Senator Quinata, and as I close on this public hearing, I just want to say it literally is refreshing and share the same sentiments as Senator Brown and Senator Quinata and Senator Taitague.

Not very easy, right, when you have to volunteer your time. and your efforts to help the community and you guys continue to do so, through your discipline, through your experience, through your work, and you guys have literally brought the synergy back to the library. I know

that the executive director has been working really hard to try and get resources back, from any which way he can, right? Back in, with, DC and Uncle Sam and and just looking for more opportunities. You guys have been able to literally work in that journey and I'm so appreciative that I don't have to hear any kind of rhetoric of not being able to do something and even with the resources being tight, you guys have been able to at least give it from your heart and volunteer from your heart.

And I know we don't pay you guys, but you know, in the efforts of giving back to the community, you folks, the three of you have really taken that time to step up. So don't call in a seat. So *un dångkolo na si Yu'os ma'åse'*. I will note for the record that, Nolan does have a fan club. I did get, testimony from, three different testimonies from, a Keisha Borja Quichocho, a Robert Barcinas, and I hope I don't slaughter this last name, a Joseph Madlangbayan, who, who said they support the efforts of what you're doing, Mr. Flores, and wanted to, present written testimony. I will keep the record open, and then I'll do, I'll do my closing remarks right now.

Si yu'os ma'ase' todos hamyu! If there is no one left to testify, the public hearing on:
