Good Morning Chairman Quinata and members of the 37th Guam Legislature. Thank you for taking time for me this morning. I will make sure I keep my comments brief.

My name is David John. I am current Chairman of the Guam Economic Development Authority and I have been a board member of GEDA since the start of the Calvo Administration. I am honored by Governor Leon Guerrero having confidence to continue in my role with the agency. I hope you will find me an acceptable candidate to continue as a member of the board for a 4th term.

In my professional life, I am Managing Director of ASC Trust LLC. ASC is the leading provider or retirement plan services in Micronesia, serving over 35,000 participants and \$1 billion in assets. I am also an active board member of the University of Guam Endowment Fund and was recently appointed Chairman of the Archdiocesan Finance Council. Most importantly, I am the husband of Teresa Ada John. Together we have two sons, Pedro and Anthony.

When I came before this committee four years ago, tourism had hit record highs and the construction of Camp Blaz was well on its way. Being involved as an active member of the GEDA Board, I was aware that at that point in time, the feedback received from bond analysts and ratings agencies that was echoed when Governor Leon Guerrero came in to office was the need to diversify the economy. When COVID19 hit, and tourism went from all-time highs to zero tourists, the need to diversify became much more magnified.

Before, I get into our efforts in diversification, however, let me share with you that the urgency at the outset of the pandemic was life support to Guam 2000 plus brick and mortar establishments. GEDA launched multiple programs to provide a life line of support starting with the Small Business Pandemic Assistance Grant in 2020 to the Local Employers' Assistance Grant in 2022. Even now as the funnel of struggling businesses narrows down to those heavily involved in tourism, we still find ourselves providing support through what we hope to be funding for the next LEAP Supplement Grant. The grand total of aid passing through GEDA's doors since 2020 under my Chairmanship equates to well over \$130 million. I am proud to steward such support and am equally proud of the team who rose to the occasion time after time to mobilize help quickly, effectively, and within federal guidelines.

Through my involvement with the Guam Chamber of Commerce, I encouraged Governor LG to empanel a diversification task force to look at opportunities that could benefit our island. We resurrected some legacy projects such as Captive Insurance and Trusts, and launched new initiatives in:alternative manufacturing, ship repair, agriculture, aquaculture, pharmaceutical, and technology opportunities.

We have seen a lot of activity in alternative manufacturing, ship repair and technology opportunities centered around cable landing and data centers already. In fact, today, at a round table, we will be reporting on what we have learned and progress made in the various industries. However, to take these opportunities to the next level we need to make sure that permitting is timely, we have an educated workforce for the skills required for the jobs, of which I am excited that many of the jobs in these industries are trade skill that pay well, and if government land is needed, that we have come up with a solution for leasing land that extends beyond five years which is not near enough time for a financial lease.

If approved by this body, I would like to continue to work to continue to strengthen the Qualified Certificate Program and focus the efforts of the agency on economic diversification efforts. We currently have seven applicants who have expressed an interest in our QC Program, in the areas of waste mitigation/circular economy, affordable housing, insurance, and tourism. This is more action in the QC space than we have seen in decades. To properly navigate the balance between what will attract outside investment without "giving away the house" has been a challenge over the years, but something I am comfortable to discuss how we have reformed the process and continue to build a sharper incentive program.

Lastly, I wanted to point out the great amount of work GEDA has done particularly in the last four years working with emerging small businesses through incubators like GUMA, the State Trade and Export Program, and our lending initiatives. At one time, GEDA was known for bonds and QC's. We are now a great resource for entrepreneurs to check in when they are contemplating "taking the LEAP".

I want to keep my comments short so that you have time to ask me questions that are on your mind. With this, I would like to thank this body for your time.

Håfa Adai Chairman Quinata and Members of the Committee:

My name is Melanie Mendiola, and I am the Administrator/CEO of the Guam Economic Development Authority. I have served since the first term of Governor Leon Guerrero and solely under the Chairmanship of David John. I knew the nominee prior to then primarily through my involvement in the financial services industry and my time as the Executive Director of the UOG Endowment Foundation.

At GEDA, we are considered a small agency with under fifty employees. The role of the board is to steer the agency strategically, supervise me, and ultimately carry out the mission of the organization to build a sound and sustainable economy that makes the lives of the people of Guam better. During Chairman John's leadership, we have achieved multiple milestones including the following:

- In years prior to his Chairmanship, the OPA issued a scathing report about how QC Community
  Contribution money was allocated towards nothing but agency travel and special interests.
  Under the leadership of Chairman John, we created the QC Community Contribution Grant
  Program, which has since passed over \$1.8 million to over 87 nonprofits and agencies for
  projects related to culture, sports tourism, economic development, and education.
- During the COVID19 Pandemic, Chairman John facilitated the meeting of industry stakeholders
  with the Governor who ultimately directed over \$130 million in direct aid to Guam's small
  businesses. His leadership involved overseeing the creation and passage of SOP's and getting aid
  to the community in a timely manner within the resource constraints of the agency and in
  compliance with federal and local law.
- The Governor called on GEDA to assist DPHSS with the childcare industry where millions of dollars were at stake to be lost. Under Chairman John's leadership, we quadrupled the enrollment in the Childcare Block Grant Program, issued millions to make daycares safer for kids, and expanded after school offerings for Guam's youth population. Additionally, every village Mayor has been recently approved for up to \$600K for youth programs. This boon to the childcare industry is now showing the fruits of its labor as people are getting back to work and daycares, although expanded, are hitting capacity. It looks like we will continue to do more with DPHSS in the coming years.



- Under the leadership of Chairman John, the GEDA team has facilitated over \$100 million in bond payment savings and the upgrade of the general ratings outlook from "negative" to "stable" and for the first time, "stable" to "positive" since Moody's started reviewing the Guam credit in 2017.
- Under the leadership of Chairman John, Guam was approved for \$61 million under the State Small Business Credit Initiative, of which, the first tranche of \$17 million arrived locally in this fiscal year for our lending and venture capital programs.
- In our Real Property space, Chairman John oversaw the collection of back rents from Guam Ancestral Lands Commission tenants which dated back two previous Administrations and amounted to just under \$5 million owed to the land bank trust account.
- Under his leadership, GEDA went from doing very little for small businesses to offering the
  pandemic aid discussed previously, forging ties with local incubators including GUMA and
  subsequently providing seed funding to local entrepreneurs and export support of around \$1
  million to over 15 businesses.
- Lastly, under his leadership, we have an active federal grant seeking arm of the agency who has
  assisted in securing millions just in the last two years in federal aid towards economic
  development initiatives.

Chairman John and I have a terrific working relationship, and in times where we do not agree, I find that he is open to a great exchange of ideas. He holds the agency to the standards of the many corporates he has deep experience running over decades of his distinguished career. I appreciate that, as I believe GEDA is an excellent training ground for business professionals in the community, including myself. On a personal note, I appreciate the fact that Chairman John is a man of faith, and his actions on the board speak to his standards of ethics, fairness, and doing what is right.

As we continue to serve the people of Guam, it is imperative we have the knowledge, expertise, and compassion at the helm of the agency. I urge the committee to hastily confirm Chairman John for another term at the Guam Economic Development Authority. I am available for questions as well.

DAVID JOHN: GREAT, THANKS SENATOR GOOD MORNING OR GOOD AFTERNOON CHAIRMAN QUINATA MEMBERS OF THE 36 37TH GUAM LEGISLATURE THANK YOU FOR THE TAKING THE TIME FOR US I'LL BE HAPPY TO MAKE I'LL BE MAKE SURE MY MAKE MY COMMENTS BRIEF AND MAYBE I CAN READ HERE IN A SECOND OKAY.

MY NAME IS DAVID JOHN I'M CURRENTLY THE CHAIRMAN OF THE GUAM ECONOMIC DEVELOPMENT AUTHORITY I'VE BEEN A BOARD MEMBER OF GEDA SINCE THE START OF THE CALVO ADMINISTRATION I'M HONORED BY GOVERNOR LEON GUERRERO HAVING CONFIDENCE IN ME TO CONTINUE MY ROLE WITH HIS AGENCY I HOPE YOU'LL FIND ME AN ACCEPTABLE CANDIDATE TO CONTINUE AS A MEMBER OF THE BOARD FOR THE FOURTH TERM IN MY PROFESSIONAL LIFE I'M MANAGING DIRECTOR OF ASC TRUST LLC ASC IS THE LEADING PROVIDER OF RETIREMENT PLAN SERVICES AND MICRO MICRONESIA SERVING OVER 35,000 PARTICIPANTS AND A BILLION DOLLARS IN ASSETS I'M ALSO AN ACTIVE MEMBER OF THE UNIVERSITY OF GUAM ENDOWMENT FUND AND WAS RECENTLY APPOINTED THE CHAIRMAN OF THE ARCHDIOCESAN FINANCIAL COUNCIL MOST IMPORTANTLY I'M THE HUSBAND OF TERESA ADA JOHN AND TOGETHER WE HAVE TWO SONS PEDRO AND ANTHONY ARE SITTING BEHIND ME HE'S IN TOWN FOR VISITING HIS MOMMY WHEN I CAME BEFORE THIS COMMITTEE FOUR YEARS AGO TOURISM HAD HIT RECORD HIGHS AND THE CONSTRUCTION OF CAMP BLAS WAS WELL ON ITS WAY BEING INVOLVED AS AN ACTIVE MEMBER OF THE GEDA BOARD I WAS AWARE AT THAT POINT IN TIME THAT THE FEEDBACK RECEIVED FROM BOND ANALYSTS AND RATING AGENCIES THAT WAS ECHOED BY GOVERNOR LEON GUERRERO WHEN SHE CAME INTO OFFICE WAS THE NEED TO DIVERSIFY THE **ECONOMY WHEN COVID-19**

ON THIS PROGRAM I WANT TO ACKNOWLEDGE GEDAS TEAM EFFORTS TO INVOLVE THE ENTIRE PRIVATE SECTOR AND THE DESIGN OF THE PROGRAM TO ENSURE THE PROGRAMS INVESTMENT WAS LEVERAGE TO DO THE MOST GOOD AND FROM THE RESPONSE I'VE RECEIVED FROM THE BUSINESS COMMUNITY I THINK THE TEAM NAILED IT EVEN NOW AS THE AS THE FUNNEL OF STRUGGLING BUSINESSES NARROWS DOWN TO THOSE HEAVILY INVOLVED IN TOURISM WE STILL FIND OURSELVES PROVIDING SUPPORT THROUGH WHAT WE HOPE TO BE THE FUNDING FOR THE NEXT LEAP SUPPLEMENTAL GRANT PROGRAM THE GRANT TOTAL OF AID PASSING THROUGH GEDAS DOORS SINCE 2020 EQUATES TO WELL OVER 130 MILLION DOLLARS I'M PROUD TO STEWARD SUCH SUPPORT AND I'M EQUALLY PROUD OF THE TEAM WHO ROSE TO THE OCCASION TIME AND TIME TO MOBILIZE HELP QUICKLY AND EFFECTIVELY WITHIN THE FEDERAL GUIDELINES AND I ACKNOWLEDGE THAT THEY DID THIS A LOT ON THEIR OWN TIME PUTTING IN THEIR OWN HOURS AFTER HOURS IN KEEPING WITH OUR EFFORTS TO WORK WITH THE COMMUNITY WE ENCOURAGE GOVERNOR LEON GUERRERO TO INVITE THE GUAM CHAMBER OF COMMERCE TO IMPALE A DIVERSIFICATION TASK FORCE TO LOOK AT OPPORTUNITIES THAT COULD BENEFIT OUR ISLAND WE RESURRECTED SOME LEGACY PROJECTS SUCH AS THE CAPTIVE INSURANCE TRUST AND LAUNCHED NEW INITIATIVES AND ALTERNATIVE MANUFACTURING OR 3D PRINTING SHIP REPAIR AGRICULTURE AQUACULTURE PHARMACEUTICAL AND TECHNOLOGICAL OPPORTUNITIES WE'VE SEEN A LOT OF ACTIVITY IN THE ALTERNATIVE MANUFACTURING SHIP REPAIR AND TECHNOLOGY OPPORTUNITIES CENTERED AROUND CABLE LANDING AND DATA CENTERS ALREADY IN FACT TODAY AT TODAY'S ROUNDTABLE THE TEAM WILL BE REPORTING AT WHAT WE HAVE LEARNED AND PROGRESS MADE IN THE VARIOUS INDUSTRIES HOWEVER TO TAKE THESE OPPORTUNITIES TO THE NEXT LEVEL WE NEED TO MAKE SURE THAT PERMITTING IS TIMELY WE HAVE AN EDUCATED WORKFORCE FOR THE SKILLS REQUIRED FOR THE JOB OF WHICH I'M EXCITED AT MANY OF THE JOBS IN THE INDUSTRIES WERE WORKING ON ARE TRADE SKILLS THAT PAY VERY WELL AND IF THE GOVERNMENT LAND IS NEEDED FOR THESE PROJECTS THAT WE COME UP WITH A SOLUTION FOR LEASING LANDS THAT EXTENDS BEYOND FIVE YEARS WHICH IS NOT NEAR ENOUGH TIME FOR A FINANCIAL LEASE I HAVE IDEAS ON THESE AREAS OF CONCERN IF YOU'D LIKE TO DISCUSS THEM IN MORE DETAIL IF APPROVED BY THE BODY I WOULD LIKE TO WORK TO CONTINUE TO STRENGTHEN THE QUALIFYING CERTIFICATE PROGRAMS AND FOCUS THE EFFORTS OF THE AGENCY AND ECONOMIC DIVERSIFICATION EFFORTS WE CURRENTLY HAVE SEVEN APPLICANTS WHO HAVE EXPRESSED INTEREST IN THE QC PROGRAM IN THE AREAS OF WEIGHTS MITIGATION CIRCULAR ECONOMY AFFORDABLE HOUSING INSURANCE AND TOURISM THIS IS MORE ACTION IN THE QC SPACE THAN WE'VE SEEN IN DECADES TO PROPERTY PROPERLY NAVIGATE THE BALANCE BETWEEN WHAT TO ATTRACT OUTSIDE INVESTORS WITHOUT GIVING AWAY THE HOUSE HAS BEEN A CHALLENGE FOR THE YEARS BUT SOMETHING I'M COMFORTABLE TO DISCUSS IS THAT WE'VE REFORMED THE PROCESS AND CONTINUE TO BUILD A SHARPER INCENTIVE PROGRAM LASTLY I WANT TO POINT OUT THE GREAT AMOUNT OF WORK GEDA HAS DONE PARTICULARLY IN THE LAST FOUR YEARS WITH EMERGING SMALL BUSINESSES THROUGH OUR INCUBATOR GUMA PROJECT THE STATE TRADE AND EXPORT PROGRAM AND OUR LENDING INITIATIVES AT ONE TIME GEDA WAS KNOWN FOR BONDS AND QCS AND WERE ALL WE ARE NOW A GREAT RESOURCE FOR INTER ENTREPRENEURS TO CHECK IN WHEN

THEY ARE CONTEMPLATING THEIR GREAT LEAP I WANT TO KEEP MY COMMENTS SHORT SO I'LL THROW OPEN ANY QUESTIONS THAT YOU MIGHT HAVE THANK YOU.

CHAIRMAN QUINATA: WE'LL JUST GO AHEAD AND HEAR MISS MELANIE HEARING TESTIMONY FIRST.

MELANIE MENDIOLA: HÅFA ADAI CHAIRMAN QUINATA AND MEMBERS OF THE COMMITTEE SENATOR TAITAGUE MY NAME IS MELANIE MENDIOLA AND I'M THE ADMINISTRATOR CEO OF THE GUAM ECONOMIC DEVELOPMENT AUTHORITY I HAVE SERVED SINCE THE FIRST TERM OF GOVERNOR LEON GUERRERO AND SOLELY UNDER THE CHAIRMANSHIP OF DAVID JOHN I KNEW THE NOMINEE PRIOR TO THEN PRIMARILY THROUGH MY INVOLVEMENT IN THE FINANCIAL SERVICES INDUSTRY AND MY TIME AS THE EXECUTIVE DIRECTOR OF THE UOG ENDOWMENT FOUNDATION AT GEDA WE ARE CONSIDERED A SMALL AGENCY WITH UNDER 50 EMPLOYEES THE ROLE OF THE BOARD IS TO STEER THE AGENCY STRATEGICALLY SUPERVISE ME AND ULTIMATELY CARRY OUT THE MISSION OF THE ORGANIZATION TO BUILD A SOUND AND SUSTAINABLE ECONOMY THAT MAKES THE LIVES OF THE PEOPLE OF GUAM BETTER DURING CHAIRMAN JOHNS LEADERSHIP WE HAVE ACHIEVED MULTIPLE MILESTONES INCLUDING THE FOLLOWING IN THE YEARS PRIOR TO HIS CHAIRMANSHIP THE OFFICE OF THE OF PUBLIC ACCOUNTABILITY ISSUED A SCATHING REPORT ABOUT HOW COMMUNITY QUALIFYING CERTIFICATE COMMUNITY CONTRIBUTION MONEY WAS ALLOCATED TOWARDS NOTHING BUT AGENCY TRAVEL AND SPECIAL INTERESTS UNDER THE LEADERSHIP OF CHAIRMAN JOHN WE CREATED THE QC COMMUNITY CONTRIBUTION GRANT PROGRAM WHICH HAS SINCE PASSED OVER 1.8 MILLION DOLLARS TO OVER 87 NON-PROFITS AND AGENCIES FOR PROJECTS RELATED TO CULTURE SPORTS TOURISM EDUCATION ECONOMIC DEVELOPMENT AND EDUCATION DURING THE COVID-19 PANDEMIC CHAIRMAN JOHN FACILITATED THE MEETING OF INDUSTRY STAKEHOLDERS WITH THE GOVERNOR WHO ULTIMATELY DIRECTED OVER 130 MILLION IN DIRECT AID TO GUAM SMALL BUSINESSES HIS LEADERSHIP INVOLVED OVERSEEING THE CREATION AND PASSAGE OF SOPS AND GETTING AID TO THE COMMUNITY IN A TIMELY MANNER WITHIN THE RESOURCE CONSTRAINTS OF THE AGENCY AND IN COMPLIANCE WITH FEDERAL AND LOCAL LAW THE GOVERNOR CALLED ON GEDA TO ASSIST PUBLIC HEALTH WHICH THE CHILD CARE INDUSTRY WERE MILLIONS OF DOLLARS WERE AT STAKE TO BE LOST UNDER CHAIRMAN JOHNS LEADERSHIP WE QUADRUPLED THE ENROLLMENT IN THE CHILD CARE BLOCK GRANT PROGRAM ISSUED MILLIONS TO MAKE DAYCARE SAFER FOR KIDS AND EXPANDED AFTER-SCHOOL OFFERINGS FOR GUAMS YOUTH POPULATION ADDITIONALLY EVERY VILLAGE MAYOR HAS BEEN RECENTLY APPROVED FOR UP TO SIX HUNDRED THOUSAND DOLLARS FOR YOUTH PROGRAMS THIS BOON TO THE CHILD CARE INDUSTRY IS NOW SHOWING THE FRUITS OF ITS LABOR AS PEOPLE ARE GETTING BACK TO WORK AND DAYCARES ALTHOUGH EXPANDED ARE CONTINUE TO HIT CAPACITY IT LOOKS LIKE WE WILL CONTINUE TO DO MORE WITH MORE WORK WITH PUBLIC HEALTH IN THE COMING YEARS AND THEN UNDER THE LEADERSHIP OF CHAIRMAN JOHN THE GEDA TEAM HAS FACILITATED OVER 100 MILLION DOLLARS IN BOND PAYMENT SAVINGS AND CASH FLOW SAVINGS AND THE UPGRADE OF THE GENERAL RATINGS OUTLOOK FROM NEGATIVE TO STABLE AND FOR THE FIRST TIME STABLE TO POSITIVE SINCE MOODY STARTED REVIEWING THE GUAM CREDIT IN 2017. UNDER THE LEADERSHIP OF CHAIRMAN JOHN GUAM WAS APPROVED 61 MILLION UNDER THE STATE SMALL BUSINESS CREDIT INITIATIVE OF WHICH THE FIRST TRANCHE OF 17 MILLION ARRIVED LOCALLY IN THIS FISCAL YEAR FOR OUR LENDING AND VENTURE CAPITAL PROGRAMS IN OUR REAL PROPERTY SPACE CHAIRMAN JOHN OVERSAW THE COLLECTION OF BACK RENTS FROM GUAM ANCESTRAL LANDS COMMISSION TENANTS WHICH DATED BACK TO PREVIOUS ADMINISTRATIONS AND AMOUNTED TO JUST UNDER 5 MILLION DOLLARS OWED TO THE LAND BANK TRUST ACCOUNT UNDER HIS LEADERSHIP GEDA WENT FROM DOING VERY LITTLE FOR SMALL BUSINESSES TO OFFERING PANDEMIC AID DISCUSSED PREVIOUSLY FORGING TIES WITH LOCAL INCUBATORS INCLUDING GUMA AND SUBSEQUENTLY PROVIDING SEED FUNDING TO LOCAL ENTREPRENEURS AND EXPORT AND EXPORT SUPPORT OF AROUND 1 MILLION DOLLARS TO OVER 15 NEW BUSINESSES LASTLY UNDER HIS LEADERSHIP WE HAVE A FEDERAL ACTIVE GRANT SEEKING ARM OF THE AGENCY WHO HAS ASSISTED IN SECURING MILLIONS IN JUST THE LAST TWO YEARS IN FEDERAL AID TOWARD ECONOMIC DEVELOPMENT INITIATIVES CHAIRMAN JOHN AND I HAVE A TERRIFIC WORKING RELATIONSHIP AND IN TIMES WHERE WE DO NOT AGREE I FIND THAT HE'S OPEN TO AN EXCHANGE TO A GREAT EXCHANGE OF IDEAS HE HOLDS THE AGENCY TO THE STANDARDS OF THE MANY CORPORATES HE HAS DEEP EXPERIENCE RUNNING OVER THE DECADES OF HIS DISTINGUISHED CAREER I APPRECIATE THAT AS I BELIEVE GEDA IS AN EXCELLENT TRAINING GROUND FOR BUSINESS PROFESSIONALS IN THE COMMUNITY INCLUDING MYSELF ON A PERSONAL NOTE I APPRECIATE THE FACT THAT CHAIRMAN JOHN IS A MAN OF FAITH AND HIS ACTIONS ON THE BOARD SPEAK TO HIS STANDARDS OF ETHICS FAIRNESS AND DOING WHAT IS RIGHT AS WE CONTINUE TO SERVE THE PEOPLE OF GUAM IT IS IMPERATIVE WE HAVE KNOWLEDGE EXPERTISE AND COMPASSION AT THE HELM OF THE AGENCY I URGE THE COMMITTEE TO HASTILY CONFIRM CHAIRMAN JOHN FOR ANOTHER TERM AT THE GUAM ECONOMIC DEVELOPMENT AUTHORITY AND I'M OF COURSE AVAILABLE FOR QUESTIONS AS WELL. SI YU'OS MA'ASE.

CHAIRMAN QUINATA: THANK YOU MISS MENDIOLA AT THIS TIME I'LL GO AHEAD AND YIELD TO SENATOR TELO IF SHE HAS ANY QUESTIONS

SENATOR TAITAGUE: THANK YOU MR CHAIR AND GOOD AFTERNOON GOOD AFTERNOON TO EVERYONE WHOS HERE WITH REGARDS TO YOUR POSITION THIS WILL BE YOUR YOU SAID FOURTH TERM HOW MUCH HOW MANY TERMS ARE THERE I MEAN HOW MANY YEARS ARE THERE IN A TERM

**DAVID JOHN: FOUR YEAH.** 

SENATOR TAITAGUE: SO FOUR OKAY SO BASICALLY THIS WILL BE YOUR FOURTH TERM IF YOU SHOULD **OKAY** 

**DAVID JOHN: YES CORRECT** 

SENATOR TAITAGUE: SO BASICALLY SITTING BEEN SITTING HERE IN THIS POSITION FOR TWELVE YEARS

**DAVID JOHN NOT AS CHAIRMAN BUT ITS BOARD YEAH BUT** 

**SENATOR TAITAGUE: BEEN** ON THE BOARD FOR TWELVE YEARS

DAVID JOHN: THAT WAS EIGHT YEARS YES UNDER THE CALVO ADMINISTRATION I SERVED CHAIRMAN FOR THE LAST ONE OR TWO MONTHS OF.

SENATOR TAITAGUE: AND IN THAT TIME HAVE YOU EVER RECUSED YOURSELF FOR A CONFLICT OF INTEREST?

DAVID JOHN: I DON'T SIT ON ANYTHING THAT HAS TO DO WITH FINANCES WITH ON THE LIKE OUR OWN INVESTMENT FINANCES OR BANKING BECAUSE MY RELATIONSHIP WITH THE BANK OF GUAM BESIDES THAT I CANT REMEMBER IF I DID BUT I DON'T THINK SO OTHER THAN THAT I STAY COMPLETELY OUT OF THAT VICE CHAIRMAN JUNE ESPALDON HANDLES ALL THAT.

SENATOR TAITAGUE BUT THERE IS STILL VOTING REQUIRED RIGHT ON THE BOARD WHENEVER APPROVING THINGS LIKE LOANS GRANTS THINGS LIKE THAT.

DAVID JOHN: YEAH I MEAN I CANT REMEMBER I CANT THINK OF ANY TIME THAT I ACTUALLY RECUSE MYSELF FROM ANY VOTE AS CHAIRMAN I DON'T VOTE BUT PRIOR TO THAT I DON'T I CANT REMEMBER IF ANY.

SENATOR TAITAGUE: SO YOU YOU DON'T YOU'VE NEVER RECUSED YOURSELF.

**DAVID JOHN: I DON'T THINK SO.** 

SENATOR TAITAGUE: I MEAN AGAIN THERE MIGHT BE A CONFLICT OF INTEREST BECAUSE OF YOUR POSITION WITH THE BANK IT COULD BE.

DAVID JOHN: THAT'S WHY I'VE STAYED AWAY FROM IT IT HAS TO DO WITH THE BUT.

SENATOR TAITAGUE: LIKE I SAID EARLIER YOU STILL VOTE AS A BOARD I MEAN ON NO ITS ALL BROKEN UP IN DIFFERENT CATEGORIES AND.

DAVID JOHN: NO I I'M A CHAIRMAN SO AS CHAIRMAN I WOULD ONLY VOTE IF THERE'S A TIE BREAK SO I DON'T IT COULD COME UP BUT I AND I CERTAINLY WOULD I WONT GO ANYWHERE NEAR ANYTHING WHERE I THINK THERE'S A CONFLICT OF INTEREST FROM A VOTE ON A BOARD FOR A FOR A COMMUNITY BOARD I HAVE OTHER THINGS TO FRY IN LIFE YEAH I JUST I ITS NOT THAT'S NOT SOMETHING I WOULD DO.

SENATOR TAITAGUE: WELL YOU KNOW TWELVE YEARS IS A LONG TIME HOW DO YOU FEEL ABOUT LIMITED TERMS FOR BOARD MEMBERS FOR GEDA.

DAVID JOHN: I THINK I'M STRETCHING IT YEAH IF YOU KNOW I THINK THIS WOULD BE MY LAST GO-ROUND ITS BEEN TWO DIFFERENT ADMINISTRATIONS AS FAR AS THINGS GO AND COVID WAS KIND OF LIKE A TIMEOUT FROM EVERYTHING ALSO I DON'T THINK WE GOT A LOT WE DIDN'T DO A LOT OF THE THINGS WE WOULD LIKE TO HAVE DONE YOU KNOW WE WERE IN YOU KNOW IN NECK HIGH IN HEALTH THINGS IN IN IN PANDEMIC GRANTS AND SO WE DIDN'T DO A LOT OF THE THINGS THAT I KIND OF THINK THAT'S KIND OF A TIME OUT BUT YEAH I I CANT IMAGINE COMING HERE A FIFTH TIME I THINK THAT THIS PASSES OFF THE REIGNS TO SOMEBODY ELSE.

SENATOR TAITAGUE: SO YOU DON'T YOU HAVE NO OBJECTIONS TO NONE AT ALL.

DAVID JOHN: LIMITED TERMS I THINK I LIKE THAT ON BOARDS BECAUSE SOMETIMES YOU GET TO A SITUATION WHERE YOU DON'T WANT TO ASK SOMEBODY TO STEP OFF KIND OF CREATES AN AWKWARD MOMENT SO HAVING TIME RESTRAINTS I THINK I THINK FOR EVERYTHING I THINK FOR I THINK LEGISLATIVELY I THINK THAT SHOULD BE FOR SENATORS I THINK IT SHOULD BE FOR BOARD MEMBERS NOT JUST PUBLIC.

SENATOR TAITAGUE: BUT WELL WITH SENATORS ITS A LITTLE BIT DIFFERENT THE PUBLIC VOTES YEAH I DON'T KNOW I'M LIKE BORED THEY'RE APPOINTED.

DAVID JOHN: YEAH BUT I THINK THAT THERE'S TIMES WHERE IT COULD KIND OF BE A NICE TURNOVER AND KIND OF KIND OF FORCING SEATS OFF I THINK ITS A GREAT IDEA I DON'T HAVE NO ISSUE WITH IT.

SENATOR TAITAGUE: OKAY WELL DON'T GET ME WRONG YOU KNOW I APPRECIATE THAT YOU WANTED ME TIME TO GIVE BACK TO THE COMMUNITY.

DAVID JOHN: I DID I DID RETHINK IT IN LIKE TWELVE YEARS BUT THEN I THOUGHT COVERED WE DIDN'T GET A LOT DONE I'LL GIVE IT YOU KNOW I WOULD LIKE TO DO IT ONE MORE TIME BUT I GET THAT YEAH

SENATOR TAITAGUE: OKAY WELL I'M GLAD TO HEAR THAT YOU DO BELIEVE IN LIMITED TERMS YOU KNOW FOR BOARD IT PROVIDES A DIFFERENT PERSPECTIVE AND DIFFERENT EYES AND DIFFERENT IDEAS COMING TO THE TABLE WHICH IS DEFINITELY NEEDED SO I APPRECIATE YOUR CAN YOU KNOW YOUR HONESTY THAT IT SHOULD BE LIMITED YEAH AND OF COURSE APPRECIATE THE TIME THAT YOU DID SERVE THE TWELVE YEARS THAT YOU WERE ON THE BOARD THE OTHER QUESTION I HAD WAS REGARDING CITIZEN-CENTRIC REPORT DO YOU GET INVOLVED DOES THE BOARD GET INVOLVED WITH THE CITIZEN-CENTRIC REPORT AT ALL.

MELANIE MENDIOLA: NO SENATOR FOR THE MOST PART THAT IS AN INTERNALLY CREATED DOCUMENT THAT IS INFORMED BY THE PRIMARILY BY THE AUDIT AND DESIGNED A GRAPHIC.

THE GRAPHIC ARTS WE DO IT EITHER IN-HOUSE OR WE HAVE A MARKETING COMPANY PUT TOGETHER THE GRAPHICS AND THEN ITS POSTED BY LAW ON OUR WEBSITE AND WE TURN IT IN AS WELL TO THE I THINK ITS THE ORGANIZATION THAT HANDLES THE ACCOUNTING THE I'M SORRY THE NAME SLIPS MY MIND BUT THE ASSOCIATION OF GOVERNMENT ACCOUNTANTS ASSOCIATION OF GOVERNMENT ACCOUNTABILITY WE TURN THAT ONE INTO THEM AS WELL AS THE OPA THE BOARD SEES IT THEY CAN THEY PROVIDE COMMENTS BUT BECAUSE THE WE CONSIDER THE CCR TO BE THE GREAT THE BOARD DOES HAVE TO ACTUALLY LET ME TAKE A STEP BACK SENATOR THE BOARD WHEN THE AUDIT IS COMPLETE THE ANNUAL AUDIT THAT IS REPORTED TO THE BOARD AND THE BOARD IS GIVEN A CHANCE TO REVIEW AND ACCEPT THE AUDIT NOW EXCERPTS OF THAT AUDIT IS TAKEN AND PUT ON THE CCRS HIGHLIGHTS HIGHLIGHTS GREATEST HITS AND THINGS ALONG THOSE LINES SO WHILE THAT IS PROVIDED TO THE BOARD ITS NOT REQUIRED THAT THE BOARD VOTES ON IT OR ADOPTS THE CCR.

SENATOR TAITAGUE: OKAY MR. JOHN CAN YOU REQUEST FOR THE THE MANAGEMENT TO AUDIT CERTAIN PROGRAMS LIKE FOR INSTANCE YOU TALKED A LOT ABOUT HOW THE ELITE PROGRAM WAS ONE OF THE LOANS THAT WERE PUT OUT AND STUFF CAN YOU REQUEST AS A BOARD MEMBER I MEAN YOU'RE THE CHAIRMAN OF THE BOARD CAN YOU REQUEST TO DO AN AUDIT ESPECIALLY FOR THE LEAP PROGRAM.

DAVID JOHN: CERTAINLY AND I THINK WITH ALL THE PROGRAMS THAT ARE FEDERAL MONEY ARE AUDITED JUST BY THE PROCESS RIGHT YEAH SO I MEAN CERTAINLY THE LEAP HAS TO BE AUDITED THAT'S GOING TO BE A BIG ONE I MEAN.

**SENATOR TAITAGUE:** HAS IT BEEN AUDITED YET.

**DAVID JOHN:** ITS NOT CLOSED OUT YET SO.

MELANIE MENDIOLA: THERE ARE MULTIPLE STAGES TO THE AUDIT PROCESS SENATOR SO INCORPORATE IT INTO THE SOPS IS AN INTERNAL AUDIT THAT TAKES PLACE WITH OUR COMPLIANCE TEAM SAR COMPLIANCE TEAM SAMPLES SO LETS SAY FOR EXAMPLE THERE'S TWO THOUSAND RECIPIENTS THEN THE INTERNAL TEAM WILL LOOK AT A SAMPLE OF TWO HUNDRED AND THEN THEY WILL PREPARE A REPORT TO A COMPLIANCE REPORT WHICH THEY THEN PRESENT TO THE BOARD THAT HAS OCCURRED FOR ALL OF THE PROGRAMS WITH THE EXCEPTION OF THE LEAP PROGRAM BECAUSE THAT IS THE ONE THAT CAN THAT IS CONTINUOUS THAT'S THE ONE THAT'S BEING UPDATED CONTINUOUS RIGHT NOW ACTIVELY UPDATED THE OFFICE OF PUBLIC ACCOUNTABILITY HAS AUDITED OUR INITIAL PROGRAMS THE SMALL BUSINESS PANDEMIC ASSISTANCE GRANT 2020 AS WELL AS OUR ONE OF OUR SMALLER PROGRAMS WHICH WAS THE RENT ASSISTANCE GRANT AND PROVIDED THAT PUBLIC REPORT THAT REPORT PUBLICLY AND THEN WE DO ALSO FALL IN UNDER THE FEDERAL COMPLIANCE TYPE REPORTS AND SO THE GOVERNMENTS SINGLE AUDIT OR THE GOVERNMENTS CONSOLIDATED AUDIT AS WELL AS GEDAS AUDIT COVERS THE GRANT EXPENDITURES ALTHOUGH THE CHECKS ARENT CUT OUT OF GEDA THE CHECKS ARE CUT OUT OF DOA SO THERE'S SOME OVERLAP WITH WHATS COVERED COMPLIANCE WISE A GEDA AND WHATS COVERED AT DOA AND THEN FOR TO ADDRESS YOUR QUESTION SPECIFICALLY IS THE BOARD ABLE TO MAKE REQUESTS OF AUDIT SURE ITS YOU KNOW THERE ARE DIFFERENT THINGS THAT YOU COULD LOOK AT LIKE A LIKE A PERFORMANCE AUDIT LIKE THEY COULD SAY WAS THE TIMELINESS WHAT WAS THE AVERAGE TIMELINESS OR SERVICE IF THEY IF THEY RECEIVE SERVICE REPORTS IF SOMEONE CALLED ONE OF THEM AND SAID I HAVE A CONCERN ABOUT HOW THAT MY ACCOUNT WAS HANDLED ABORT ANY BOARD MEMBER CERTAINLY HAS THE HAS CAN REQUEST THAT OF US WITHOUT ANY ISSUES.

SENATOR TAITAGUE: THANK YOU THANK YOU MEL MR JOHN HAVE YOU REQUESTED TO YOU KNOW SEE SOME OF THE DOCUMENTS ON AS THE AUDIT ISNT COMPLETE YET BUT YOU KNOW AS THEY MOVE FORWARD TO ITS COMPLETION HAVE YOU ASKED TO LIKE KEEP TABS ON YOU KNOW MAKING SURE THAT

FIRST COME FIRST SERVE IS APPLIED AND THAT NOBODYS JUMPING AHEAD OF THE LINE TO GET ANY GRANTS OR LOANS ARE YOU FOLLOWING THROUGH WITH THAT.

DAVID JOHN: YEAH NO I'VE NOT ASKED FOR ANY AUDIT OF THAT OR ANY OF THE LIKE LISTING OF WHOS GOING IN WHAT ORDER NO.

**SENATOR TAITAGUE:** I THINK YOU SHOULD.

DAVID JOHN: WELL YOU KNOW IF YOU'D WORK WITH THIS TEAM YOU'D REALIZE IS IT REALLY IS A WERE HELPING WITH THE POLICY SIDE OF IT SOMETIMES WE GET IN INTO THE INTO THE WEEDS I GOT INTO THE WEEDS A LOT DURING THE COVID CRISIS MORE JUST TRYING TO HELP SET UP SOPS AND SUCH BUT ONCE THE SOPS ARE IN PLACE I'VE JUST NEVER HAD ANY EXPERIENCE WHERE I KNOW WHEN I TURNED THE REINS OVER TO THE TO THE TEAM THAT IT WASN'T GOING TO GET FOLLOWED THROUGH I SO HELP SET UP THE GUIDANCE OF THINGS AND THEY'VE DELIGHTED I MEAN THEY'VE EXCEEDED EXPECTATIONS ALMOST EVERY TIME OUT OF THE GATE SO I YOU KNOW I'VE NEVER HAD AN AUDIT COME BACK THAT I'VE SEEN SOMETHING THAT MADE ME CONCERNED SO GOING FORWARD I WOULD HAVE DEEPER EYES ON SOMETHING SO FROM THAT PERSPECTIVE ITS JUST NOT BEEN A BIG PART OF WHAT I DO AND YOU KNOW THAT WOULD BE MY ANSWER TO THAT ONE SORRY.

SENATOR TAITAGUE: WELL AS THE CHAIRMAN OF THE BOARD I THINK YOU SHOULD YOU KNOW PUT YOUR NOSE INTO EVERYTHING THAT GOES ON IN I MEAN.

DAVID JOHN: WE LOOKED THROUGH THE PROCESS RIGHT AND WE'VE RECEIVED THE NUMBER.

SENATOR TAITAGUE: REGARDLESS OF THEIR SOPS I MEAN YOU NEED TO FOLLOW THROUGH YOU DON'T WANT TO WAIT UNTIL A MISTAKE HAPPENS OR SOMETHING FALLS THROUGH THE WEEDS AND THEN LATER ON YOU'RE KICKING YOURSELF BECAUSE YOU DIDN'T YOU KNOW LOOK AT IT BEFOREHAND OR FOUND A MISTAKE THAT NEEDED TO BE CORRECTED BEFORE IT GOES SOMETHING YOU KNOW EVEN FURTHER SO I YOU KNOW THAT'S THE INVOLVEMENT I THINK OF THE BOARD YOU KNOW JUST DO YOU ALSO DO YOU DO A WHAT IS THAT AN ASSESSMENT OF THE GENERAL MANAGER THE GENERAL MANAGER IS.

DAVID JOHN: YES WE DO AN ANNUAL REVIEW DEFINITELY SHE'S I MEAN SHE'S UNDER OUR PREVIEWS FOR HIRING ENVIRONMENT WE WILL NOT FIRE HER.

**SENATOR TAITAGUE**: OKAY AND HOW MANY TIMES ONCE A YEAR.

DAVID JOHN: IT'S JUST A BETTER PROCESS IT GETS BACK TO WHAT MEL AND HER TEAM HAVE DONE WE SET UP SOPS VERY STRONG SOPS AND WE EXPECT DELIVERY OF THEM AND THE BOARD EXPECTS THAT WHAT WE'VE PUT IN PLACE WITH THEM ARE BEING FOLLOWED AND WE'VE NEVER I CAN'T I MEAN I'M SURE THERE'S SITUATIONS EVERYONE MAKES MISTAKES EVERYONE DROPS THE BALL NOW AND THEN BUT I REALLY CAN'T SIT HERE AND THINK ABOUT IT IN A SITUATION WHERE A PROCESS WASN'T FOLLOWED MISTAKES ARE MADE PEOPLE YOU KNOW THEY MAKE A BAD DECISION I MAKE BAD DECISIONS LIKE WE ALL DO ALONG THE WAY BUT THE PROCESSES ARE FOLLOWED I THINK TO THE T I MEAN IT'S JUST SUCH IT'S A GREAT TEAM TO WORK WITH ITS BELIEVING I KNOW YOU'VE DONE IT.

SENATOR TAITAGUE: I WORKED AT GEDA AND THERE ARE A BUNCH OF HARD-WORKING INDIVIDUALS AND VERY INTELLIGENT YOU KNOW I'VE WORKED AT TINA TINAS BEEN AMAZING AND I STILL CALL HER TO THIS DAY IF I HAVE ANY QUESTIONS YOU KNOW AND OF COURSE AS I'VE WORKED WITH MEL AND SHE'S BEEN AMAZING SOME OF THE COMMENTS THAT SHE MADE I HAVE LEGISLATION THAT'S GOING ON SESSION NEXT WEEK YOU KNOW TO ASSIST GEDA AND PUTTING THINGS IN ORDER AND I THINK YOU KNOW THAT'S ONE OF THE THINGS I I LIKE MOSTLY ESPECIALLY ABOUT MEL IS THAT YOU KNOW YOU'RE PUTTING THEM IN THE SPACE THEY NEED TO GO IT'S EASY TO FIND OUT WHETHER THERE IS A MESS UP

BECAUSE IT'S ALL EASILY CATEGORIZED YOU KNOW AND CLEANING UP CLEANING HOUSE SO YOU KNOW I ALWAYS OFFER MYSELF TO ASSIST GEDA WHEN MOVING FORWARD SO MY LAST QUESTION MR CHAIR I WON'T BELIEVE WERE THIS WHY DO YOU WANT TO STILL SIT ON THE BOARD MR. JOHN.

DAVID JOHN: I'D LIKE TO FOLLOW THROUGH WITH WHAT WE HAD WHAT WE HAD STARTED WITH THE QUALIFYING CERTIFICATE PROGRAMS AND THE DIVERSIFICATION EFFORTS ARE THE BIG ONE I REALLY THINK THAT YOU KNOW AS A COMMUNITY YOU KNOW TOURISM AND IT HAS BEEN A IT'S BEEN A VERY GOOD INDUSTRY FOR US AND OF COURSE ALL THE FEDERAL SPENDING WITH THE THINGS THAT ARE GOING ON WITH CAMP BLAS AND EVERYTHING ELSE IS GREAT FOR THE ECON THE ECONOMIC SIDE OF THE ISLAND BUT COVID YOU KNOW WAS A WAKE-UP CALL TO US I THINK THAT WE NEED TO DIVERSIFY OUR ECONOMY AND TO GET INTO OTHER INDUSTRIES WITHIN THE CONSTRUCTS OF WHERE WE ARE AND WHO WE ARE AND A SKILL SETS OF OF OUR OF OUR POPULATION WHICH I THINK IS GREAT SO I REALLY WANT TO SEE MOVEMENTS IN THE 3D MANUFACTURING PROCESSES THE SHIPBUILDING THE TECHNOLOGY AREAS AND WHAT I REALLY LIKE ABOUT THIS SWEET SPOT I SAID IT IN MY COMMENTS IS THAT I DON'T THINK EVERY EVERYONE SHOULD GO TO COLLEGE I KNOW ITS BUT WE ALL NEED TO BE ADVANCING IN TRAINING AND THE MAJORITY OF THE JOBS OF WHAT WE'RE SHOOTING FOR ARE ARE ITS SKILLED LABOR ITS SKILLS THAT CAN BE DONE THROUGH COMMUNITY COLLEGE THAT CAN BE DONE THROUGH APPRENTICESHIP PROGRAMS AND THEY'RE GOOD PAIN THIS IS WHAT WE'RE SHOOTING FOR SOLID PAYING JOBS THAT CAN SUPPORT A FAMILY AND I WOULD REALLY LIKE TO HELP LEAVE THAT AS IS I MY MARK ON THE WAY OUT THAT WE'VE THAT WE'VE THAT SOME SUCCESS IN OUR DIVERSIFICATION OF THE ECONOMY SPECIFICALLY IN THOSE AREAS IN AQUACULTURE AND AGRICULTURE ALSO RIGHT ALONG WITH THAT BUT I THINK THERE'S SOME REALLY GOOD OPPORTUNITIES OUT THERE RIGHT NOW STARING US DOWN AND I'D LIKE TO BE A PART OF THAT.

SENATOR TAITAGUE: WELL THANK YOU SO MUCH FOR ANSWERING MY QUESTIONS AND I GREATLY APPRECIATE YOU WANTING TO STEP UP TO THE PLATE AND YOU KNOW I THINK GVB IS GOING TO BE MAKING SOME PHONE CALLS TO YOU GUYS ON THE SETUP OF YOUR AGENCY BECAUSE THEY'RE HAVING SOME ISSUES WITH THEIR BYLAWS AND THEIR ENABLING LEGISLATION AND I THINK THEY WANT TO TRY AND MIRROR IT AFTER GEDAS SETUP SO THAT.

DAVID JOHN: I JUST GOT CAUGHT AT LUNCH I WAS ON THE WAY OUT THE DOOR TO COME DOWN HERE AND SOMEONE ASKED ME CAN YOU SEND ME YOUR BYLAWS I SAID YEAH I'LL SEND THEM DOWN SO THEY ALREADY DID.

SENATOR TAITAGUE: YEAH GREAT YEP THAT'S EXACTLY WHATS GOING TO HAPPEN SO AGAIN I APPRECIATE YOUR TIME AND OF COURSE YOUR GREAT STAFF THAT HAVE HAD THE OPPORTUNITY TO WORK WITH ITS ALWAYS GOOD TO SEE THEM AGAIN THANK YOU SO MUCH.

**DAVID JOHN: THANKS SENATOR.** 

CHAIRMAN QUINATA: IT WAS A PLEASURE MEETING YOU YESTERDAY.

**DAVID JOHN: NICE TO SEE YOU AGAIN.** 

CHAIRMAN QUINATA: SO YOU KNOW IT IS MY UNDERSTANDING YOU DO HAVE MILLIONS OF DOLLARS AND I THINK THAT WERE VERY BLESSED FOR ALL YOUR EXPERTISE YOU DO YOU DEAL WITH MILLIONS OF DOLLARS PRIVATELY AND IN THE GOVERNMENT AGENCIES AND YOU GUYS WERE EXECUTING NUMEROUS GRANTS AND OPPORTUNITIES FOR THE PEOPLE YOU GUYS HAVE BEEN ABLE TO STAND UP PROGRAMS IN A HEARTBEAT AND FOR THAT I DON'T THINK THERE'S REALLY ANY FURTHER QUESTIONS FOR YOU DIRECTOR DO YOU HAVE IS THERE ANY CONCERNS THAT I SHOULD ANY ISSUES I SHOULD BE CONCERNED OVER MR JOHN.

MELANIE MENDIOLA: NO SIR NOT IN HIS CAPACITY AS THE CHAIRMAN OF GEDA THERE MIGHT BE ISSUES JUST IN GENERAL BUT NO I'M JOKING NO ITS BEEN A ITS BEEN A PLEASURE TO WORK WITH ITS BEEN A PLEASURE TO WORK WITH CHAIRMAN JOHN OVER THE LAST I THINK I SPEAK FOR THE ENTIRE TEAM HE CHALLENGES US WITHOUT HE CHALLENGES US WITHOUT MICROMANAGING US AND HE STEWARDS THE THE SHIP VERY VERY EFFECTIVELY AND I THINK THAT ITS ONE OF THE REASONS WHEN YOU SAID WHEN SENATOR TAITAGUE ASKED WHY DO YOU WANT TO SERVE AND I I ALMOST THE DEFAULT ANSWER FOR ME WAS BECAUSE I CALLED HIM AND I SAID COME ON SIR YOU'RE GONNA WHAT DO YOU MEAN YOU'RE NOT GONNA WHAT ARE WE GONNA DO WHAT ARE WE GOING TO DO YOU KNOW SO I THINK THERE'S THERE'S A THERE'S A LEVEL OF COMFORT AND A LEVEL OF WHEN YOU HAVE CONSISTENCY IN MANAGEMENT AND I ONE HUNDRED PERCENT AGREE WITH SENATOR TAITAGUE THAT FOR THE MOST PART A LOT OF TIMES YOU NEED NEW BLOOD AND THAT'S WHY A LOT OF TIMES TERM LIMITS ARE IMPORTANT BUT TO NOTE WHEN WHEN THERE'S A BOARD THE CHAIRMAN SETS THE TONE OF LEADERSHIP THAT'S FOLLOWED BY THE MEMBERS OF THE BOARD AND HE'S REALLY ONLY BEEN THE CHAIR FOR FOUR OUT OF THE LAST TWELVE YEARS AND I THINK WHAT YOU'VE SEEN IS UNDER HIS LEADERSHIP THERE'S BEEN TRANSFORMATION OF THE AGENCY VERSUS PARTICIPATION AND INPUT AND A LOT OF TIMES THE FIRST TERM OF A OF A BOARD MEMBER ESPECIALLY IF ITS THEIR FIRST TIME SERVING ON A GOVERNMENT BOARD I THINK WE'VE ALL OBSERVED THIS ITS LEARNING AND NOT TRYING TO MAKE TOO MANY WAVES AND SO I THINK THAT A LEADERSHIP POSITION SUCH AS A GOOD CHAIRMAN IS HARD TO A GOOD CHAIRMAN OR CHAIRWOMAN IS HARD TO COME BY AND SO I CERTAINLY APPRECIATE THE VOLUNTEERISM THE SPIRIT OF VOLUNTEERISM THAT HE HAS TO CONTINUE TO SERVE AT THE CAPACITY THAT HE'S SERVING.
