The public hearing was Called-to-Order at 5:25 p.m.

Chairwoman Amanda L. Shelton:

Buenas and Hafa Adai. The Committee on Maritime and Air Transportation, Parks, Tourism, Higher Education, and the Advancement of Women, Youth, and Senior Citizens is back from recess. The time now is 5:25 pm. We are continuing with our confirmation hearing and we are now on agenda item C, the appointment of Yolanda M. Padrones to serve as a Member of the Guam Community College, Board of Trustees. The mission of the Guam Community College is to be a leader in career and technical workforce development, providing the highest quality student-centered education and job training in Micronesia. The college engages with the community in order to be able to provide programs and services that can best meet the needs of the community and the workforce, now and in the future. The Board of Trustees adopts policies and regulations necessary to operate the college. Board members appoint and evaluate the president of the college, evaluate and make recommendations for executive and legislative action to improve programs, and much more. It is the vision of the Guam Community College to be the premier educational institution for providing globally recognized educational and workforce development programs.

At this time, I'd like to welcome our Guam Community College Board of Trustees Chair Mr. Frank Arriola, Board of Trustees member Rose Grino, and Mrs. Tudella Vice President of the Guam Community College. Can you tell us your first name for the record?

Gina, thank you very much. And I like to first start with Mr. Arriola. Please state your name before you begin with the testimony.

Frank Arriola:

Frank Arriola. Chairman of the Board of Trustees. GCC.

Chairwoman Amanda L. Shelton:

Si Yu'os Ma'ase, Chair Arriola. Mrs. Grino.

Rose Grino:

Good afternoon, Madam Chairperson and the members of the 37th Guam Legislature.

[written testimony present orally]

Madame chair, I also want to read the testimony of our Vice Chairperson if you will allow me?

Chairwoman Amanda L. Shelton:

Yes, please proceed.

Rose Grino:

Okay.

[written testimony presented orally]

Chairwoman Amanda L. Shelton:

Thank you very much, Mrs. Grino and Mr. Leon Guerrero for your testimony, as well as Chairman Arriola. Dr. Tudella.

Gina Tudella:

Hafa Adai Madam Chairperson and Honorable Senators, my name is Gina Tudella and I'm the Vice President for Academic Affairs at Guam Community College. Unfortunately, our President Dr. Mary Okada is not able to be here this afternoon but she requested that I represent her and read her testimony to the Legislature.

Chairwoman Amanda L. Shelton:

Thank you very much, Dr. Okada and Dr. Tudella for that testimony. I will now hear from the nominee, Ms. Padrones.

Yolanda M. Padrones:

[written testimony presented orally]

Chairwoman Amanda L. Shelton:

If there's anyone else who wishes to testify for the airport okay we'll begin with questions from the Senators who are here. Vice chair.

Vice Chairman Jesse A. Lujan:

Thank you very much, Madam Chair. Thank you panel. Thank you Ms. Padrones for wanting to step up in public service. You're currently with the Triple J right? Triple J and also an adjunct professor at the University of Guam. What do you teach?

Yolanda M. Padrones:

Human Resources.

Vice Chairman Jesse A. Lujan:

Human Resources.

Yolanda M. Padrones:

Employment law specifically.

Vice Chairman Jesse A. Lujan:

Why did I ask right? Yeah, what are your goals? What do you see for your goals? For with the GCC?

Yolanda M. Padrones:

I want to be able to lend my expertise and also I have a unique perspective in being the SHRM president to be able to hear the concerns of our membership, to be able to add value in the the goal of GCC's Board of Trustees is to evaluate their their curriculum to be able to make recommendations for programs. And so my goal is to be able to add value to that.

Vice Chairman Jesse A. Lujan:

You know your president is up for another position. I think she's one of the finalists. Were the presidency of University of Guam and I don't know how the board meets and things like that in regards to how to respond to the situation when if she's picked as the next president of let's go say United States. I'm jumping ahead here right yeah anybody but joke right anyway. But if she expected to be the next University President, what are your thoughts? Who would it be the interim and because I know the board alongside of course President Okada have done a tremendous job with GCC. And I've always said that in regards to the needs of the community GCC responds at a faster rate too what is needed up there. And most especially you know we got this military build up, you guys have these boot camps that you put on and we talked about you know of course the need for I.T. is again underutilized here in Guam. And the need to enhance that again

our to need to promote that even more. So our folks who you know our kids be able to get into in these fields that is under served under utilized here in Guam right. So again how prepared is the board again to tackle that situation should your president be picked for the next University of Guam President? I mean I know it's in good hands but still you know you still have your leader that might be the next president. I'm sorry to put you in that position but you might be facing that.

Yolanda M. Padrones:

As the newest potential member of the board it is always on the back as part of the strategy is succession planning. So I can't speak on behalf of the board but I do recognize that there is a process by which people submit their submissions and then we will evaluate it based on you know their merits.

Frank Arriola:

Yeah, I've been on the board 14 years and Dr. Okada has been on working for GCC before then so I haven't gone through a president search. But there is a formal process in that and Dr. Okada's been very good about communicating you know her future. She's ready for retirement and then she has her other opportunities like you had mentioned. We're very excited to have Yolanda. On top of that, we have accreditation also coming up so we're going to need a full board again ask you guys for your support.

Vice Chairman Jesse A. Lujan:

So again in in your expertise did you bring into the board what again in regards to your thinking and method in moving forward. What would be something different that you would add to the board that maybe it's not there? I mean you have a board's running great but there's always another direction and always another way to do things, to be able to enhance it even more. And so in your thinking what could you contribute to enhance that opportunity there and maybe not necessarily take it a different direction but enhance that direction and take it to a better place now that it's not in a good place right now?

Yolanda M. Padrones:

That's a great question. You know because of COVID so much has changed. The employment landscape, recruitment strategies have changed so much. So if I could offer anything to the board, it's my experience in testing different recruitment strategies, looking at different interviewing techniques to be able to incorporate behavioral interviewing, situational interviewing techniques to better gauge whether or not a candidate is fit for the role. So in short, I think just my experience in human resources can lend itself to

selecting a candidate based on you know just the newer maybe recruitment strategies and interviewing process.

Vice Chairman Jesse A. Lujan :

You know I think it was last week or the week before we had the Department of Corrections here and the reason why I put this up because one of the one of the programs that they had prior to COVID was for the inmates that qualified to be able to go to either at GCC or UOG but because of COVID they weren't able to attend or continue to attend. And I knew that I mean they did not have the infrastructure. Of course they're not allowed to take computers back to their cells and things of that nature but how would you again work to maybe enhance that program because you know we asked them whether they're a jail or a correctional facility and they said of course both a jail and a correctional facility. I don't want to lose that part of the correctional facility in regards to you know better bettering the inmates who may be looking at getting out soon. And how do they change their lives to be productive? And I hate to be able to I mean not have the infrastructure in place and I know a lot of this would definitely be on the shoulders of DOC but what would you recommend again to be able to work closely with institutions like DOC and maybe well I don't know if you guys work with DYA as well but to make sure that programs are not lost most especially again folks who are maybe getting ready to transition out to come back out into the community? And I hate to have them again lose that because COVID did not do that and they weren't allowed. I mean yeah most people want were online for schools but they weren't able to do that. So I don't know if they're ever completed their education regarding that. So what do you recommend? What do you foresee in that?

Yolanda M. Padrones:

I think as a whole we've had to, as a community, we've had to adjust right? To the challenges that COVID presented if we're not able to allow inmates to have a tablet for whatever reason, I think maybe pivoting to being able to do it virtually if that's even possible. I don't know fully the infrastructure of the Department of Corrections facility but that would be one thing that comes to mind. We could always go back to you know materials and having them do independent study is another. I don't know how successful that will be but like everything else, we've had to test different methods to see whether or not I mean even the online training has not really proven to be very successful. So a lot of it is you know we are testing and seeing whether or not it is successful and then we have to just adjust after that.

Vice Chairman Jesse A. Lujan:

I look forward to voting in your nomination of course. I need to ask my questions but anyway I look forward to that and again you're entering a great institution. Great great folks again sometimes you know of course you want to see people rise to to even better positions and you know or selfish reasons sometimes you want to say hey why do you have to go you know that but anyway but congratulations to your nominations and but it seems like you're ready to do the job right?

Yolanda M. Padrones:

Thank you Senator Lujan.

Vice Chairman Jesse A. Lujan:

Yeah well thank you very much Madam.

Chairwoman Amanda L. Shelton:

Thank you Vice chair. Senator Quinata.

Senator Roy A.B. Quinata:

Congratulations on your appointment Ms. Yolanda. Does your family support you taking up this membership?

Yolanda M. Padrones:

My son is off in the military so I'm an empty nester. I have a new lease on life and I enjoy contributing to the community from which I've gained so much from. So it's a passion of mine. So I have the full support of those around me, including my employer.

Senator roy A.B. Quinata:

I'm very thankful for your appointment here. I think it's very fitting for you to be stepping up to this position. Like my colleague said earlier I'm almost certain that there will be a new presidency needed for GCC down to the top three and I think she's gonna be the president of choice. So I think you guys will be having a huge search for yourselves. I think she's done a huge impact on the college. So I'm hoping she can do a huge impact also for the University. I really don't have any questions for you. I see that you have an extensive background in Human Resources. You've had a phenomenal career so I'm sure you're going to be putting a lot of that information to work and you're going to be helping the college figure out whatever it needs to figure out and I think you should be confirmed so you have my my support and confidence. I wish you all the best. Thank you again for your public service.

Yolanda M. Padrones:

Thank you senator.

Chairwoman Amanda L. Shelton:

Thank you Senator Quinata. Senator Fisher.

Senator Thomas J. Fisher:

Thank you madam chair. Good afternoon ma'am. I don't have any questions either for you. I'm looking at the package that was given to us. You are a very impressive individual and you're going to begin service at a very impressive institution. I wish you the best and if you need anything please come to us. Thank you.

Yolanda M. Padrones:

Thank you.

Chairwoman Amanda L. Shelton:

Thank you Senator Fisher. Senator Taitague.

Senator Telo T. Taitague:

Si Yu'us Ma'ase, Hi Yolanda. First I want to apologize for the long wait. It's obvious you know this was scheduled wrong but you know had to leave you guys here all night almost but I appreciate you waiting it out and especially those who are here to testify. You know my apologies for that. Yolanda, first I want to say *Biba* Notre Dame right on? When I saw that yay my son went to Notre Dame he's one of the first when it opened up to the boys so *biba*. Yeah and the second one is how many times does the board meet Yolanda a month?

Yolanda M. Padrones:

The GCC board?

Frank Arriola:

Yes it's once a month.

Senator Telo T. Taitague:

Okay so it tells me that you had to look to find out. So how much do you know about this board then? It meets once a month which you just found out. Have you had the opportunity to read any of the board minutes?

Yolanda M. Padrones:

So, I have done my research on its mission and understanding how I can contribute to the board. So yes I've read into GCC's mission and the Board of Trustees and what their role is.

Senator Telo T. Taitague:

Okay what about the board minutes?

Yolanda M. Padrones:

I have not read their board minutes, no.

Senator Telo T. Taitague:

So you don't know what they're doing currently right now?

Yolanda M. Padrones:

I understand their initiatives in terms of work workforce programs.

Senator Telo T. Taitague:

Okay, so I recommend that you know before you get started. The confirmation might take another couple weeks. It gives you enough time to catch up and see what those board minutes or we're talking about or what was said on that okay to get you ready. Because your resume looks good. This first time ever serving on a government of Guam board?

Yolanda M. Padrones:

Yes.

Senator Telo T. Taitague:

Okay you do realize that you'll have to take an Ethics Course?

Yolanda M. Padrones:

Sure.

Senator Telo T. Taitague:

Okay and you do realize that any funds or anything that you have everything must be transparent?

Yolanda M. Padrones:

As a former banker, I can attest to being very comfortable with that.

Senator Telo T. Taitague:

That's very good to hear, very good to hear I mean you saw what happened earlier so you don't want to get into that kind of shenanigans. You know other than that again thank you so much for wanting to step up and serve. This is your first time in government board so please my door is always

open if you have any questions or if I can be of assistance to you. Please don't be afraid to call on me.

Yolanda M. Padrones:

Thank you very much.

Senator Telo T. Taitague:

Thank you.

Chairwoman Amanda L. Shelton:

Thank you. Senator Brown.

Senator Joanne M. Brown:

Certainly welcome and I know it's been a long afternoon probably far longer than you anticipated but this should be fairly easy. I'm also a fellow Notre Dame grad just a few years before you started in '86. That's just several years ahead of you before I graduated but I certainly welcome your contribution. We enjoy having people outside of government come in because otherwise things get a little too incestuous you know. I think it's important to have members of the community that different awareness different insight particularly from the private sector to come in and certainly can improve on how we operate. And even though we all know the Guam Community College has had quite an impressive history to get it collectively of where it is today and certainly for all you that have contributed it's much appreciated. Impressed with your background and also you know just sitting as SHRM president. With regards to human resources I mean that's such a critical resource in any organization be it the private sector in the government or you can't move things without your people. How do you feel that background will help maybe improve or contribute to the Guam Community College with you serving on the board?

Yolanda M. Padrones:

I think as part of the main things that we do is to evaluate the vocational training and so my experience with the SHRM as well as human resources I've actually even benefited from one of the boot camps with Triple J and so I fully support it. I think it's so necessary. We're having extreme issues with recruiting on the island and so I'm a proponent that if you can't find them and it's very difficult then you grow them yourselves. And so I think that the GCC you know hits the nail on the head by being able to work with employers to understand what their needs are and to come and answer that call. I've sat and we were part of the first Diesel Mechanic Training or boot camp that is. And so you know that process made me feel very very

comforted to know that the GCC spends enough time with employers to really get a better understanding of what their needs are and supports us fully. So I believe that my experience in Human Resources having been a benefactor of the program I have my ear on the ground with my experience with SHRM and we can you know just essentially prepare. Like we can make recommendations that's part of what we do to, be able to also improve the the student experience. So I think there are many factors that I can add value to as with respect to my experience and how I can add value to the board well.

Senator Joanne M. Brown:

I appreciate your response and I think that's really critical is the connection. I mean you have people out there that need the jobs and being able to provide them maybe they don't have the training in that area but they can go to GCC and get that training and be able to connect to our you know employment opportunities that are really relevant and in demand. And I think that's important. I think it's important to have in order to have a healthy community we have to have a working community. And you know the amount of people that we have that are not working that should and could have had you know could have the opportunity to do that. I mean there's such a large number so I certainly appreciate your your stepping up to the plate. I am very impressed as well with your presentation and your credentials. And I certainly wish you well in your appointment to the GCC board. We certainly look forward to hearing good things ahead. Thank you very much and thank you for stepping up to the plate. T

Yolanda M. Padrones:

Thank you senator.

Chairwoman Amanda L. Shelton:

Thank you Senator Brown. Senator Blas.

Senator Frank Blas Jr:

Thank you madam chair and Miss Padrones and to the rest of the GCC family, thank you very much for being here. It's taken aback. I was doing some research and taking it back, you have a son in the military. Are you old enough to have a son in the military? Thank you very much for you for your son and for trusting that he's off on that. I tell you I'm very impressed just sitting here and just listening and how you were able to present yourself and being and what your ideas. I've got an affinity. I've got you know a little bit with with GCC. I used to adjunct to GCC as well okay? And I got most of my professional training from GCC okay. So I knew what it could do 40 years

ago. Unfortunately I'm gonna have to say it that way. 40 years ago. Don't laugh Ray don't laugh because you were there. Okay 40 years ago and then and today to see where it continues to go you know and you're right. I think you bring a perspective that I don't want to say is going to improve. I think it's going to enhance and build on already you know the the brainchild and the dream and what the the knowledge and that they have on the board you know. When you do unfortunately when you do you guys are the unfortunate victims of being the comparison with you know another post-secondary facility and okay. When you kind of outshine them in many places it's a good thing on you. And Ms. Padrones as I see your nomination and I see your inclusion in this with your expertise to be a very welcome addition to to this board which is why you have no problems in getting my affirmative vote in this thing. Thank you. First are you sure you want to do this? Did you get glorious from that guy? Let's talk later and I'll give you a few reasons okay well how you can handle him and Carlo okay, okay. Aand Ms. Grino over there okay. So I'll be able to. But other than that no thank you very much. I like you know same sentiments as my other colleagues. Thank you for stepping up okay. We got a lot we got a lot of challenges before us. and she's gonna you know this community is gonna look a lot to GCC and what we're going to be able to to provide okay. I at least my fears are alaid and I know that with your expertise in there along with the expertise that already exist in this board that we're going to do much better. No just no matter who the president is okay. They're not that worry us. Just so long as he doesn't take any one of you with her to the next place if she goes over there okay. Dr. Tudella you got to make sure that. Okay okay so thank you very much.

Yolanda M. Padrones:

Thank you senator.

Chairwoman Amanda L. Shelton:

Thank you very much Senator Blas. Thank you to everyone who came to testify today for Ms. Padrones. To the GCC team, *si yu'os ma'ase*. Thank you very much Ms. Padrones for your willingness to serve, for stepping up to this position and for the Governor's appointment to this board. We look forward to moving your nomination quickly. Hopefully in this next session so you can join the board. You're going to have a lot of work ahead of you so we wish you the best of luck and with that. That concludes this nomination hearing for Yolanda Padrones for the GCC Board of Trustees. *Si yu'os ma'ase* everyone. We will take a one-minute recess.

III. FINDINGS AND RECOMMENDATIONS
