Thank you for the invitation to provide testimony on Daniel Taitingfong's appointment to the Guam EPA Board of Directors. Unfortunately, I am unable to get out of work commitments that are scheduled during the hearing.

Therefore, I have prepared a few brief remarks.

First I would like to say that the board currently has four (4) directors out of the nine (9) prescribed in the law. The Assistant Attorney General – Legal Counsel to Guam EPA – has noted that we do not have enough members to conduct meetings. We did not have a meeting this month because of this. Among other topics, agenda items would have included discussion on issues with Guam's laws and regulations regarding Septic Systems; funding requests to GSWA and DPW for clean up programs throughout the island; and review of the Agency's Zero Waste Master Plan. It is imperative that the board have the 5 directors required to conduct business.

Therefore, I am pleased to see that we have a new potential Director up for consideration. Upon reviewing his packet, I have noticed that Mr. Taitingfong is a former member of the Army, was a real estate agent, is a current private business owner, and is on the Yona MPC. I view these experiences as assets that will complement our current board. Mr. Taitingfong's past work experience and current occupation as a business owner in the water sector should positively influence our discussions.

The Guam EPA board is a diverse one -- we have an engineer, an attorney, a teacher, a media talk show host, and government and non-profit directors. Mr. Taitingfong would be a welcomed addition. Much of the board's discussions deal with our island's land, water, and existing government systems. Mr. Taitingfong's background indicates that he will provide new insights to our deliberations.

If confirmed, I look forward to working with him. His willingness to step up to proactively provide ideas, suggestions, questions, and solutions for Guam EPA to execute is commended.

Thank you for the invitation to provide testimony on Daniel Taitingfong's appointment to the Guam EPA Board of Directors. Unfortunately, I am unable to get out of work commitments that are scheduled during the hearing. Therefore, I have prepared a few brief remarks.

First I would like to say that the board currently has four (4) directors out of the nine (9) prescribed in the law. The Assistant Attorney General – Legal Counsel to Guam EPA – has noted that we do not have enough members to conduct meetings. We did not have a meeting this month because of this. Among other topics, agenda items would have included discussion on issues with Guam's laws and regulations regarding Septic Systems; funding requests to GSWA and DPW for clean up programs throughout the island; and review of the Agency's Zero Waste Master Plan. It is imperative that the board have the 5 directors required to conduct business.

Therefore, I am pleased to see that we have a new potential Director up for consideration. Upon reviewing his packet, I have noticed that Mr. Taitingfong is a former member of the Army, was a real estate agent, is a current private business owner, and is on the Yona MPC. I view these experiences as assets that will complement our current board. Mr. Taitingfong's past work experience and current occupation as a business owner in the water sector should positively influence our discussions.

The Guam EPA board is a diverse one -- we have an engineer, an attorney, a teacher, a media talk show host, and government and non-profit directors. Mr. Taitingfong would be a welcomed addition. Much of the board's discussions deal with our island's land, water, and existing government systems. Mr. Taitingfong's background indicates that he will provide new insights to our deliberations.

If confirmed, I look forward to working with him. His willingness to step up to proactively provide ideas, suggestions, questions, and solutions for Guam EPA to execute is commended.

- (3) Senators will be given an opportunity at the end of each panel to ask questions, (but due to the potential high volume of those testifying I respectfully ask that questions be concise to facilitate the participation of the public).
- (4) Questions and testimony shall be confined to the substance or nature of the agenda. The personal inference as to the character or the motive of any Senator, or any individual testifying, is NOT permitted.

So now to begin our agenda. We are hearing testimony on the Executive Appointment of Mr. Daniel A. Taitingfong to serve as a Member on the Guam Environmental Protection Agency Board of Directors.

A brief overview of the Guam Protection Agency. The board of Directors consist of nine members appointed by the governor with the consent of *I Liheslatura*. Members serve a term of three years each. Some responsibilities include the following:

- The Board is responsible for appointing the Administrator who administers the matters of the agency, under the supervision of the Board.
- The Board appoints the Deputy Administrator, who is not a member of the Board and does not have the right to vote. The Deputy shall perform the functions as the Administrator desires during the absence of him or her.
- The Board shall serve as an appellate body so that any citizen of the community who believes he or she has been aggrieved by an action or decision of the Administrator of Guam EPA can request a hearing before the Board of Directors.
- The Board will also hear notices of violations, any kind of infractions or enforcement actions by any entity.

Notices of today's confirmation hearing were sent to the Chairman of the Board. We have received testimony by the Chairman himself, as well as, Mr. Brian Bamba. At this time, I'd like to call upon anyone who wants to provide testimony, including the nominee himself. If you can please come forward and please state your name. We're going to move from my left, this far end, and we'll move down. and save the nominee for last. Sir, you're recognized. Please state your name.

Mark Mendiola, *Community member*: Hi. Good morning. *Håfa adai*. Mark Mendiola, citizen of Guam. I love our island. I think the Environmental Protection Agency plays a vital role in ensuring that our environment is safe and clean for our future generations. *Håfa adai*. Good morning, Chair, Senator Perez, Senator Lujan, Senator Duenas, Senator Nicolas and Senator Quinata. I think I saw two Senators last night. We did a marathon session last night on GDOE Special Education for like 5 hours. Yeah, we stayed.

So anyways, I'm very grateful for the opportunity to be here this morning to testify in support of the appointment of Mr. Daniel Taitingfong. I know him as Professor Dan. He's actually my jiujitsu instructor. I've known him for over 10 years, both professionally and personally, and the professional capacity. I know that this young entrepreneur served our nation. He's a veteran, and he's come back to Guam, planted his roots here. His family's from Yoña. I know that he's very capable of providing the guidance necessary to meet the mission of Guam EPA, particularly. In terms of appointments, oftentimes we come to these confirmation hearings, but I love to see when we have fresh faces, fresh ideas, and fresh people that come with a different perspective. And Mr. Taitingfong here has traveled. He's seen a global perspective, and, I think, he's going to be able to bring that to the table. Not only as a businessman here on Guam and I just think its very important you guys are charged and tasked with vetting people that are appointed to the Board and understanding that role. They basically act as fiduciary agents, but also as keepers at the gate to ensure that the agencies complying with the policies and the rules and regulations.

I know Mr. Taitingfong to be very, *gi fino' CHamoru, menhalom*. He's got good wisdom and his ability to ask questions. I think this is the nature of what we do professionally. If you don't know, ask, and, you know, build from there and get the information that's a part of you. I've sat on boards and commissions, and I always try to make decisions based on what's presented in front of me and the best interests of what I believe to be true. And I've witnessed Mr. Taitingfong in these arenas, both in the private and the public sector. So, I stand here today in support of his candidacy. I know he will serve our island well, and he will look out for our environment. *Un dånkolo na si Yu'os ma'åse'*.

Chairperson Perez: Si Yu'os ma'åse', Mr. Mendiola. Next, we have Mayor Quenga. Thank you.

Mayor Bill Quenga, *Yoña Municipality*: Good morning, Senators. How are you guys doing this morning? I'm glad to be here to testify on behalf Mr. Daniel Taitingfong. To make it short and sweet and to the point, Mr. Daniel Taitingfong is an MPC member under Yoña Mayor's office, under me, and he's a very humble man. And he you know he's, like I said, it's part of my MPC and his biases and his leadership towards his guidance towards our village has been very helpful. I'm pretty sure with him being on board the EPA Board, he will do a great job too. So, that's what I'm here for, to let you know that he's a very humble man and he works hard too, as well. And like I said, about jiu-jitsu, he's been a great leader, too, to the kids in Yoña. And I'm pretty sure he'll do a great job again. Thank you.

Chairperson Perez: Thank you, Mayor Quenga, for your testimony and for your participation today. I'd like to offer the floor to the nominee himself to provide his testimony.

Daniel Taitingfong, *Nominee: Buenas and Håfa adai,* Madam Chair, members of the 37th Guam Legislature. I'm humbled and honored to be sitting here in front of you all today to be considered as a member of the Board of Directors for the Guam EPA. Saina ma'åse' for this opportunity.

My name is Daniel Taitingfong. My wife Jaylene and I, who unfortunately, couldn't make it. She tried her best to be here, but we are the parents of five beautiful children, which is why she couldn't be here today. And we're from the beautiful village of Yoña. I understand our island is facing numerous environmental challenges, and it is my only hope that we can conquer these challenges and see the change happen now for the betterment of our island, her people and our future generations. My commitment will be in helping make the tough and necessary decisions for the good of our island and our people. My passion is sustainability, and I have made it my life's work to tirelessly promote sustainable choices, and be more conscientious about the dangers and harmful effects of single use plastics. I humbly ask for your consideration and full confidence in appointing me to the Guam Environmental Protection Agency Board. *Saina ma'åse*.

Chairperson Perez: Thank you so much Mr. Taitingfong. I'd like to open the floor to my colleagues. I'll reserve my questions for last. Senator Lujan. If you have any questions.

Senator Jesse A. Lujan, *Committee Member*: Thank you, Madam Chair. Good morning, gentlemen. Good morning, Mayor, Mr. Mendiola, Mr. Taitingfong. Good morning. I think we can recess now because Yoña rules. But thank you for your presence this morning. Mr. Taitingfong, again, congratulations on your nomination. I look forward to voting. I mean I know you, as well. So, but anyway let me ask you just a couple of questions, because actually our office has been entertaining this since day one regarding EPA. EPA seems to be a choke point for homeowners or home builders, developers, and things of that nature. What is your view on allowing holding tanks for businesses and the homeowners on the Groundwater Protection Zone where sewers not available, are very expensive to put in? I know right now that EPA is really looking at it. They've been inundated with the folks visiting them who can't build in properties that they bought. And again, the situation where sewer line is not available or really expensive to bring it in miles and all that. What is your stance on that? And not only that but the permitting process? Not just with that, but just permitting in in general where EPA has become a chokehold in a lot of sense?

Daniel Taitingfong: Thank you for that question. You know, Senator, to be honest. I never realized that not having access to main sewage and having a septic tank was an issue, because personally where I live too, we're not connected to the main water to the main sewage lines. So, it is something new to me. And like I said I never realized there was an issue, but you know I do plan to learn more about it. And to learn from the Board members and the agency themselves and figure out what we can do about it and what are the other alternatives and how we can make it work for the homeowners and the businesses. Because again, like I said, I never realized that was an issue. Yeah, definitely learn more about that and dive into it.

Senator Lujan: Yeah, well thank you very much for that, because it's an issue that GEPA is really working with, and I'm thinking that it's going to need legislation to make the changes and all that. Then we have to also balance it out when the need to protect the water lens and all that. Right? But likewise, growth and all that. Homeownership nowadays is almost unaffordable right at this point. People are buying properties and going to build. And then finding out that they really can't get the

permit, because they're around an area where they have to bring miles and miles of water or sewer line. Yeah. And you know I mean almost on a daily basis we get calls from folks from the CHamoru Land Trust with the same situation as well. So, thank you very much for that. But also, outside of that as well I mean, we have our paperwork is stuck at EPA. Can we just push it along? And it's not because there's something wrong with it, it's just looking at it and getting an expedited process to be able to get things done. I myself, or I think it was last year and wasn't at EPA, it was at agriculture where my paperwork sat for three weeks, and they just needed a signature because all the reporting and all the inspections were done. It just needed the signature. And I couldn't take my permit with me because at any moment they were going to sign it, and if I would have taken it, I could have had the other agency sign off on it and then I'll bring it back. But it's, "Sir, no because at any moment it's going to be signed...". Three weeks, right? Three weeks. So, you know, we just need... the one stop process is really not a one stop process. It's a frustrating bula stop process. But anyway, I'm excited we have a new thinker now he'd be able to do that and willing to learn and a businessman at that. So, you know the balance between the government bureaucracy and the need to get economic prosperity going and likewise definitely protecting the environment as well, alongside that, the whole balance. But thank you very much. I look forward to your voting in your nomination. Thank you.

Daniel Taitingfong: Si Yu'os ma'åse', Senator.

Senator Lujan: Thank you.

Chairperson Perez: Thank you, Senator Lujan. Senator Dueñas, you are recognized.

Senator Chris M. Duenas, *Legislative Member: Si Yu'os ma'åse'* Madam Chair and Mr. Taitingfong. Thank you for being before us today. Mayor Quenga. Thank you. And of course, the one and only, our good friend. You got good backers here. So, I think the biggest thing that that's jumps out to me is your honorable service in the Armed Forces and, to me, I know that any employer and I'm sure you as an employer now, that always ranks really high when you're looking at an individual and what they'll bring to the organization. So, I think that that integrity first and foremost is what already puts me in a favorable situation to honor the request of the Governor and thank you for stepping up and being willing to serve. I think the other thing that my good colleague mentioned here is that you know your businessman, and so I believe that you're going to bring that balanced perspective to understanding what's required to move EPA along. I was hoping the Director would be here because obviously to make quorum for the Board your nomination has been needed for a long time. So, I'm glad that you're here and we'll do what we can to expedite this going forward. I'm not going to ask you a bunch of questions, because as you mentioned earlier you really are going to go into this and accept the responsibility of learning and getting on board.

But I want to put something on your plate, because I want to present to the Board once again. I'll be reintroducing a bill that Senator Tony Ada and myself worked on in the last term and that is to deal with junk cars. We've had this, this bounce back and forth between EPA, Public Works, GPD citations, and the other issues. I just wanted to get your thoughts really quick to see at least if you agree with the premise of the bill that we introduced. And that is to basically, after a certain amount of time, say 72 hours, consider a junk vehicle just trash. And I know that EPA has, and they've written some of the legal points that they want us to fix in the bill and I am fixing those. But I just

wanted to get your main concurrence, whether you think that's logical to say, if you're not responsible enough to remove your junk vehicle from the side of the road after 72 hours, would you consider that as garbage as well as many of us do?

Daniel Taitingfong: Yes. *Si Yu'os ma'åse'* for that, Senator. Coming into the Board I don't know what the rules and regs are, but on a personal stand point I agree with you. It's an eyesore. We see so many of it. We see it in our villages, we see it, in our heading home into our personal streets, whatever. And it is an eyesore, and I totally agree with you. And something needs to be done about it, because it seems like it's getting worse, even on the main roads, people just leave their vehicles there. And personally, in a specific village across the street from where my kids go to a daycare at Catholic school. It just got cleaned up. And I've seen that there for maybe two years. But it was a great thing. The mayor coordinated for that specific village to clean it up. But I definitely agree with you. It needs to be, something needs to be done.

Senator Duenas: Yeah. And I agree with your sensitivity too. When we're talking about maybe on the inner villages, we're going to have to work on that a little bit more.People are going to have to make a determination when they're working on it, and they're done working on it. It's got to go. But my really main thing is on the main thorough fares, the routed roads and the like. It's dangerous first and foremost. And secondly, we see a lot of issues associated with that, where it's an abandoned vehicle. And then it becomes an abandoned vehicle with no tires. Then it becomes an abandoned vehicle with no hood and no doors.

And let's be honest with ourselves. If a responsible individual really cared about that vehicle, they're going to get that darn thing off the road within 24 hours. So I just wanted to make sure that as we present this bill, again, I know that the Director will filter this thing through the Board as well, and legal will make the recommendations. We're going to clean it up, like I said, but I just wanted to make sure you were on Board with something as straightforward as that because I think it, we really got to clean up our island and we really got to get those junk cars predominantly off the roadsides.

And we want to redo that again. We want to be able to say, after 72 hours, this is no longer a junk vehicle, this is trash and we're going to remove it. I've got a good feeling now. I had a good feeling going in, but I, if you can jump on board with the passion on that issue you certainly and like I said, your honorable service and as a businessman, I think everything looks to be a really good fit. And I thank the Governor once again for giving your nomination coming forward and look forward to voting in the affirmative on your confirmation. Thank you, Madam Chair.

Daniel Taitingfong: Si Yu'os Ma'åse, Senator.

Chairperson Perez: Thank you, Senator Duenas. I'd like to recognize the Administrator, Walter Leon Guerrero. If you don't mind coming to the table and any words, if you'd like to present at this time?

Walter Leon Guerrero, *Administrator, Guam EPA*: I thank you, Senators. I have to admit, I do not know Mr. Taitingfong. And I actually think that's a good thing. I welcome, first off. Senator,

Duenas. I was outside and I did hear I didn't want to put Mr. Taitingfong in a bad position by saying I didn't know him, but again I think it's a good thing. I welcome people.

First off, I want to acknowledge, we are short on Directors. So that we do need people. And so I welcome anybody onto the Board. I also wanted to make sure, again, to restate, I don't know him, but I welcome him because I welcome anybody's thoughts. It's open-mindedness that is what's going to get us forward, moving forward supplying solutions, because sometimes we get stuck.

I do want to say, and I'm sorry, I know this is about you, sir. But the abandoned vehicles that we have a problem with. I do want to note that we spent over \$5 million in the last four years to get abandoned vehicles removed from the streets of Guam. And I know that there's some white goods and some other things in it, but it's a community problem that needs to be addressed by the community. We can do only so much with the money. And \$5 million is a huge sum to be allocated towards removing junk vehicles. And I'll get off the soapbox cause again this is about appointing Mr. Taitingfong. But I just want to remind people there has been a large amount of funding spent to remove vehicles and for some reason we can't keep up.

Thank you, sir. I support Mr. Taitingfong even though I don't know him. Sorry I just butchered his name. To be a part of the Board, because we need a Board of Directors, and I look forward to working with him and hearing him about his initiatives that he would like to push forward in Guam EPA. Thank you.

Chairperson Perez: Thank you, Administrator Leon Guerrero. We do have a round table coming up. So, let's just table that discussion. It's next week, Thursday. Thank you.

Senator Duenas: Madam Chair. If you give me just one discretion not on the abandoned vehicles. I just want to put it on the record. Walter, have you brought to the attention of the Governor how critical this is in terms of needing nominees? Do you have any other nominees prospective coming down? We really shouldn't be down to the last guy and having the Board situation that it's in right now.

Administrator Leon Guerrero: Yes, Senator. It's been brought, in fact, we just had a meeting two days ago, and she's asking me to come up with people that would want to be on the Board.

Again, I'm going to try. But my hesitation is the Board is who actually confirms the Administrator and also approves my performance evaluation. So I don't want it to be looked at that I'm building a Board that supports me. And to be honest, I know it, I'm in, in a rock in a hard place kind of thing. I need to find Board members, but I don't wanna find Board members that people will say he's just filling a board for himself. I don't want to do that, sir. But the Governor knows the urgency, and she knows that there's 11 spots available. When I said we need Board members, she herself, Madame Governor said, I know you have 11. We're working on it. And if you could provide more names, please do. And this is a cry out to the public. If you're interested in being on the Guam E.P.A. Board, call me up, and we can submit your name to try to get you on the Board. Yes, she does know. I do want you to know, she brought it up too. After I brought it up, she took it over and said, we know exactly what needs to be done. Thank you, Senator.

Senator Duenas: Yeah. Walt that shouldn't be your responsibility. Your responsibility should let them know what's going on. That's at the Chief of Staff level. That's at other levels. It's their job to get out there and solicit. I've been in that position before to where we had to make a lot of phone calls and find people who are willing to serve. So, I agree with it. I don't want, I don't want the burden to be on you. I just wanted to make sure that the notification has gone up. We have a serious situation. We need quorum. And you've done your job in that part. I know you don't want to have people favorable to yourself. I can understand that. But that's the front office job. So I just wanted to make sure you're on the record saying you've sounded the alarm. Thanks Walt.

Administrator Leon Guerrero: Yes, Senator. And again, on the record, they have responded that they understand, and they've been working on getting additional Board members. Thank you, Senator.

Chairperson Perez: Thank you, Senator Duenas. Senator San Nicolas.

Senator Dwayne San Nicolas, *Legislative Member*: Thank you, Madam Chair. Good morning, everyone. You got some good backers there, spoke on your behalf. The Mayor, Mr. Mendiola. I got you. I got your back. I got your back. Army Hua. You're familiar with the VA and the VA language sometimes. There's always that thing. There's a de novo review. I hope that when you do go in, you look at things with fresh eyes and you make your decisions. And I've gotten a lot of complaints about EPA regarding permitting and the lengthy process. I hope that you try to find a way to be more compassionate and more understanding, and hopefully we can move our island forward.

Although we need to do the job. But we can also make sure that we process this in a timely manner, not like how the VA did it's processes in 2009 or 2012. That, that. So I hope you do bring in fresh eyes and honesty and compassion to the people who actually have to go through the process. That's my only concern.

Other than that, I heard Jiujitsu, and you also do. You volunteer time for the kids. All you had to do was say that and you got my support. So, you do have my support and thank you gentlemen for your testimony this morning in support of our soldier there. Thank you, sir. Thank you for your service and your continued service beyond this point.

Daniel Taitingfong: Thank you so much.

Senator San Nicolas: Thank you, Madam chair.

Chairperson Perez: Thank you, Senators San Nicolas. I'd like to recognize Senator Joe S. San Agustin. Thank you, sir. I'd like to recognize Senator Quinata, if he has any questions for the nominee.

Senator Roy Quinata, *Legislative Member*: Good morning, Mr. Taitingfong. Congratulations. Is your family aware that you're being appointed to this Board?

Daniel Taitingfong: Yes.

Senator Quinata: Does your wife approve? Okay. I'm sure you'll be taking on a huge task on being a Board member. I just wanted to find out if you're aware that there was a roughly 10-acre property given to EPA to design ...for its headquarters facility in Dededo? Are you familiar where that is? I know you're from the south, but it's up north.

Daniel Taitingfong: I got to take a trip up there. But no. Like I said I'll learn it as I go. If granted the opportunity. And no, I'm not aware of the new facility.

Senator Quinata: Okay. To my understanding it's a quite huge cleanup operation. The Director has stated that it's grossly underfunded, and it needs to be cleaned up. It's a huge environmental mess. There were private companies once upon a time on that property. And I hope that you guys try to find some kind of a common ground to figure out how to get the headquarters moving forward so that we can ensure that the employees of EPA are housed in a better facility. Because I know your facility in Tiyan has been tried true. And already it's been tested and it's just DOE public schools. Their time has come, and I think it's, time to move forward. So, I'm hopeful that you maintain course with that new facility in the headquarters in Dededo so that we can get things more swiftly done and probably have a better operating system for EPA. Are you familiar with erosion control?

Daniel Taitingfong: Yes. Just briefly going over the different rules and regs under EPA. Yes. But yes. More to learn for sure. More to learn.

Senator Quinata: Okay. Because we've had companies recently really violate erosion sediment and contaminating water. The water over at Marbo Cave, although it's private property, it was once upon a time, a huge tourist site, also local site. But unfortunately, that water is contaminated, and I don't think that water will ever be up to par. How, for how many years it's been cleaned. Other than that, I don't see any real issues. I know my colleagues already in brought up the sewer issue. I do have interest with that. I know that there's a lot of properties that are over the water aquifer up North. Unfortunately, those in the South don't need to deal with that issue. You guys can have leaching fields. But on a development standpoint it's quite a huge task for you to try to find a sewer line. And I don't think that's the developer's fault. If they're a tycoon developer, then of course they can afford the initial blow of the cost. But I think we really need to find solutions and bridge the gap between the small homeowner groups and literally the small housing areas, because it's a very tough task to carry out. And bless you guys for taking on this endeavor.

On another note, I know that we do have some interest for tire recycling, and they also share the same situation. They need to find some kind of leaching, not leaching field, but they need to find some kind of storage tank that's feasible for you guys to advise on and accept for operation. And then also the junk car removal, a long-standing issue. So, I'm hopeful that you can help address those issues. Other than that, I'm sure Mr. Mark Mendiola and my prim over there, Bill Quenga has good insight on your work ethic. So, I don't think there's really any problems with your support today and bless you and have a great time. Let us know what we can do to help EPA and move your guys' agenda forward. Okay? Thank you.

Daniel Taitingfong: Thank you, Senator.

Chairperson Perez: Thank you, Senator Quinata. Senator San Agustin, if you have any questions for the nominee?

Senator Joe S. San Agustin *Committee Member*: For sure. I have a lot of questions for Mr. Taitingfong. But it is, it's really just comments. You're with my cousin here, and then you're with my two brothers from DLX. So, you're in good hands. I only ask and I thank you for accepting the nomination.

I look at your background. You're a former NCO in the United States Army ...ammo. You know what it takes where you're going to set ammo. So when you do whatever, you're going to do at EPA, you know what you need to do. And because of your background also in real estate. I know you're going to be friendly to the real estate industry. Correct. And when you do that, you end up being friendly to all. That's the beauty. I know they brought up many things about the ammunition. I mean the trash that's out there. I hope that as a Board member, you'll participate in their budget process. What they're going to be asking for and what they need their money for. Because when you come before me on the budget, you'll first go through your oversight. But by the time you get to me, I hope you have all your 'i's dotted and your 't's crossed. Because if you don't, I'll make sure I pick it out. There's no 'i's, there's no 't's. And that we come to terms of what you need and how we can get you to where you need to be. Okay? That's the main thing. When it was mentioned about the site you guys are moving up to Dededo, for me, that's self-inflicted. The site was determined by EPA. If you found out its trash, you should have checked it before you asked for it. You know how that works. It's like a real estate agent, before I attempt to sell a property, I make sure first it's sellable. Otherwise I should have went somewhere else.

But at the end of the day, I hope for the best for you, and I will support your nomination. You're among good people. Stay focused and you'll be okay. Your family's backing you. And you're from Yoña, nai. What do they say? Yona rules? Nah, don't let Yona rule you. You do what you need to do because you'll do fine. We're going to have fun. And we just take care of the people of Guam. Thank you, Madam Chair.

Daniel Taitingfong: Thank you, Senator.

Chairperson Perez: Thank you, Senator San Agustin. Thank you, Mr. Taitingfong for stepping up to the plate. As you know, we're in a critical situation where Guam EPA Board of Directors is

not meeting quorum. So, your presence at every meeting is critical, because there's a huge responsibility that the Board of Directors has, especially if there are violations that have to be dealt with. Are you confident that you'll be able to attend all the meetings on top of all the responsibilities that you have?

Daniel Taitingfong: Yes, Senator, I'll definitely make it.

Chairperson Perez: And the other thing that goes with that, obviously you're going to have steep learning curve. EPA has a lot of mandates. And so, you're going to be learning a lot on the job. In addition to attending the meetings, preparation is also critical to understand. You have resources, the Administrator, you have other directors who you can turn to, and my office, if you have any questions regarding any mandates.

I'm glad that my colleagues asked a lot of questions. I think they did a tour of the different mandates or the challenges that Guam EPA is doing. One of them that I would like to bring up is a plastic bag ban. You have talked about the issues of microplastics. I see still the plastic bag ban hasn't been quite fully implemented. Of course, you as a Board member may have to address any enforcement actions. What is your thought about the plastic bag ban?

Daniel Taitingfong: Thank you for that, Senator again. On a personal standpoint, I am completely against the plastic bag use. I don't know the rules and regs from the EPA but definitely, personally I am against it and if we can do something about it and we can push the issue and get these stores to cooperate. What do you call it? Fine or whatever we have to do. Then you know we'll push the issue, because I am personally against it.

Chairperson Perez: I want to point out is that we did pass a Zero Waste Bill and so that has opportunities for incentivizing the ban. Other issues I noticed you have a background in Hazmat. What do you think you can provide or what contributions can you provide to the Board in regards to your experience?

Daniel Taitingfong: So yeah hazmat. I mean just following proper protocol and again just learning what EPA's standpoint is and collectively working with, whether it be on the federal side, the GovGuam side, the private sector, just learning stuff and figuring out what we can do and being in compliance and stuff like that. So, I am excited to learn more about it and that way I can give my input and give my standpoint on certain things and just go from there.

Chairperson Perez: Thank you for that. And in regards to conflict of interest. I know you're a businessman. Your business is Flowater. How can you guard against conflict of interest, as a business person and then as a Board member?

Daniel Taitingfong: Right. So, it would be just to basically recuse myself from anything you know that puts me in that position. I basically just let the other Board members know, you know the Chairman, Administrator and I personally wouldn't want to be in those positions. So, it would just be easy just to recuse myself and go from there.

Chairperson Perez: Thank you for responding to these questions. And again, thank you for stepping up, and we look forward to your confirmation.

Daniel Taitingfong: Thank you, Senator.

Chairperson Perez: Thank you to everyone for being here. The Committee will continue to receive written testimony until 4:00 PM on Monday, April 17th, 2023. Please address all testimony to Senator Sabina Flores Perez, Chairperson on the Committee on Environment, Revenue and Taxation, Labor, Procurement, Statistics, Research and Planning.

III. FINDINGS AND RECOMMENDATION

The Committee on Environment, Revenue and Taxation, Labor, Procurement, and Statistics, Research, and Planning notes that per Mr. Daniel A. Taitingfong nomination packet, he will serve for a term of three (3) November 29, 2021, to November 28, 2024.

The Committee on Environment, and Revenue and Taxation, Labor, Procurement, and Statistics, Research, and Planning herby reports out the appointment of **Mr. Daniel A. Taitingfong** to serve as a **Member** of the **Guam Environmental Protection Agency, Board of Directors** with the recommendation <u>TO DO CONFIRM</u>.
