





Football stadiums belong in the suburbs

It is a truth universally acknowledged, that a new owner in possession of a football team, must be in want of a new stadium. Preferably, I might add - with apologies to Jane Austen - one that is publicly subsidized.

So it is hardly surprising that, with a new ownership group set to take over and despite the desperate need for a new quarterback, the NFL's Washington Commanders have hired lobbyists to enlist public support for their quest for a new home. The team used to play at RFK Stadium, about two miles east of the Capitol, and many fans would like them to return to the city after almost 30 years in suburban Landover, Maryland.

As a fan, I too would love to see them play in a first-rate stadium. As a wonk, however, I hope it's not in the city. Like most NFL teams, the Commanders belong in the suburbs. Football and suburbia are two great American passions that belong together.

Pro sports franchises fled American central cities during the great urban decline of the 1960s and 1970s, only to return more recently as many downtowns came back. In many ways that makes sense – if it can be done on financially reasonable terms. The case against public subsidies for sports teams has been around for

a long time, and it is strong, but my argument is more geographic. Let the suburbs have the stadiums. Cities need housing.

The case of the Commanders is complicated by the fact that 62-yearold RFK Stadium, which would need to be demolished, sits on land owned by the Department of the Interior. The team's lobbyists want the feds to give control of the site to the D.C. government, presumably so they can drag the city into a bidding war with Maryland and Virginia over which one will offer a better deal for a new stadium.

But football stadiums are different from other sports facilities in two ways that make them a poor match for urban areas. First, they are much larger, because the NFL is much more popular than its rival leagues. And second, they host many fewer games.

Washington's baseball stadium, opened in 2008, anchors an impressive urban revitalization project and hosts 81 regular season games per year. That generates meaningful amounts of foot traffic for local businesses, which in turn become attractive amenities for nearby residents. The stadium itself is large, but not nearly as large as an NFL stadium. And its parking needs are met by relatively compact garages.

An NFL team, by comparison, plays eight or nine regular-season home

games. This is just not enough use to be a meaningful benefit to nearby businesses. Meanwhile, an NFL stadium has a larger footprint and much more expansive parking needs, normally met – as at the RFK site – by vast surface lots that are friendly to tailgating.

The basketball and hockey seasons are shorter than the baseball season, of course. But basketball and hockey teams can share arenas in large cities, creating heavily used facilities nine months out of the year.

These problems could, of course, be ameliorated by having football teams share facilities with franchises in other sports. Combination football/baseball stadiums were once popular for this reason, and later so were football/ soccer stadiums. From a strict urban planning standpoint, this was ideal. But baseball and soccer teams and fans have discovered over the years that the compromises to the fan experience aren't worth it. And frequently used baseball stadiums and relatively compact soccer stadiums are both reasonable uses of urban land.

That leaves pro football an island, representing a peculiar combination of high demand and low frequency that is a highly inefficient use of urban space. Luckily, America has a place with vast acres of space just looking for a use: It's called the suburbs. As with any rule of thumb, there are exceptions: If your city's only major pro sports franchise is an NFL team – by my count there are only two – and lacks other major facilities, an NFL stadium could do double-duty as a concert venue or even a convention center. If your downtown is scarred by blight and vacant lots, a rarely used football stadium and a bunch of parking could be a step up.

But Washington, though not without its problems, is an expensive city with high demand for housing. And the RFK site is already far afield from the city's other sports venues. So the team might as well just move even farther from the center of the city.

Granted, the Commanders' existing stadium, though only 26 years old, is outdated and in need of replacement. But its location – close to the Beltway, an inconvenient-but-doable 20-minute walk from a Metro station, in the relatively inexpensive suburbs east of the city – is close to ideal.

As I said, I am a fan of the team. But I am also a resident of the city, and I'd like to see Washington put the RFK parcel to better use. Turning the derelict stadium and its associated parking lots into market-rate housing and retail, with maybe a neighborhood park or two, would generate jobs and tax revenue. It would help stabilize an urban economy that – like many others in the US, especially on the coasts – is reeling from the impact of remote work on commercial real-estate rents.

As they try to adapt to the new WFH world, cities are promoting themselves as hubs of recreation and consumption. It makes perfect sense. But professional football, despite its tremendous popularity, just doesn't belong in the middle of a city.

More disturbing news from the nation's report card

Those well-steeped in our nation's history long ago learned the inspiring story of how President George Washington delivered his stirring Gettysburg Address, a four-hour oration, in an effort to revive hope among Americans struggling during the Great Depression of the 1920s.

Or maybe not.

On Wednesday, the National Assessment of Educational Progress - the nation's "report card" - released the results of standardized tests given last year to eighth graders across the country on civics and history. Turn away if you seek to avoid depressing news.

Just 13% of students met proficiency standards in history, meaning "they could explain major themes, periods, events, people, ideas and turning points in the country's history," according to The Wall Street Journal. About 20% reached proficiency in civics.

In other words, only a small percentage of American kids poised to enter high school probably would be able to identify more than two errors in this essay's lead sentence, if they could identify any of the obvious mistakes at all.

The scores were the most miserable on record for a test that has been in existence for decades. In fact, students scored worse on these two subjects than in any other areas, including reading and math. "These data are a national concern," Peggy Carr, commissioner of the National Center for Education Statistics, told reporters. "The health of our democracy depends on informed and engaged citizens."

Various interests pointed fingers in an effort to place blame for this dismal development. The pandemic was an obvious culprit, and no doubt didn't help. James Grossman of the American Historical Society cited "the falling quality of history and civics lessons taught in American schools, which has been fueled by political acrimony," the Journal reported. Fair enough. But acrimonious battles over curricula involving politically controversial issues such as race are meaningless to kids when they lack the basic facts upon which to build a foundation that supports critical thinking and leads to the examination of more complex – and even contentious – subject matter. The great failure of this nation's public school system is that students aren't learning even elementary skills when it comes to reading and mathematics or even the simplest of facts in terms of history and civics.

The current push to ensure students are exposed to a more complete and robust view of this nation's history – warts and all – is wise and worthwhile. Yet it makes little sense if kids don't first develop a grasp of the fundamentals before moving on to more challenging subject matter.

I. OVERVIEW

The Committee on Environment, Revenue and Taxation, Labor, Procurement, and Statistics, Research, and Planning convened a public hearing on May 18, 2023, at 11:00 a.m. in the Guam Congress Building, Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Ms. Alexandria "Sandy" Gould Yow to serve as a Member of the Guam Real Estate Commission, of whose appointment is as follows:

- Appointed by Governor Lourdes A. Leon Guerrero on March 28, 2023, to serve from January 16, 2020 to January 15, 2024.
- Appointment packet was forwarded to I Liheslaturan Guåhan on April 13, 2023
- Appointment packet forwarded to this Committee for public consideration on April 17, 2023.

Public Notice Requirements

Public Hearing notices were disseminated via email to all Senators and all main media broadcasting outlets on May 11, 2023, and again on May 16, 2023, fulfilling the 5-Day Notice and 48-Hour Notice of the Open Government Law requirements respectively.

II. SUMMARY OF TESTIMONY AND DISCUSSION

The public hearing was Called-to-Order at 11:01 a.m.

Senator Sabina Flores Perez, *Chairperson*: Good morning, everyone. The Committee on Environment Revenue and Taxation, Labor, Procurement. Statistics, Research and Planning is calling this public hearing to order. The time is now 11:01 a.m. Thursday, May 18, 2023.

In compliance with Open Government Law, notices of today's hearing were published in the Guam Daily Post; provided via email, to Senators Stakeholders, and the local media and; posted to the Government of Guam Public Notices website on Thursday, May 11th, 2023 for the 5-Day notice and Tuesday, May 16th, 2023 for the 48-hour notice thus meeting the requirement.

The purpose of this hearing is to receive testimony on three nominees. The first one is the Executive Appointment of Ms. Alexandria "Sandy" Gould Yow to serve as a member of the Guam Real Estate Commission. The second item is the Executive Appointment of Mr. Jason W. Baza to serve as a member of the Guam Banking and Insurance Board. The last item is to hear testimony and Executive Re-Appointment of Mr. Steven R. Hollister just serve as a member of the Guam Environmental Protection Agency, Board of Directors.

The rules of conduct are: Those called to testify will be the order of those who called in advance prior to May 15th, followed by the order on the sign in sheet. We'll reserve the nominees for last, best for last. If you brought written testimony today, we ask that you provide it to our staff who can then make copies and circulate them. Those providing oral testimony will be first recognized by myself. Please begin by stating your name for record keeping purposes and if it applies, your organization. Senators will be given opportunity at the end of each panel to ask questions, and questions and testimony shall be confined to the substance or nature of the agenda. Personal inference as to the character or motive of anyone testifying is not permitted.

Now to begin our agenda to hear testimony for the Executive Appointment of Ms. Alexandria "Sandy" Gould Yow. To serve as a member of the Guam Real Estate Commission. Just some overview of the Guam Real Estate Commission. According to 21 GCA, Chapter 102, the Guam Real Estate Commission consists of seven members. Currently there are four members. That is appointed by *I Maga 'Hagan Guåhan*, and then confirmed by *Liheslaturan*. The Guam Real Estate Commission are to meet quarterly, but they may be called to a meeting upon the discretion of the chair. The functions of the Commission are to promulgate rules and regulations relating to the administration that must be consistent with the law and they can make recommendations for policy to the Commissioner that they may deem beneficial and proper for the welfare and progress of real estate licensees and of the public and of the real estate businesses on Guam. The Commission shall have full power to regulate and control the issuance and revocation of both temporary and permanent licenses that are issued under 21 GCA.

Notices were sent to Director Dafne Shimizu of DRT, as well as, Chairman Frank Pangelinan of the Real Estate Commission. As of today, we receive written testimony in full support of Ms. Sandy from the former Real Estate Commissioner Christopher Murphy, and the current Chairman Frank Pangelinan. At this time, I'd like to recognize those who are here to provide oral testimony. As of now, we have the first one signed up is Anthony Goodwin. *Bueñas*. Good morning, Mr. Goodwin.

Anthony Godwin, *Today's Reality: Buenas yan Håfa Adai!* Senator Sabina Flores Perez, Committee on Environment, Revenue and Taxation, Procurement, Statistics, Research and Planning. Boy, you have a job. A big job, and I thank you for that. We thank you for all this responsibility with you and your team up there. I'm writing to wholeheartedly recommend Alexandria "Sandy" Gould Yow. She has a lot of names. She has one more name, which is missing from here "Joan" in her official legal name.

Chairperson Perez: Thank you so much Anthony and thank you for taking the time to provide this wonderful testimony and testament to Sandy. Next, we have on our list is Duane.

Duane Pahl, *Today's Reality*: Good morning, Senator. Good morning, everybody. Very difficult to follow Anthony Goodwin's, written testimony, but it's so beautiful.

I'm here. First, I'd like to congratulate Sandy on her nomination. This committee will flourish and succeed with her as a participant and a leader and a voice in real estate.

I do not have any written, prepared testimony. Excuse me. I'm here to really speak from the heart.

Her and I have been working together very closely for the last six, seven years, although we've been in the same office for the last 20 years. That's at Today's Realty, and I am an associate broker at Today's Realty. A few words come to mind: integrity, experience, leadership, confidence, and strength.

Most of these qualities she has daily basis. Every single morning, every single evening, we communicate constantly, and she keeps me on my toes, and I think she'll keep the committee members on their toes as well. It's not an easy thing to do, and to be able to donate your time as a volunteer to help an industry that's so important on this island says a thousand words. So, I want to thank the Governor for nominating her for this position. Senator Perez, thank you for the opportunity to speak on her behalf. I think she will be an amazing asset. Thank you very much.

Chairperson Perez: Thank you so much, Duane, for the heartfelt testimony, and now we have the nominee herself. If she can provide her testimony.

Alexandria "Sandy" Gould Yow, *Nominee:* Thank you, Senator. I have been a licensed real estate professional and a member of the Guam Association of Realtors for 32 years. I have been a licensed broker for 24 years and have chaired or served on various committees of the Guam Association of Realtors and have been voted "Realtor of the Year" by my peers. Outside of being a realtor, I served six years on the UOG Board of Regents and as a member of Mercy Action Mariana's Limited. I continue to elevate my profession and serve in capacities that can help people understand the complexities of real estate.

As a Commission member, I would like to see final passage of a seller's disclosure form. When you purchase anything, let alone the most expensive thing you'll ever purchase, you deserve to know the conditions of your purchase. How old is the home? Has it experienced flooding? Is it in a flight path? Is the ground filled? Is the property on sewer, septic, or a holding tank? Every one of these items has been discovered by a buyer, after they have purchased property, and I'd like to help change that.

I also believe the requirements to become a broker, particularly a principal broker, need to be stiffened. Yes. Right now, with or without a four-year degree, you can obtain your broker's license by working as an agent for two years, then taking a 100-

question exam. This really is not enough. There are now 100 real estate offices and 600 realtors. We handle the sale of property for people who often have nothing more valuable than their real estate. I currently co-write and co-host videos and articles with associate broker Duane Paul. These run weekly in the Pacific Daily News website in an effort to share information that is helpful to the general public. This is education, and I hope to do more of this by providing more continuing education for our body through the Commission. Thank you.

Chairperson Perez: Thank you so much, Mrs. Yow, for your testimony and most importantly, for accepting the nomination. I know it's difficult to find the time for a lot of professionals that are very busy to take up service for the government. And judging from the testimony that's provided today, you are somebody who is ethical and who provides a standard for the industry. I see that you already have goals in mind and seller disclosure is one that is of interest to me. This is something that I've worked with the previous chairman and so we look forward to seeing that come to fruition under your participation as a board member.

At this time, the questions are, are you willing to commit to being at the meetings?

Alexandria "Sandy" Gould Yow, Nominee: Yes.

Chairperson Perez: I know they're quarterly, but there's a chance that there might be more. As far as conflicts of interest, do you have any conflicts of interest and how would you address those if they do exist?

Alexandria "Sandy" Gould Yow, Nominee: What would be a conflict of interest?

Chairperson Perez: : So, as a Commissioner member, you have the power to revoke licenses of real estate professionals. How would you determine whether there's a conflict of interest that exists in making that determination, for instance? That's one potential.

Alexandria "Sandy" Gould Yow, *Nominee*: Yes. In all the time I've been a real estate agent, I don't think I know of anybody who's had their real estate license revoked by the government. Are you? If that were to take place, that would be pretty amazing, because I do think that I have been witness to situations that would cause me some concern and wonder whether or not there was a method for having somebody's license to at least be questioned. So, it is something that needs further exploration, I believe.

Chairperson Perez: But as far as conflict of interest as a real estate?

Alexandria "Sandy" Gould Yow, Nominee: No, not at all.

Chairperson Perez: So, you're saying that you don't believe you have a conflict of interest?

Alexandria "Sandy" Gould Yow, Nominee: No.

Chairperson Perez: All right. Those are my questions to you, and I want to thank you for accepting the nomination and the only thing I could see is that it's a short term. It's not the full-term or three-year term normally. You're filling the position that the former chairman left, which is under three years. I appreciate your being here today and we'll look forward to your confirmation and not the upcoming session probably in June. Most likely in June.

Thank you so much. Just want to check to see if there's anyone else here to testify. At this point we are going to consider the confirmation hearing duly heard. The Committee will continue to receive written testimony until 4:00 p.m., May 19th.

Chairperson Perez adjourned the confirmation hearing for Alexandria "Sandy" Gould Yow at 11:17am.
