

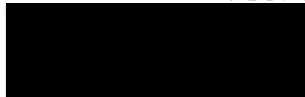

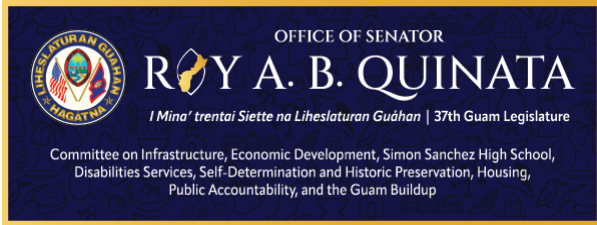

### II. SUMMARY OF TESTIMONY AND DISCUSSION

**The Public Hearing was Convened at 2:00 p.m.**

**(PLEASE SEE PROVIDED TESTIMONY FROM JESSE JOHN QUENGA, EXECUTIVE DIRECTOR, GUAM ETHICS COMMISSION)**

**Chairman Joe S. San Agustin:** Senator Taitague, do you have any questions for the appointee, the nominee?

**Senator Telo T. Taitague, Vice Chairperson:** Thank you, Mr. Chair, and good afternoon to you, and of course those who are here today to testify. And, uh, first let me thank you so much for wanting to continue to serve in this capacity. I know this is not a very easy commission, um, you know, looking over cases and then people finding out that you're on this board and you might get some phone calls that you really don't want at late hours at the night and so I hope, um, your four years that you've been serving, correct?

It's been four years currently or is it only two?

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** It's been two. I was appointed in 2021.

**Senator Telo T. Taitague, Vice Chairperson:** Okay. So this is going to be considered your second term. Okay. So in the laws of, of this commission, you could only serve two terms. So this will then, you know, have a serve. I'm a true believer in that. I believe that we, we need to allow other people to serve on boards and I've heard that people have been on boards for almost, you know, 20 years sometimes.

And, you know, there's, we, we lack the, you know, uh, new ideas, fresh eyes, you know, when something like that happens. That's why I like this board, the way it's set up. It is four years. It's quite extensive. It's almost eight years long. Um, but when we get people like you who want to sit on the board, who actually is the president, especially in human resources, you know, of, of yours, uh, I think as a society of human resources management, as a past president, people with your, uh, expertise and know how, you know, that it's music to my ears because then I know that you have the experience needed.

You know, in this capacity, in this very difficult commission capacity, you know, so, um, other than that, I just want to thank you again for serving the people of Guam, and, uh, my door is always open, if you have any concerns, and I'll be happy to address anything I can do to help you. Okay? Good luck to you.

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** Thank you, Senator Taitague.

**Senator Telo T. Taitague, Vice Chairperson:** Thank you.

**Chairman Joe S. San Agustin:** Ms. Leon Guerrero, you work for AK?

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** Yes.

**Chairman Joe S. San Agustin:** Anybody get a discount for a Toyota, or I'm just going to tease you.

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** Only if you're married to me.

**Chairman Joe S. San Agustin:** Okay. I just wanted to tease because I used to be a fan of AK until they were slow and giving me my deals, my bill anyway. But anyway, you know, thank you for accepting another round.

And may God bless you because everything you do at the Guam and these commissions, it's going to bleed over to AK. Or whatever you do in an AK, it bleeds into the government. It's got to be business friendly. And if it's wrong, it's wrong. If it's right, it's right. And I know you, you, that's how you're, you're viewing it.

And may God bless, uh, the folks that get reported. May they find some refuge somewhere else, other than messing around in the government of Guam. And they don't run to private industries. Hopefully when they get marked in GovGuam, maybe they leave. So we can be, clean up our island. But with that being, there's no other one to ask questions.

Yes ma'am. Yes Senator.

**Senator Telo T. Taitague, Vice Chairperson:** I'm sorry, I had one more other question. I apologize. Um, do you see anything that you need at the, uh, commission right now to, uh, make sure that, you know, you're, you're ensuring your T's are dotted and I's are, you know.

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** In terms of, uh, sorry.

**Senator Telo T. Taitague, Vice Chairperson:** Yeah, well, in terms of what can better, um, serve the, the commission, the ethics commission, what do you need additionally to..

You know, to get the job done, to ensure that there's fair, fair analysis of all those complaints that come in. Um, something like that, you know..

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** Definitely it's, it's supporting our request on the budget, especially right because..

**Senator Telo T. Taitague, Vice Chairperson:** I'm sure you're directly seeing over, I just saw him, you know budget, you know I wasn't a true fan of you know, giving additional money to create a whole new government agency with this commission. I've been one that's been very vocal about It. I don't want to create another civil service commission or another agency within the government. It's about downsizing our government, you know, right sizing it, not downsizing it, but right sizing it.

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** Yeah.

**Senator Telo T. Taitague, Vice Chairperson:** You know, so, but anyways, okay. The budget and anything else?

**Daphne M. Leon Guerrero, Member, Guam Ethics Commission:** To be able to support our initiatives, but also, uh, really, really support of, uh, what we're doing and maybe promoting more visibility of, of the accomplishments that the, uh, commission has.. You know, has achieved over the last couple of years, right? We were just, uh, redeployed or reactivated, um, basically a couple of years ago, and so I think we've made

tremendous strides. I think more visibility to the work, um, that we're doing would be really good, and that's what we're working toward this year.

**Senator Telo T. Taitague, Vice Chairperson:** Okay. Well, thank you. Fair enough. Thank you, Mr. Chair.

**Chairman Joe S. San Agustin:** Thank you, Senator Taitague. And just a reminder that, you know, Senator Taitague is my vice. We're in charge of the appropriation and all that stuff. So when you talk about money, you watch the movie, right? Show me the money? You need to show me what you've done. What you have. When it comes to the budget, if you don't show it, just don't ask. Save yourself, you know, the length of asking. Because Senator Taitague and I will look at you like, really? But anyway, moving along, there

being no one else to present testimony on the appointment of Daphne M. Leon Guerrero, this hearing is now concluded.

I want to thank everyone for attending this hearing and providing feedback and suggestions. The referral of appointment of Daphne M. Leon Guerrero to serve as a member of the Guam Ethnic Commission for the term of four years, beginning on May 17, 2023 to May 16, 2027. This public hearing is now adjourned. The time now is 2:22.
