Dear Speaker Terlaje:

As you may know, the Honorable Benjamin C. Sison, Jr.'s second term as magistrate judge will conclude this October. After careful consideration, I am appointing **Attorney Sean E. Brown** to serve as the new magistrate pursuant to 7 GCA § 4401, subject to the approval of *Liheslaturan Guåhan*.

Attorney Brown was one of three candidate names provided by the Guam Bar Association (GBA) as required under 7 GCA § 4401(a)(2). For your records and convenience, enclosed are copies of the GBA's first two recommendations for the magistrate position, the GBA's request to verify the eligibility of a third candidate, and the Supreme Court's decision on the matter. After receiving the names, I convened a panel of three judicial officers and one attorney to review resumes and conduct interviews. The panel unanimously recommended the selection of Attorney Brown. I request that he be given the due consideration mandated by Guam law.

Attorney Brown satisfies the requisite statutory qualifications and has the competence, integrity, experience, and temperament to be successful as a magistrate. He earned his Juris Doctor from California Western School of Law in 2010 and has since worked as an associate attorney at the Office of Louie J. Yanza and as an Assistant Attorney General at the Office of the Attorney General of Guam for the past decade. As a prosecutor, he has participated in over fifty felony trials, has represented the Attorney General's office in federal court, and has served as the lead for violent crimes, property crimes, and DWI offenses.

In addition to his extensive litigation experience in criminal, civil, and domestic law, Attorney Brown has been a proactive member of the Board of Trustees for the Guam Law Library. He has also contributed to the community as a volunteer judge for mock trial competitions, a volunteer at the Boys & Girls Club, and an adjunct professor at the University of Guam for several years.

The Board of Governors is in receipt of your letter dated April 12, 2024, titled Request for Recommendations for the Position of Magistrate in which you request that the Guam Bar Association ("GBA") begin "soliciting interest for the position of magistrate and [provide] a list of three candidates in accordance with 7 G.C.A. § 4401(a)...."

On April 25, 2024, and then on May 16, 2024, to respond to your request and comply with our statutory mandate, the Board of Governors solicited interest by listserving all active members of the GBA. Additionally, to proactively solicit interest, the Board of Governors directly communicated with various members.

Five members expressed interest in the magistrate position. Accordingly, the Board of Governors convened a special meeting on May 20, 2024, to review the eligibility of all five applicants. The Board of Governors deemed the five applicants as follows: two eligible, two ineligible (lack residency requirement and/or requisite years of active practice in Guam prior to nomination), and one withdrawal.

Thank you for your letter of June 5, 2024 forwarding Attorney James Basil O'Mallan, III's letter of interest and resume for the position of Magistrate. You indicated the Board of Governors did not reach a conclusion on the eligibility of Attorney O'Mallan because he was inactive from December 6, 2023, to May 16, 2024 and then active again on May 17, 2024.

The Supreme Court of Guam reviewed the statutory requirements and determined that the statute does not require that an individual be in the active practice of law immediately prior to becoming a candidate for magistrate. Attorney O'Mallan's lengthy active service in good standing satisfies the seven-years in the active practice of law in Guam required by 7 GCA § 4401(b)(3) and 7 GCA § 3109(c).
