**CHIEF JUSTICE CARBULLIDO:** YOU YOU WILL BE RECOGNIZED AS YOU WILL BE RECOGNIZED SENATOR AT THIS TIME SENATOR PARKINSON YOU ARE RECOGNIZED.

**SENATOR PARKINSON:** I NOMINATE SENATOR JOE SAN AGUSTIN AS SPEAKER OF THE 37<sup>TH</sup> GUAM LEGISLATURE.

CHIEF JUSTICE CARBULLIDO: THANK YOU SENATOR SAN AGUSTIN DO YOU ACCEPT THE NOMINATION.

SENATOR SAN AGUSTIN: I DO.

CHIEF JUSTICE CARBULLIDO: SENATOR BARNETT YOU ARE RECOGNIZED.

**SENATOR BARNETT:** SORRY YOUR HONOR I THOUGHT YOU SAID SENATOR BARNETT I MOVED TO NOMINATE SENATOR THERESE TERLAJE AS THE SPEAKER OF THE 37TH GUAM LEGISLATURE.

CHIEF JUSTICE CARBULLIDO: THANK YOU SENATOR BARNETT SENATOR TERLAJE DO YOU ACCEPT THE NOMINATION.

SPEAKER TERLAJE: I DO YOUR HONOR.

CHIEF JUSTICE CARBULLIDO: ARE THERE ANY OTHER NOMINATIONS ON THE FLOOR SENATOR JESSE LUJAN.

SENATOR LUJAN: MOVE TO NOMINATE SENATOR FRANK BLAS JR FOR SPEAKER.

CHIEF JUSTICE CARBULLIDO: SENATOR FRANK BLAS JR DO YOU ACCEPT THE NOMINATION.

SENATOR BLAS: YES YOUR HONOR.

**CHIEF JUSTICE CARBULLIDO:** ARE THERE ANY OTHER NOMINATIONS FROM THE FLOOR IS THERE A MOTION TO CLOSE THE NOMINATION SO SENATOR SAN NICOLAS I'M SORRY I'M SORRY.

SENATOR QUINATA: I MAKE A MOTION TO CLOSE.

**CHIEF JUSTICE CARBULLIDO:** MOTION CARRIES ALRIGHT WE WILL GO AND SEQUENCE FOR THE VOTE AND ALL THOSE IN FAVOR OF SENATOR JOE SHIMOS SHIMIZU SAN AGUSTIN PLEASE RAISE YOUR RIGHT HAND ALL THOSE IN FAVOR OF SENATOR THERESE TERLAJE PLEASE RAISE YOUR RIGHT HAND OKAY ALL THOSE IN FAVOR OF SENATOR FRANK BLAS JR PLEASE RAISE YOUR RIGHT HAND OKAY THE RESULTS OF THE VOTES ARE SENATOR JOE SHIMIZU SAN AGUSTIN SIX VOTES SENATOR THERESE M TERLAJE THREE VOTES AND SENATOR FRANK BLAS JR SIX VOTES THE NUMBER OF VOTES REQUIRED UNDER THE STANDING RULES FOR THE VOTING OF SPEAKER REQUIRES EIGHT VOTES SO NO ONE IS SELECTED AT THIS TIME ARE THERE ANY OTHER NOMINATIONS I'M GOING TO CALL FOR A SECOND ROUND OF VOTING AND AT THIS TIME I'M GOING ARE THERE ANY OTHER NOMINATIONS FROM THE FLOOR SENATOR SABINA PEREZ.

**CHIEF JUSTICE CARBULLIDO:** THE OPENING SESSION OF THE FIRST REGULAR SESSION OF *I MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN* THE 37<sup>TH</sup> GUAM LEGISLATURE IS CALLED BACK TO ORDER I JUST WANT TO NOTE FOR THE RECORD THAT ALL 15 SENATORS ARE PRESENT AND THEY WERE SWORN IN IN THE OPENING DAY JANUARY 2ND 2023 OF THIS SESSION AND THE LEGISLATURE HAS A QUORUM TO CONTINUE ITS BUSINESS SENATORS WE WILL RESUME WITH THE ELECTION OF THE SPEAKER THE FLOOR IS OPEN FOR NOMINATIONS SENATOR CHRIS BARNETT YOU ARE RECOGNIZED.

**SENATOR BARNETT:** TEST THANK YOU YOUR HONOR AND GOOD MORNING GUAM I MOVED TO NOMINATE SENATOR THERESE TERLAJE AS SPEAKER OF THE 37TH GUAM LEGISLATURE.

CHIEF JUSTICE CARBULLIDO: SENATOR TERLAJE DO YOU ACCEPT THE NOMINATION.

**SPEAKER TERLAJE:** I DO YOUR HONOR.

CHIEF JUSTICE CARBULLIDO: SENATOR WILL PARKINSON YOU ARE RECOGNIZED.

SENATOR PARKINSON: I NOMINATE SENATOR JOE SAN AGUSTIN FOR SPEAKER OF THE 37TH GUAM LEGISLATURE.

CHIEF JUSTICE CARBULLIDO: SENATOR SAN AGUSTIN DO YOU ACCEPT THE NOMINATION.

SENATOR SAN AGUSTIN: YES I DO YOUR HONOR.

CHIEF JUSTICE CARBULLIDO: OTHER NOMINATIONS SENATOR JESSE LUJAN.

SENATOR LUJAN: I NOMINATE SENATOR FRANK BLAS JR FOR SPEAKER.

CHIEF JUSTICE CARBULLIDO: SENATOR FRANK BLAS JR DO YOU ACCEPT THE NOMINATION.

SENATOR BLAS: YES I DO YOUR HONOR.

**CHIEF JUSTICE CARBULLIDO:** ANY OTHER NOMINATIONS FROM THE FLOOR SENATOR SABINA PEREZ YOU ARE RECOGNIZED.

SENATOR PEREZ: THANK YOU HONOR I MOVED TO CLOSE THE NOMINATIONS FOR SPEAKER.

CHIEF JUSTICE CARBULLIDO: ANY OBJECTION.

**CHIEF JUSTICE CARBULLIDO:** MOTION CARRIES SO SENATORS WE WILL VOTE BY A SHOW OF HANDS AND UNDER THE APPLICABLE STANDING RULES EIGHT VOTES ARE REQUIRED TO ELECT THE SPEAKER AND THE VOTES WILL BE TAKEN IN THE ORDER OF THE NOMINATIONS AND THE ACTING CLERK WILL COUNT THE VOTES AND I WILL ANNOUNCE THE RESULTS IN THE ORDER OF THE NOMINATIONS SO THE FIRST NOMINEE PLEASE WRITE YOUR RAISE YOUR RIGHT HAND ALL THOSE IN FAVOR OF SENATOR THERESE TERLAJE THANK YOU FOR SENATOR JOE T SAN AG I'M SORRY JOE SAN AGUSTIN FOR SENATOR FRANK BLAS JR.

SENATOR BLAS: YOUR HONOR I RESPECTFULLY DECLINE MY NOMINATION.

**CHIEF JUSTICE CARBULLIDO:** SENATOR BLAS DECLINES SET THE NOMINATION MADAM CLERK IF YOU COULD GIVE ME THE RESULTS SO I CAN READ IT OUT ALOUD SO THE RESULTS OF THE VOTES BY A SHOW OF HANDS IN THE ORDER OF THE NOMINEE NOMINATIONS SENATOR THERESE TERLAJE RECEIVED NINE VOTES AND SENATOR JOE SAN AGUSTIN RECEIVED SIX VOTES THEREFORE SENATOR THERESE TERLAJE HAVING RECEIVED THE MAJORITY OF THE MEMBERS IS DULY ELECTED AS THE SPEAKER OF THE 37TH GUAM LEGISLATURE MADAM SPEAKER YOU MAY COME FORWARD FOR YOUR INAUGURAL ADDRESS AND PRESIDE AS CHAIR FOR THE REMAINDER OF THE FIRST SESSION AND CONGRATULATIONS.

SPEAKER TERLAJE: CAN I GIVE A SPEECH HÅFA ADAI I WANT TO THANK OUR CHIEF JUSTICE CARBULLIDO FOR BEING PATIENT WITH US AND PRESIDING OVER OUR INAUGURATION TWO-DAY FESTIVITIES BUT SI YU'OS MA'ASE' CJ I WANT TO SAY BUENAS YAN HÅFA ADAI TO MY COLLEAGUES MAÑELUHU YAN MANAIÑAHU OUR FRIENDS OUR FAMILY OUR NEIGHBORS OUR COLLEAGUES AND THE PROUD PEOPLE OF GUAM I STAND HERE TODAY AND I THINK ABOUT ALL THE GREAT LEADERS THAT HAVE GRACED THESE HALLOWED HALLS WHO HAVE CLEARED THE PATH FOR US WITH THEIR ACTS OF SERVICE LEADERSHIP AND FEARLESSNESS AND THEY CONTINUE TO INSPIRE US IN MARCH OF 1949 CONCERNED ABOUT LIMITED LEGISLATIVE POWERS THE GUAM CONGRESS STAGED AN ACT OF DEFIANCE IN PROTESTS AGAINST THE NAVAL GOVERNMENT DRAWING NATIONAL ATTENTION IN ITS QUEST FOR SELF-GOVERNANCE WHICH HAS SINCE BECOME KNOWN AS THE WALKOUT ASSEMBLY SPEAKER ANTONIO B WON PAT STATED IN THE LETTER TO THE NAVAL GOVERNOR POWNALL IN 1949 THE MEMBERS OF THE HOUSE OF ASSEMBLY CONSIDERED THAT THE POWERS OF THE THREE BRANCHES OF GOVERNMENT MUST BE DEFINED IT IS FURTHER BELIEVED THAT ONLY THEN CAN YOU AND YOUR STAFF THE LEGISLATIVE AND JUDICIAL BRANCHES OF THE NAVAL GOVERNMENT ASSURE THE PEOPLE OF GUAM OF THE FULL FUNCTIONING OF THE DEMOCRATIC PROCESSES OF GOVERNMENT IN THE MEANTIME THE MEMBERS OF THE ASSEMBLY DO NOT FEEL THAT THEY CAN APPEAR TO HAVE THE STATUS OF A LEGISLATIVE BODY WITHOUT THE PROPER POWERS TO CARRY OUT THAT FUNCTION UNQUOTE AN EVER LEGISLATURE SINCE THAT WALKOUT HAS INHERITED THE RESPONSIBILITY TO BUILD UPON THE PROGRESS OF OUR PREDECESSORS WHO FOUGHT FOR MORE LEGISLATIVE AUTHORITY FOR WHAT WAS AT ONE TIME AN ADVISORY BODY TO A PLENARY POWER AND WE MUST CONTINUE TO EMBODY THEIR SPIRIT TODAY AND EVERY DAY FORWARD BY DILIGENTLY AND RESPONSIBLY EXERCISING OUR AUTHORITIES OF OVERSIGHT 

# Organic Act of Guam

Seventy three years ago, the Organic Act of Guam was passed by U.S. Congress and signed into law by President Truman as P.L. 81-630.

To Washington, the act was just another public law. But to the People of Guam, it was a symbol of the hard-won success of our CHamoru leaders.

Due to the concerted efforts of the men and women of the Guam Congress Walk-Out, our People were at last granted the institutions they had, for half a century, been denied: U.S. citizenship, the establishment of the Guam Legislature, and limited self-rule.

While it would be another twenty years before the People of Guam would elect their own governor, the Organic Act marked a turning point in the island's struggle for self-governance, and a sign of hope that when a small group of thoughtful, committed citizens get together, they can, in fact, change the world.
