



**AN ACT RELATIVE TO AUTHORIZING THE
EXTENSION OF CONCESSION AGREEMENTS OF THE
ANTONIO B. WON PAT INTERNATIONAL AIRPORT
AUTHORITY, GUAM**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Authority to Extend Concession Agreements.** The A.B. Won
3 Pat International Airport Authority, Guam is authorized to negotiate extensions of
4 its current concession agreements for up to an additional three (3) years from the end
5 of the then-current term upon terms and conditions in the best interests of GIAA,
6 subject to approval by the GIAA Board of Directors.

7 **Section 2. Effective Date.** This Act shall be effective from and after its
8 enactment.

9 **Section 3. Severability.** If any provision of this Act or its application to any
10 person or circumstance is found to be invalid or contrary to law, such invalidity *shall*
11 *not* affect other provisions or applications of this Act that can be given effect without

- 1 the invalid provision or application, and to this end the provisions of this Act are
- 2 severable.

To add a new Section 1 to the Bill to read:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that given the damage and uncertainty caused by the COVID-19 pandemic, Typhoon Mawar, and other geopolitical issues and hardships that have arisen over the past several years, it is projected to take at least several years for the Territory's visitor industry and for the A.B. Won Pat International Airport Authority, Guam ("GIAA") to achieve the enplanement trajectory and financial stability - through the restoration of operating reserves and capital improvement funds - expected prior to the Covid-19 pandemic. Accordingly, I Liheslaturan Guåhan finds that the current GIAA concessions are in the best interest of the GIAA and the Territory and an extension of such concessions is in the best interest of GIAA and the Territory.

~~Section 1.~~ Section 2. Authority to Extend Concession Agreements. The A.B.
