



**AN ACT TO *AMEND* § 4719(a) AND (b) AND TO *ADD* A
NEW § 4719 (c) AND (d), ALL OF DIVISION 1, ARTICLE
7, CHAPTER 4, TITLE 26 OF GUAM ADMINISTRATIVE
RULES AND REGULATIONS, RELATIVE TO
COMPLIANCE REQUIREMENTS AND REGULATIONS
FOR DEPARTMENT OF EDUCATION PUBLIC
SCHOOLS.**

1 Section 1. § 4719(a) and (b) of DIVISION 1, ARTICLE 7, CHAPTER 4,
2 TITLE 26 OF GUAM ADMINISTRATIVE RULES AND REGULATIONS
3 is hereby *amended* to read:

4 **“§ 4719. Existing Facilities.**

5 (a) School facilities in existence at the time that these regulations
6 take effect shall be given five years from the date that these rules become
7 effective to come into full compliance with the requirements of these rules
8 unless a school facility or operator files a written statement of exception with
9 the Director and receives a variance as provided in § 4722.

1 (b) Guam Department of Education (GDOE) Public school facilities
2 shall come into full compliance by the start of School Year ~~2023-2024~~ 2024-
3 2025 with the requirements of these rules unless a public school facility or
4 operator files a written statement of exception with the Director and receives
5 a variance as provided in § 4722.

6 Section 2. A new § 4719(c) and (d) of DIVISION 1, ARTICLE 7,
7 CHAPTER 4, TITLE 26 OF GUAM ADMINISTRATIVE RULES AND
8 REGULATIONS is hereby *added* to read:

9 (c) GDOE shall submit monthly written reports to the Speaker of I
10 *Liheslaturan Guahan* detailing the status of each public school's compliance
11 or non-compliance with Article 7, Chapter 26 of these Rules and Regulations
12 that will result in the suspension of the Sanitary Permit of a GDOE public
13 school. Such report shall include but not be limited to the proposed corrective
14 action(s) which will be taken to avoid suspension of its Sanitary Permit or to
15 support GDOE's request for a variance under this Chapter.

16 (d) Until such time as all GDOE public schools have obtained Sanitary
17 Permits required under this Chapter, GDOE shall be subject to monthly
18 oversight hearings to report on the status of its compliance or non-compliance
19 with Article 7, Chapter 26 of these Rules and Regulations."
