AN ACT TO *ADD* A NEW § 1909(c)(1) TO CHAPTER 19 OF TITLE 1, GUAM CODE ANNOTATED, RELATIVE TO THE DUTIES OF THE PUBLIC AUDITOR.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new § 1909(c)(1) and is hereby *added* to Chapter 19 of Title
1, Guam Code Annotated, to read as follows:

4 "(c) To communicate directly with any person or with any department, 5 officer or person having official relations with the office in any matter relating to the 6 expenditures of government funds and property or to the settlement thereof; and

(1) establish deadlines for submission by every department or agency head, inclusive of autonomous entities, or head of a program within the government of Guam of all financial or program information under their control as are necessary to carry out the duties and functions of the Office of

Public Accountability. Failure to submit such information by the required 1 deadline shall result in the imposition of a Two Hundred Fifty Dollar 2 3 (\$250.00) fine against the general manager, director, or head of the agency, in their personal capacity, per missed deadline which shall be deposited into the 4 5 Guam Memorial Hospital Authority Hospital Operations Fund. An additional 6 fine of Two Hundred Fifty Dollars (\$250.00) shall be assessed against the general manager, director, or head of the agency, in their personal capacity, 7 8 for every thirty (30) days that the reporting requirements are not met.

9 (2) The Public Auditor shall file a report of those general managers, 10 directors, or heads of the agency who fail to pay the fine imposed herein 11 within thirty (30) days with the Office of the Attorney General of Guam for 12 enforcement."
