AN ACT TO APPROPRIATE FIVE MILLION DOLLARS (\$5,000,000) FROM FISCAL YEAR 2024 GENERAL FUND REVENUES COLLECTED IN EXCESS OF THE ADOPTED LEVELS ENUMERATED IN PUBLIC LAW 37-42, AS AMENDED, TO THE DEPARTMENT OF PARKS AND RECREATION FOR THE PURPOSE OF CONSTRUCTING THE "NÅFTAN MAÑAINA-TA SHRINE."

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Appropriation. Five Million Dollars (\$5,000,000) is
- 3 appropriated from Fiscal Year 2024 General Fund revenues collected in excess of

- 1 the adopted levels enumerated in Public Law 37-42, as amended, to the Department
- 2 of Parks and Recreation for the construction of the "Nåftan Mañaina-ta Shrine" as
- 3 approved by the SHPO. This appropriation shall remain available until fully
- 4 expended and is not subject to I Maga'hågan Guåhan's transfer authority.
- 5 Notwithstanding any other provision of law, the land severed for the "Nåftan
- 6 Mañaina-ta Shrine" shall not exceed five (5) acres. This limitation shall be a
- 7 condition of any funding provided under this Act.
- 8 **Section 2. Effective Date.** This Act shall be effective upon enactment.
