



1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **SECTION 1.** § 40101 of Chapter 40, Division 4, Title 5, Guam Code

3 Annotated are *amended* to read:

4 **"§ 40101. Number of Mayors and Vice-Mayors.**

5 There shall be a Mayor and/or Vice Mayor for the municipalities and villages of
