AN ACT TO AMEND § 4108(c)(2)(B) OF ARTICLE 1, CHAPTER 4, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO GREATER INCLUSION IN SICK LEAVE POLICY.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. § 4108(c)(2)(B) of Article 1, Chapter 4, Title 4, Guam Code

 Annotated, is hereby *amended* to read as follows:
- "(B) Immediate family member means the employee's spouse, common law, parents, parents-in-law, grandparents, brothers, sisters, children, grandchildren, brothers' and sisters' children, any step or adoptive parents, adopted children or grandchildren of both the employee and the spouse, a guardian or person in loco parentis."
 - **Section 2. Effective Date** This Act shall be effective upon enactment.
- Section 3. Severability. If any provision of this Act or its application to any person or circumstance is found to be invalid or inorganic, such invalidity shall not affect other provisions or applications of this Act that can be given effect without

- 1 the invalid provision or application, and to this end the provisions of this Act are
