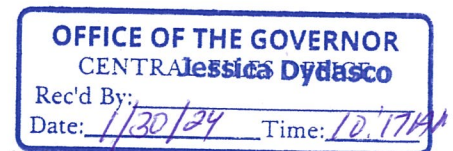
1. The Legislature did consent to the Executive Appointment of Janalynn C. Damian to serve as a Member of the Guam Board of Equalization.


