AN ACT TO AMEND § 4637(a) OF ARTICLE 6, CHAPTER 4, DIVISION 1, TITLE 26, GUAM ADMINISTRATIVE RULES AND REGULATIONS, RELATIVE TO THE REQUIREMENT OF LIFEGUARDS AT SWIMMING POOLS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. § 4637(a) of Article 6, Chapter 4, Division 1, Title 26, Guam
Administrative Rules and Regulations, is *amended* to read:

4 "(a) One or more QUALIFIED LIFEGUARDS shall be on duty at
5 POOL side at all times when the PUBLIC SWIMMING POOL is open to use
6 by BATHERS except at POOLS with less than 2,250 square feet of water
7 surface or POOLS appurtenant to condominiums, townhouses, and apartment
8 complexes. Such attendant should be in full charge of bathing and have
9 authority to enforce all rules of SAFETY and sanitation."
