AN ACT TO AMEND §13103(g) OF CHAPTER 13 OF  
TITLE 5 GCA AND TO AMEND SUBITEM (a) AND  
ADD AN NEW SUBITEM (f) TO SECTION 3 OF  
CHAPTER VII SUPPLEMENTAL FUNDING OF PL. 29-  
02 RELATIVE TO THE COMMISSION ON  
MODERNIZATION OF THE GOVERNMENT OF  
GUAM (COM-21).

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. §13103 (g) of Chapter 13 of Title 5 Guam Code Annotated  
3 is amended to read:

4 "§13103. Duties of the Commission.

5 (g) The office of the Commission *shall* be located at the Jesus  
6 and Eugenia Leon Guerrero UOG School of Business and Public  
7 Administration (SBPA) Building. the Bureau of Statistics and Plans  
8 (BSP). The ~~School of Business and Public Administration~~ BSP *shall*  
9 serve as the Secretariat of the Commission and shall provide  
10 administrative and professional services to the Commission.  
11 Logistical support and resources for the ~~School of Business and~~  
12 ~~Public Administration~~ BSP in support of the Commission *shall* be  
13 provided by the ~~Bureau of Statistics and Plans~~ Bureau of Budget and

1        Management Research (BBMR) and the Guam State Clearing House.

2        If necessary, ~~the School of Business and Public Administration~~ BSP

3        *shall* provide an annual budget request to the Speaker of I

4        *Liheslatura* on the Commission's behalf for Fiscal Year 2008."

5        **Section 2. Subitem (a) of Section 3, Appropriations, of Chapter VII**

6        **Supplemental Funding of Public Law 29-02 is amended to read:**

7                "(a) University of Guam - ~~\$500,000, of which \$25,000 is~~

8                ~~appropriated to the School of Business and Public Administration to~~

9                ~~fund the Commission on Modernization of the Government of Guam~~

10               ~~created by the Miscellaneous Provisions Section of this Act~~ \$475,000;"

13                "(f) Bureau of Statistics and Plans - \$25,000 to fund the

15               by the Miscellaneous Provisions Section of this Act."
