AN ACT TO TRANSFER THE WASTE WATER PUMPS LOCATED ON THE SCHOOL GROUNDS OF SOUTHERN HIGH SCHOOL AND LUIS P. UNTALAN MIDDLE SCHOOL TO THE GUAM WATERWORKS AUTHORITY.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that 2 the Guam Department of Education (GDOE) has historically struggled with issues 3 4 associated with the waste water pump station located on the premises of Southern 5 High School in Santa Rita and Luis P. Untalan Middle School in Barrigada. 6 I Liheslaturan Guåhan further finds that throughout the years sewage is persistently overflowing at the waste water pump station at Southern High School 7 8 thereby causing GDOE to contract the professional services of private entities pump to 9 out the sewage so that it may not pose a health threat or otherwise compromise the learning and working environment of students, faculty, and staff at Southern High 10 11 School. 12 I Liheslaturan Guåhan further finds that GDOE does not have the human, 13 mechanical, or financial resources available to manage, maintain, or otherwise service 14 waste water pumps. However, it is further determined that a power of the Guam

Waterworks Authority, as defined in Chapter 14 of Title 12, Guam Code Annotated, is
to collect, treat and dispose of waste water on Guam.

Therefore, it is the intent of *I Liheslaturan Guåhan* to assign the responsibility of managing and maintaining the waste water pumps located on the school grounds of Southern High School and Luis P. Untalan Middle School to the Guam Waterworks Authority in order that GDOE may focus on its core business of educating the children of Guam.

Section 2. Transfer of Waste Water Pumps located on the School Grounds of Southern High School and Luis P. Untalan Middle School. Waste water pumps located on the school grounds of Southern High School and Luis P. Untalan Middle School operated and maintained by the Guam Department of Education is hereby transferred to the Guam Waterworks Authority. The Guam Waterworks Authority shall control, operate, improve, equip, maintain, repair, renew, replace, reconstruct, alter and redesign said waste water pumps.
