AN ACT TO TRANSFER TRACT 3620, LOT MUNICIPALITY OF INARAJAN, WITH AN AREA OF 929.02± SQUARE METERS, FROM THE CHAMORRO LAND TRUST **INVENTORY** AND TO THE **ADMINISTRATIVE** JURISDICTION OF THE' THE INARAJAN MAYOR'S **OFFICE** FOR CONSTRUCTION OF A MULTI-PURPOSE FACILITY FUNDED THROUGH FEDERAL SOURCES

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds 3 that the population of Inarajan, Guam, now exceeds 3,000 people, making it the second most populated village in Southern Guam. Despite this fact, the village of 4 Inarajan remains without a recreational sports facility for its children and families. 5 6 I Liheslaturan Guåhan further finds that the Chamorro Land Trust 7 Commission leased Tract 3620, (formerly basic lot no. 381-2), Municipality of 8 Inarajan, Guam, containing an aggregate area of 5.37 acres (21,734 ± sq. meters), 9 to the Inarajan Mayor's Office for this purpose on March 30, 2000, but that the 10 construction of an Inarajan Sports Facility has stalled because of a lack of funding. 11 Additionally, I Liheslaturan Guåhan finds that the CLTC lease for Tract 3620 (formerly basic lot no. 381-2), Municipality of Inarajan, Guam, will expire in 12 13 six years, preventing the construction of a long-term multi-purpose facility funded 14 through federal sources.

It is, therefore, the intent of *I Liheslaturan Guåhan* to transfer Tract 3620, (formerly basic lot no. 381-2), Lot 15, Municipality of Inarajan, 929.02± square meters, survey map 150FY85, PID No. 10002203340000, Municipality of Inarajan, Guam, under the administrative jurisdiction of the Inarajan Mayor's Office to permit the construction of a multi-purpose facility for the people of Inarajan funded by the Community Block Grant Program or such other sources of funding as may be viable and appropriate.

Section 2. Transfer of Land Identified to the Administrative Jurisdiction of the Inarajan Mayor's Office. Notwithstanding any other provision of law, rule or regulation, Tract 3620, (formerly basic lot no. 381-2), Lot 15, Municipality of Inarajan, 929.02± square meters, survey map 150FY85, PID No. 10002203340000, is hereby transferred from the inventory of the Chamorro Land Trust Commission to the Office of the Inarajan Mayor for the purpose of constructing a multi-purpose facility. The transfer of said administrative jurisdiction shall become effective upon the enactment of this Act.

Section 3. Reversionary Clause Upon Inaction. If two (2) years after the enactment of this Act, a multi-purpose facility is not built on Tract 3620, (formerly basic lot no. 381-2), Lot 15, Municipality of Inarajan, 929.02± square meters, survey map 150FY85, PID No. 10002203340000, such lot shall revert to the inventory of the Chamorro Land Trust Commission.

Section 4. Administrative Duties. The Office of the Mayor of Inarajan *shall* be responsible for the administration, operation and maintenance of the Tract 3620, (formerly basic lot no. 381-2), Lot 15, Municipality of Inarajan, 929.02± square meters, survey map 150FY85, PID No. 10002203340000, Guam, and any multipurpose facility built on said lot shall be for the benefit of the residents of Inarajan and the island community.

- Section 5. Waiver of Appraisal Requirement. § 2107 of Chapter 2, Title
- 2 2, Guam Code Annotated, and the Standing Rules of I Mina'Trentai Tres Na
- 3 Liheslaturan Guahan relative to requiring land appraisals for land bills, shall not
- 4 apply to this act.

5 **Section 6. Effective Date.** This act *shall* take effect upon its enactment.
