AN ACT TO REZONE LOT NO. 2057-R2, MUNICIPALITY OF MONGMONG-TOTO-MAITE (FORMERLY MUNICIPALITY OF BARRIGADA), FROM AGRICULTURAL ZONE (A) TO COMMERCIAL ZONE (C).

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan find
- 3 that the heirs of Francisco Meno Mesa are the property owners of Lot No. 2057-R2
- 4 located in the Municipality of Mongmong-Toto-Maite (formerly Barrigada),
- 5 Guam.

- Furthermore, the heirs of Francisco Meno Mesa would like to maximize the
- 7 highest and best use of Lot No. 2057-R2, and are requesting the assistance of I
- 8 Liheslaturan Guahan to rezone this property from Agricultural Zone (A) to
- 9 Commercial Zone (C).
- It is, therefore, the intent of *I Liheslaturan Guahan* to rezone the property
- from A to C. in an effort to assist the heirs of Francisco Meno Mesa in maximizing
- the highest and best use of their property.
- 13 **Section 2. Lot Rezoning.** Notwithstanding any other provision of law, Lot No.
- 14 2057-R2, Municipality of Mongmong-Toto-Maite (Formerly Municipality of
- Barrigada), Guam, containing an area of $21{,}363 \pm \text{square meters}$, lot is marked and
- 16 designated on Surveyor's Drawing No. FC12-0325, Land Management No.
- 17 155FY2012 recorded under Instrument No. 839392, in the Department of Land

- 1 Management, Government of Guam, is hereby rezoned from Agricultural (A)
- 2 Zone to Commercial (C) Zone. (Map attached as Exhibit "A").
- 3 Section 3. Effective Date. This provisions contained herein shall take effect
- 4 immediately upon enactment of this Act.
