## **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 Section 1. A new § 75107.1 is hereby *added* to Chapter 75 of Title 21,

  - "§ 75107.1. Leases to Chamorro, Licenses: Moratorium.

1	(a) No lease or license shall be granted pursuant to 21 GCA §
2	75107 until the expiration of ninety (90) days from the date administrative
3	rules and regulations required by 21 GCA § 75103 have been duly adopted
4	by the Commission and have been added to the Guam Administrative Rules
5	and Regulations as published on the Compiler of Laws' website. Said period
6	shall be known as The Moratorium.
7	(b) The Temporary Receiver shall have all the authority of the
8	Administrator of the Chamorro Land Trust Commission and the Director of
9	Land Management to administer the personnel assigned to the Department
10	of Land Management, and to implement the provisions of this Chapter and
11	related laws during The Moratorium.
12	(c) The rules and regulations shall reference, include, codify,
13	correct and supplement the statutory regulations denominated as "The
14	Senator Paul Bordallo Rules and Regulations for the Chamorro Land Trust
15	Commission" in Public Law 23-38.
16	(d) The rules and regulations) shall include express provisions
17	dealing with standards of conduct, conflicts of interest, disclosure, self-
18	dealing, honesty and ethics.

20	protection for employees who report nonfeasance, misfeasance, or

24	"§ 75107.2. Leases to Chamorro, Licenses: Voidable. Any lease
25	or license awarded by the Commission may be voided upon petition to the
26	Superior Court by the Temporary Receiver or any interested person if the
27	Court finds that the lease or license was improperly awarded because the

3	Section 3. A new § 75103.1 is hereby added to Chapter 75 of Title 21,
4	Guam Code Annotated, to read:
5	"§ 75103.1. Administration: Temporary Receiver During
6	Moratorium. The Temporary Receiver shall have all the authority of the
7	Administrator of the Chamorro Land Trust Commission and Director of
8	Land Management to administer the provisions of this chapter and related
9	laws until the end of The Moratorium."
10	Section 4. A new § 75103.2 is hereby added to Chapter 75 of Title 21,
11	Guam Code Annotated, to read:
12	"§ 75103.2. Administration: Authority of the Director of Land
13	Management suspended. The authority of the Director of Department of
14	Land Management to administer this Chapter is suspended during the
15	pendency of The Moratorium imposed by 21 GCA § 75107.1 of this
16	Chapter. The salary of the Director of the Department of Land Management
17	shall be reduced by Twenty-five percent (25%) during the pendency of The
18	Moratorium."
19	Section 5. A new § 75103.3 is hereby added to Chapter 75 of Title 21,
20	Guam Code Annotated, to read:
21	"§ 75103.3. Administration: Abolition of the Administrative
22	Director of the Chamorro Land Trust Commission. The position of
23	Administrative Director of the Chamorro Land Trust Commission is
24	abolished and any statutory reference thereto however denominated is
25	repealed."
26	Section 6. A new § 75103.4 is hereby added to Chapter 75 of Title 21,
27	Guam Code Annotated, to read:

1	"§ 75103.4. Administration: Appointment of the Temporary
2	Receiver. The Governor shall appoint the Temporary Receiver for a term
3	coextensive with The Moratorium from among the retired judges and
4	justices of the courts of Guam and the Commonwealth of the Northern
5	Marianas. The salary of the Temporary Receiver shall be equal to the current
6	salary of the incumbent of the position from which the temporary receiver
7	retired."
