1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, John Camacho Salas, Ph.D., is the eldest child in a family of
4 nine (9) siblings, and his parents, a retired U.S. Navy Steward and spouse, had
5 always stressed that education and hard work were the keys to a successful
6 and worthy life; and

7 **WHEREAS**, Dr. Salas went on to fulfill the beliefs of his parents,
8 graduating from Father Duenas Memorial High School, and then going on to
9 earn undergraduate and masters degrees. In 1974, he received a Doctor of
10 Philosophy Degree from the University of Connecticut; and

11 **WHEREAS**, in the course of working his way through college, Dr. Salas
12 received a broad range of experiences preparing him for later life, including
13 janitorial work, construction, and in the management of the local college town
14 McDonalds; and

15 **WHEREAS**, Dr. Salas was hired as the first Executive Director of the
16 Guam Hotel & Restaurant Association; and is a former Vice President of
17 Human Resources, Duty Free Shoppers Limited Partnership, Micronesia; and

18 **WHEREAS**, Dr. Salas served as a key manager in all three (3) public
19 educational institutions on Guam, as well as serving as a member of
20 governing boards throughout the Guam and the Micronesia region; and

21 **WHEREAS**, Dr. Salas is a former Deputy Superintendent of the Guam
22 Public Schools; the Founding Provost of Guam Community College; and a

1 former President of the University of Guam, serving as that institution's
2 seventh (7th) chief executive; and


3 **WHEREAS**, Dr. Salas was elected to serve as a Senator in the 24th & 25th
4 Guam Legislatures (from 1997 to 2000); and

5 **WHEREAS**, Dr. Salas retires from the University of Guam as a tenured
6 Associate Professor of International Tourism and Hospitality Management;
7 now, therefore, be it

9 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
10 people of Guam, congratulate, commend, and recognize Dr. John Camacho

13 him well on the occasion of his retirement from the University of Guam; and
14 does further extend *Un Dångkolo Na Si Yu'os Ma'ase* to him for his many
15 accomplishments and for attaining the highest standards of achievement; and

21 to the Honorable Felix P. Camacho, *I Maga'lahren Guåhan*.


