14 Guam , Class of 1969 and began her professional career as Sales Clerk of
15 Family Shoe Store in June 1968 to August 1968 ; and

1 **WHEREAS**, In June 1969 to February 1970 she worked as a trainee/student
2 with the Department of Education and moved back to family business as
3 Sales Clerk of Pangelinan Store in February 1970; and

5 **WHEREAS**, Rosita P. San Nicolas went back to work with Government of
6 Guam in March 1970 as an Interviewing Clerk II of Guam Memorial
7 Hospital; and

9 **WHEREAS**, On June 8, 1970, Rosita P. San Nicolas began employment with
10 District Court of Guam as Temporary Clerical Assistant for an indefinite
11 term; and

13 **WHEREAS**, In December 1973 she was promoted to Deputy Clerk to
14 perform her duties as Secretary to the Clerk, Court Reporter Monitor,
15 Courtroom Deputy Clerk, Telephone Coordinator, Civil Docket Clerk,
16 Criminal Docket Clerk and financial duties including cashier responsibility;

19 **WHEREAS**, Rosita P. San Nicolas was promoted to Courtroom Deputy on
20 June 4, 1990 and was promoted again to Chief Deputy Clerk on September
21 16, 1991; and
