10 worked in similar positions at the Department of Labor's Personnel Division, the  
11 Department of Administration's Records Management Division, the Department of  
12 Revenue and Taxation's Insurance and Securities Division, the Department of  
13 Administration's Personnel Services Division, and again at the Department of Land  
14 Management. In 1975, Catalina worked at the Office of the Governor, specifically for  
15 the Territorial Crime Commission; and in 1976, she served in a similar capacity for  
16 the Department of Commerce. Continuing in her career with the government of Guam,  
17 Catalina decided to work primarily for the Department of Labor, where she served as  
18 an Administrative Assistant in various capacities. Catalina transferred on December  
19 19, 2003 to the Department of Labor's Guam Employment Services Division from  
20 where she now retires after thirty-seven (37) years of dedicated service to the  
21 government of Guam; now therefore, be it

8 Calvo, *I Maga'låhen Guåhan*.


